FILING A CROSS APPEAL

Bankruptcy Rule 8006

FYI:Pursuant to Bankruptcy Rule 8006:A Cross Appeal must be filed within ten (10) days of
the date of the filing of the initial Notice of Appeal.

Within ten (10) days of filing the Cross Appeal, the Cross Appellant must file and serve it's Statement of Issues on Cross Appeal and a Designation of Additional Items to be included in the record.

Within ten days from service of the Cross Appellant's Statement the Cross Appellee may file its Designation of Additional Items to be included in the record.

- 1. Click **Bankruptcy** or **Adversary** (whichever is the case in which the original Notice of Appeal is filed).
- 2. Click Appeal.
- 3. Enter Case Number, then click **Next**.
- 4. At the Document Selection screen as shown below, click **Cross Appeal**, then click **Next**.

- 5. At the Joint Attorney Filing screen, make the appropriate selection, then click **Next**.
- 6. At the Filing Party screen as shown below, select the filing party.
