

# U.S. Ambassador-designate Ned L. Siegel and Mrs Siegel Arrive at Post

United States Ambassador-designate Ned L. Siegel and Mrs. Stephanie Siegel arrived in Nassau on Friday, November 2. They were greeted at Million Air Airport by a team of Embassy personnel led by Chargé d'Affaires Hardt and Mrs. Hardt. In a brief statement to the press, Ambassador-designate Siegel said that he and his wife are delighted to be in the Bahamas. He said that he looks forward to presenting his credentials to the Governor General and working with the Government of the Commonwealth of The Bahamas to represent the United States and further the many common interests shared between the two countries.

Following his arrival, Mr. and Mrs. Siegel drove to the Embassy, where he and Mrs. Siegel were formally introduced by Dr. Hardt and received a warm welcome by Embassy staff gathered in the Consular Waiting Room.

Ambassador-designate Siegel was confirmed as the 12th U.S. Ambassador to The Bahamas by the United States Senate on September 12. Mr. Siegel, a resident of Boca Raton, Florida, is founder and Chairman of The Siegel Group, a real estate investment and management group. He has served the United States as Senior Advisor to the U.S. Mission to the United Nations for the UN General Assembly and as a Member of the Board of Directors of the Overseas Private Investment Corporation. Mr. Siegel has also served as Member of the Board for Enterprise Florida, a public/private partnership promoting Florida's economic development.

Mr. Siegel has served as member, board member or trustee of over 25 civic organizations. He is on the National Board of Directors for the Republican Jewish Coalition, is Co-President of the Jewish National Fund and is a Trustee of the Institute for the Study of Global Anti-Semitism and Policy. He is a founding member of the Treva Brogan Educational Institute, which provides scholarships for disadvantaged youth, and has served on the Boards of St. Andrew's and Pine Crest Schools in Boca Raton and has been an advisor to New York University and the University of Pennsylvania.

Ambassador-designate Siegel and Mrs. Siegel have three children: Justin, Joshua and Jillian.

Protocol Corner

**Representational Events:** The purpose of a representational event must fall under one of the following four categories: promotion of U.S. national interests, protection of U.S. citizen's interest, promotion of economic activities and commemorative and ceremonial requirements. Attending a representational event is an extension of a Foreign Service Officer's workday. These social events provide a venue to build contacts, establish networks, exchange information and get to know and trust each other.

**Your Role at Events:** If you are an employee, you are expected to attend official events to which you are invited. Spouses may or may not be invited to official events depending on space limitations and nature of the function. At official events hosted by the Ambassador, the DCM or your colleagues, you are considered a co-host. You are there to assist the host by meeting people, representing the U.S., and making guests feel welcome.

**Invitations and Responses:** Cultural differences abound in issuing and responding to invitations. In most cases, the invitation will come addressed specifically to the employee and spouse if the spouse is invited. If a spouse is not specifically named, he/she is probably not invited. It is inappropriate to bring a date to a working event. However, in special cases, which will usually be identified, one invitation addressed to the family is meant to include everyone in the house.

Please note **R.s.v.p.** appears in the lower left-hand corner of the invitation and this abbreviation refers to the French phrase, "Répondez, s'il vous plait." Responding is very important and should be done, generally by phone, within two days (48 hours) after receiving an invitation. It is considered inappropriate, and in most cultures rude, to leave someone who has invited you to a reception or dinner with no idea of how many people to expect. Your reply is necessary for planning purposes and as common courtesy. Be sure to observe the request on the invitation. "Regrets only" means to call only if you will not attend, and "RSVP" means to respond whether you will or will not attend. Once you have accepted, you are expected to attend, baring illness, death in the family, or a sudden, unavoidable trip. If you find you cannot attend a function for which you have already accepted because of an emergency, it is essential that you let the host/hostess know as soon as possible and preferably by phone. This is particularly the case for seated dinners where it is very inconsiderate not to advise the host so another guest can be identified to take your place at the table. Even at a large catered party such notifications are important because the host/hostess plans and pays for the number of guests expected and not for how many actually arrive. On the other hand, if you have refused an invitation for a legitimate reason and the circumstances have changed and you wish to attend the function you may call the host, explain the situation and ask if you may still attend. This situation only applies to large receptions or cocktail buffet which would not likely cause any complications.

Please follow these guidelines in responding to events to which you may be invited by the Ambassador, DCM, or Bahamian officials in the future.
