



#### **Compact Goal**

MCC signed a 5-year Millennium Challenge Compact with the Republic of Armenia in March 2006, which entered into force in September 2006. The compact is designed to reduce rural poverty through a sustainable increase in the economic performance of the agricultural sector through a program of strategic investments in rural roads and irrigated agriculture. The program is being administered by MCA-Armenia (www.mca.am), a state, non-commercial entity established by the Government of Armenia. A stakeholders' committee allows for participation from Armenian civil society.

#### **Update on Progess** Rural Roads Rehabilitation Project


- The Armenian government will rehabilitate 943 km of rural roads, which, when complete, will help ensure that rural communities have access to markets, services, and the main road network.
- Construction on a 24.5 kilometer road segment in the Gyumri region began on October 29, 2007. Procurement is proceeding on contracts for maintenance, design and feasibility, construction, and construction supervision.

#### Irrigated Agriculture Project: Infrastructure Activity

- MCA-Armenia is finalizing the procurement for the design and supervision of 18 irrigation schemes throughout Armenia.
- In February 2007, MCA-Armenia signed an agreement with the Irrigation Project Implementation Unit to oversee implementation of the civil works of the Irrigated Agriculture Project.
- To date, MCA-Armenia has signed several contracts for design and feasibility studies of canals, reservoirs, and environmental oversight.

#### Irrigated Agriculture Project: Water-to-Market Activity

- MCA-Armenia and ACDI/VOCA signed a \$18.5 million contract for ACDI/VOCA to manage the Water-to-Market Activity.
- The random selection of the timing to determine when communities would receive training under the Water-to-Market Activity took place in a public forum in August 2007. The event included representatives from the MCA-Armenia stakeholders' committee, water users' associations and Armenian government officials.
- In October 2007, an agreement was signed between MCA-Armenia and the Rural Finance Facility Project Implementation Unit, which will facilitate the implementation and monitoring of the credit component of the MCA-Armenia Waterto-Market activity.







**Compact Status** 

#### **Compact Goal**

The Benin Compact removes key constraints to economic growth and supports improvements in physical and institutional infrastructures in four critical sectors in order to increase investment and private sector activity in Benin. The Compact comprises four projects: Access to Land, Access to Financial Services, Access to Justice, and Access to Markets.

#### **Update on Progress**

On November 3, MCA-Benin hosted a general assembly of organizations representing farmers, civil society groups, unions, and artisans. The groups elected representatives from these groups to serve on the Advisory Council and on the Consultative Committee. Nine new representatives were elected – two representing artisans, two representing farmers, two representing unions, and three representing civil society.

The Beninese National Assembly devoted a day to the Compact and other USG assistance programs. Honored guest Ambassador Gayleatha B. Brown presented a summary of how the USG supports development in Benin. National Coordinator Simon Pierre Adovelande responded to the intense interest of the representatives with a detailed explanation of the Compact objectives. In an important step forward for the Compact, the host, Assembly President Mathurin Nago, outlined the importance of the National Assembly's role in developing new legislation to support access to land in rural and urban areas, an essential part of the Compact program.

#### **Access to Markets Project**

The Port of Cotonou passed an inspection conducted by the United States Coast Guard to determine compliance with the minimum requirements of the International Ship and Port Security Facility (ISPS) Code. Security at the Port remains problematic but significant improvements were accomplished in August. Compliance with the ISPS Code is an important milestone in the Access to Markets Project.

#### **Access to Land Project**

From October 8-17, the Access to Land Project conducted a national information campaign through ten of the twelve departments (regional districts) of Benin. Accompanied by representatives of national and local government offices, farmers, and civil society groups, the Land Project directors held information sessions, reaching over 400 people, to inform local elected officials, civil society organizations, and local administrative offices on the Land Project's activities and the role that local institutions play in its success. Local institutions play a key role in providing information to ongoing national studies, and in communicating the benefits of formalized property rights to the population.

The activity for the expansion of formal land rights in rural areas has been launched. Through this activity, the Access to Land Project will produce rural land plans for 300 villages.

#### Access to Financial Services Project


MCA-Benin signed a partnership agreement with the Interbank Monetary Group of the West African Economic and Monetary Union (Groupement Interbancaire Monétique de l'Union Economique et Monétaire Ouest Africaine, or GIM-UEMOA). GIM-UEMOA will work with MCA-Benin to oversee a study on the feasibility of introducing various technological solutions to improve the supply of financial services to small, medium, and micro enterprises. GIM-UEMOA is the regional institution charged with defining the regulatory and security framework for the use of electronic banking.

The National Policy for Microfinance has been finalized and is expected to be submitted to the Council of Ministers for adoption. Adoption of this policy is an important milestone for the Access to Financial Services Project.

#### Access to Justice Project

MCA-Benin signed a Partnership Agreement with the Ministry of Justice. Through this agreement, MCA-Benin will help strengthen the capacity of the Inspection General office by providing training courses and materials. As the information needs of this office have been identified in a recent study, MCA-Benin will work with the Ministry to provide up-to-date and relevant documents and legal reference materials.



#### **Proposed Goal**

The proposal concentrates on the Northern region of Bolivia in the departments of La Paz, Beni and Pando, and comprises large infrastructure projects to improve major and rural roads, and a smaller project focused on rural productive development.

The main objectives of the proposal are to: 1) increase integration of a region historically isolated from the rest of the country; 2) reduce transportation time/costs while improving road infrastructure to foster greater national and regional interconnectivity; and 3) diversify the Bolivian economy from its reliance on natural gas and mineral resources.

#### **Update on Progress**

 The Bolivian Ambassador Gustavo Guzmán made a formal submission of the Bolivian proposal on September 21, 2007. The proposal is being reviewed by the MCC Bolivia Transaction Team.

#### **Proposed Goal**

Burkina Faso's proposed Program is expected to promote economic growth in the rural sector by (i) fostering land tenure security by strengthening the land planning regime, implementing a mediation and conflict resolution mechanism, and formalizing access to land rights; (ii) investing in irrigation and watershed management infrastructure and improving existing agro-industrial supply chains; (iii) constructing national roads and feeder roads. In addition, MCC and the U.S. Agency for International Development are currently in discussions with the government of Burkina Faso to facilitate the extension of the successful MCC Threshold program focused on girls' primary education.

#### **Update on Progess**

- Since November 2006, MCC staff and consultants have been reviewing technical
  documents and frequently traveling to Burkina Faso to assess the feasibility of the
  investments proposed by the MCA-Burkina compact development team (MCABurkina).
- In March, Ambassador Danilovich traveled to Burkina Faso in early March to visit a girl-friendly school built under the Threshold Program and to review compact development progress.
- Since May, MCC has been working with MCA-Burkina on administrative, legal, financial, and management planning for work required in connection with establishing the accountable entity. and to prepare a memorandum to the MCC Investment Committee to request 609(g) funding to support the establishment of the accountable entity. MCA-Burkina is engaged in recruiting key staff members of the team that will implement the Compact, once signed.
- In June, the MCC Investment Committee approved the transaction team's request for 609(g) funding to support the establishment of the accountable entity, to fund the first year's fees for the Fiscal Agent and Procurement Agent, to secure stakeholder participation in the preparation of a new land law and code, to complete final design and environmental assessment work for the roads project, and to collect baseline data for monitoring and evaluation activities. Procurement Negotiations of the agreements with of the Procurement and Fiscal Agents is are underway, and will be completed by the end of DecemberNovember. MCA-Burkina has nearly completed its selection of key staff for the implementation of the projects, and MCC is providing guidance to MCA-Burkina on the evaluation and selection processes.
- In November, MCC and the Government of Burkina Faso signed athe 609(g) grant funding agreement to facilitate compact development and implementation. with expected dDisbursements of the 609(g) grant are expected to beginning in early 2008. The transaction team and MCA-Burkina are working concurrently to refine the terms of the 609(g) funding agreement, and on continued due diligence ofn the project components and on preparation for implementation and management of the Compact. MCC staff and consultants continue to visit Burkina Faso regularly to examine details of the proposed investments.






#### **Compact Description**

MCC signed a 5-year Compact with the Government of Cape Verde on July 4, 2005, with the Compact entering into force in October 2005. The Compact supports Cape Verde in achieving its overall national development goal of transforming its economy from aid-dependency to sustainable, private-sector led growth. MCC funds are being used to improve the country's investment climate and reform the financial sector; improve infrastructure to support increased economic activity and provide access to markets, employment, and social services; increase agricultural productivity and raise the income of the rural population as well as carry out key policy reforms needed for sustained economic growth.

- MCC, MCA and the Government of Cape Verde have completed the 2nd Annual Review of Compact implementation and are preparing revised detailed project implementation schedules.
- Progress is being made on the Port of Praia project, with Phase 1 surveys completed
  and a consultant for Phase 2 studies selected. A Port Options report presenting results of Phase 1 studies was presented in August. The revised Port detailed project implementation schedule will take into consideration results of the 2nd Annual Review.
- Local teams from the Ministry of Agriculture are implementing Community Based Water Management Plans in all three interventions areas.
- The International Finance Corporation (IFC) is working with MCA on the four phased Partnership to Mobilize Investments (PMI) project which focuses on key sectors identified in a Phase I survey. Consultants have been contracted to develop plans and design deliverables in the areas of SME market access, tourism circuits, tourism linkages and public sector capacity building. Final selection of activities by a Government of Cape Verde committee, and which follow established Investment Guidelines, will lead to implementation of the action plans by Phase IV.
- The Compact is supporting a new system of public budget management and financial accountability by strengthening capacity for transparency in public finance for the entire government,
- Achievements have been made in government e-readiness; reductions in time to start
  a business; improved transparency in government operations; completion of monitoring & evaluation (M&E) baseline surveys and poverty profile surveys; public outreach
  and awareness campaigns on environmental issues and technical assistance (TA) in
  private sector investment.
- The Compact supports development that protects the environment and citizens' rights. MCA has held environment-related public awareness sessions, concluded baseline water studies, environmental impact assessments and environmental and social monitoring plans, and is completing water resource monitoring plans. Following resettlement action plans, MCA is negotiating compensation for land-owners and users along the roads planned for construction.
- The Compact supports HIV-AIDS prevention. All construction contractors are required to prepare awareness campaigns targeted to construction personnel and beneficiaries living along the roads and bridges being built on two islands. The initiative has been publicly praised as a "Best Practice" and a "Source of Inspiration" as well as a "funding window for HIV/AIDS projects" by the Executive Secretary of HIV/AIDS Commission in Cape Verde.







#### **Compact Goal**

El Salvador's Program is expected to play a key role in the transformation of the northern region of the country by: (i) significantly increasing the number of households with access to basic services such as water, sanitation and electricity; (ii) improving community infrastructure to facilitate greater access to health and education facilities as well to jobs and markets; (iii) spurring new investment in value-added production chains to increase productivity and competitiveness of local and national businesses; (iv) increasing the number of local people with the necessary skills to drive a growing and diversified economy; and (v) providing modern connectivity to local and regional producers with national, regional and global markets via the northern transnational highway and proposed network of complementary feeder roads.

#### **Update on Progress**

- Fondo del Milenio (FOMILENIO), the governmental entity responsible for the oversight and implementation of the program, was established by legislative decree in January 2007.
- The Board of Directors of FO-MILENIO was confirmed in March.
   The Board includes four Government of El Salvador representatives of the Government of El Salvador, one private sector representative and two non-governmental organization representatives.
- FOMILENIO's Advisory CCouncil has been fully formed and approved by the FOMILENIO Board of Directors. The
  - Advisory Council is made up of the following members: 5 cCommissioners of the National Development Commission, 3 mMayors from the Northern Zone (plus 3 alternate mMayors), and 1 civil society representative from the Northern Zone (and alternate).
- FOMILENIO selected a contractor to provide services under the pProductive Ddevelopment component of the program. For more information please visit www.mca.gob.sv
- The Ccompact entered-into-force on September 20, 2007. This marks the start of the 5-year Compact term of the compact and authorizes the disbursement of compact funds to FOMILENIO.

#### **Compact Goal**

MCC signed a 5-year Compact with the Government of Georgia in September 2005. The Compact program is designed to rehabilitate key regional infrastructure by improving transportation for regional trade, ensuring a reliable supply of energy, and improving the delivery of regional and municipal services. In addition, the program will develop regional enterprises by funding investment and increasing productivity in farms, agribusinesses and other enterprises to increase jobs and rural income. The Millennium Challenge Georgia Fund (www.mcg.ge) is administering the program, with oversight from the mixed governmental/ non-governmental/private sector Supervisory Board and a civil society Stakeholders' Committee.

#### Update on Progress Progress on the Road Rehabilitation

- Rehabilitation will be concentrated on roads traversing the Samtskhe-Javakheti region, enabling agricultural and other suppliers to more easily connect with consumers and helping the region to integrate economically through improved access to jobs and markets.
- The roads design and feasibility study as well as other components of the pre-construction phase have been finalized for 245 km of rural road.
- The procurement process for the construction of the road is presently underway. Construction is expected to begin in 2008.

# **Progress on the Energy Sector Rehabilitation**

- Phase 1 of repairs on critical sections Georgia's main natural gas pipeline totaling \$14.5 million in MCC funding were completed in 2007. Phase 2 repairs and rehabilitation are being designed for the 2008 construction season.
- The Georgian Oil and Gas Corporation (GOGC), the institution responsible for the long-term operations of the pipeline on behalf of the Georgian Government, is designing and supervising the repairs.
- The pipeline repairs include standards for environmental protection that are being employed by GOGC and private sector contractors for the first time.

# Progress on the Georgia Regional Development Fund

- The Georgia Regional Development Fund approved its second investment in November, 2007, bringing its total investments to \$3.5 million. The second investment of \$1.8 million supports the expansion plans of a Georgian hotel chain in several cities throughout Georgia.
- The Fund, managed by SEAF Management LLC, officially launched in January 2007, provides loan and equity capital for small- and mediumsized enterprises operating in the agribusiness and tourism sectors outside the capital, Tbilisi.

#### Progress on the Regional Infrastructure Development Project

- The Poti Municipal Water Project for rehabilitation of water delivery services has been initiated. As a result of the project, the population of Poti (50,000 people) will receive a 24 hour supply of safe drinking water. The MCC grant of \$5.55 million leveraged additional parallel financing for the total project costs of \$15.6 million.
- The Municipal Development Fund (MDF), a Georgian entity, is implementing the program that will provide funds for the rehabilitation of regional and municipal infrastructure, such as water supply, sanitation and irrigation

# Progress on the Agribusiness Development Activity

- A total of 51 grant agreements have been signed for an aggregate value of \$1,704,246. Thirty six grants are for primary agricultural producers, ten are for Farm Service Centers, and five are for agricultural processors and manufacturers.
- These projects will directly benefit approximately 500 farmers and indirectly benefit an estimated 36,000 rural Georgians who will have greater access to quality agriculture supplies and extension services.
- Grantees use funds to expand current production of fruit, vegetables, fish and livestock, improve/expand processing facilities for agricultural products, and open farm service centers to serve their local communities.





#### **Compact Goal**

The goal of the Ghana Compact program is to reduce poverty through private sectorled agribusiness development. Interventions aim to reduce poverty by increasing farmer incomes and export earnings. Specifically, these investments are designed to increase the production and productivity of high-value cash and food staple crops in some of Ghana's poorest regions and to enhance the competitiveness of Ghana's agricultural products in regional and international markets.

The Compact is comprised of three components: the Agriculture project (\$241 million) is designed to enhance the profitability of commercial agriculture among small farmers. The Transportation project (\$143 million) is designed to reduce transportation costs for rural farmers taking crops to market. The third component, a Rural Development project (\$101 million) is designed to expand the availability of basic community services such as access to education, water and sanitation, and electricity in rural areas.

#### **Update on Progess**

- Entry-Into-Force of the Ghana Compact occurred on February 16, 2007, with Initial Disbursement following soon after on March 7, 2007. With this disbursement, the Millennium Development Authority (MiDA) began work on the commercial training, agriculture credit, community services, and financial services activities of the Compact.
- President Kufuor recently appointed a new MiDA Board chair, Edward Boateng, who officially took up his post on August 1, 2007.
- MiDA signed an Implementing Entity Agreement with the Bank of Ghana (BoG) on September 13, 2007, allowing the BoG to begin implementation of the agricultural credit program.
- On September 17, 2007, MiDA signed an Implementing Entity Agreement with the Public Procurement Authority for the implementation of the procurement capacity building activity.
- MiDA signed an Implementing Entity Agreement with the Ministry of Food and Agriculture (MOFA) on October 22, 2007. This agreement will allow MOFA to identify and recruit farmer-based organizations to participate in the commercialization training. Training is expected to begin in March 2008.
- By end 2007, MiDA expects to have signed major contracts in all three component areas of the Compact. Implementation is expected to accelerate rapidly in early 2008.

#### **Compact Goal**

MCC signed a 5-year Millennium Challenge Compact with the Government of Honduras in June, 2005. The compact seeks to reduce poverty by increasing the productivity and business skills of farmers who operate small and medium size farms and their employees, and by reducing transportation costs between targeted production centers and national, regional and global markets. The Rural Development Project and the Transportation Project of the Program are respectively focused on achieving these goals. The Program seeks to improve incomes by \$69 million per year. MCA-Honduras (www.mcahonduras.hn), a Honduran government entity comprised of a technical unit and a supervisory board with civil society and government representation, manages the Program.

#### **Update on Progress** Rural Development Project

- President Zelaya, Ambassador Ford, Minister Hernandez and other officials attended the first year anniversary of the Farmer Training and Development Activity (FTDA) in Comayagua. During the event, Andy Medlicott, Executive Director of the entity that implements the FTDA , presented an overview of accomplishments highlighting success stories of progress in meeting targets in implementation. Through the FTDA, 1015 farmers are currently receiving technical assistance for crop production, product commercialization and training on production and small business skills through weekly on-farm visits by professional agronomists. In addition, 206 farmers are undergoing the selection process prior to official registration as program farmers.
- It is expected that 8,225 farmers will receive such training over the 5 year life of the Program. Relationships with exporters and local markets for commercialization of products grown by program farmers continue to be strengthened.
- During the month of October, program farmers invested more than \$86,000 in fixed assets, primarily related to the installation of irrigation equipment.

- 83% of program farmers sell their produce in the local market and the remaining 17% have begun production for exports to regional markets – tomato, sweet peppers, cucumbers and onions, and to the USA, Canada and the European Union – sweet potato, plantains and squash.
- MCA-Honduras is developing grant agreements for 7 proposals approved by the grants committee for funding through the Agricultural Public Goods Grants Facility. Disbursements to grantees are expected to commence by the end of November.
- Within the Farm to Market Roads Activity, more than 800 km. of rural roads have been evaluated and the corresponding ERRs for each road have been estimated. The mayors of the corresponding municipalities have demonstrated high interest in this activity and continue to actively support the MCA-Honduras team in completing the road selection process.

## **Transportation Project**

- MCA-Honduras has begun negotiations with people that will need to be resettled regarding the specific compensation they are due to receive. Approximately 800 people will be impacted or resettled along the MCA portion of the CA-5 highway improvement corridor.
- MCA-Honduras has submitted to the Honduran Congress a new decree to enable the resettlement activities in time to allow for construction on the CA-5 highway within the compact's timeline.
- The designs for the northern half of the CA-5 highway improvement have been finalized and the construction firms have been pre-qualified. Release of the bidding documents is expected in December and construction is expected to commence in April 2008.
- MCC has begun discussions with CABEI (Central American Bank of Economic Integration) and the Government of Honduras regarding a potential co-financing of works on the Southern segment of the CA-5.



#### **Update on Progress**

- Jordan has appointed a full time point of contact for MCC proposal development and assembled a team of dedicated professionals. This team is organizing data collection for the macroeconomic "constraints analysis", a first step toward a full proposal. Jordan's Threshold Program is advancing reform in the areas of political rights, civil liberties, voice and accountability, and economic freedom. The ongoing program is managed by US AID, which awarded contracts for customs modernization and municipal governance support projects earlier this year.
- The MCC team traveled to Jordan to provide detailed guidance on the macroeconomic constraints analysis, results of which will inform a subsequent consultative process. The delegation expects to meet with civil society and private sector representatives, donor partners, and Jordanian government officials to encourage broad participation in the development of a proposal.

#### **Proposed Goal**

Lesotho's Compact for approximately \$362.6 million over five years endeavors to reduce poverty by safeguarding the health of the population to achieve the productive participation of those of working-age in the economy and to secure the productive participation of future generations. - Public Outreach: An interview with MCC Resident Country Director, Gene Mac-Donald and Deputy Resident Country Director Brian Baltimore was published in the "Public Eye", a local newspaper in Maseru, on October 22.
- The first Disbursement Request for Compact Implementation Funding under the Compact and the related Quarterly Financial Rerport were approved by MCC on November 17.

#### **Compact Description**

MCC signed a four year Compact with the Government of Madagascar in April 2005. The Compact program is designed to augment incomes in rural areas by increasing land security, expanding competition in the financial sector, and increasing investment in farms and other rural businesses. Program implementation is focused on five discrete geographic high-potential zones. The Program is being administered by MCA-Madagascar (www.mcamadagascar.org), a Government of Madagascar entity, with oversight from a mixed public-private Steering Committee and a civil society Advisory Council.

#### **Progress on the Land Tenure Project**

- The Land Tenure Project is making progress towards a modernized decentralized national system. A total of 19 local land management offices have been opened and are issuing land certificates. Full expansion of decentralizing land management has begun in two of MCA-Madagascar's zones. Expansion into the remaining three zones is planned for January, 2008.
- All existing land documents in the 29 land administration services (a total of more than 876,000 documents) have been inventoried.
- Construction of permanent buildings for the existing land offices, and the architectural and environmental studies for the construction of the remaining estimated 240 land management offices that will be established by mid-2008, will begin in December, 2007.

#### **Progress on the Finance Project**

- The feasibility and design study for the new national inter-bank payment system has been completed, and implementation of this system is expected to begin in February, 2008.
- The \$1 million Institutional Support Fund for microfinance institutions

(MFIs) was launched and five proposals were selected to receive funding with the goal of increasing accessibility of credit in rural areas. These activities are expected to begin in early 2008.

A consulting team of international financial and legal experts (Eurogroup) is currently designing reforms to the banking and financial market laws, which will be submitted to the Malagasy Parliament for ratification

# Progress on the Agricultural Business Investment Project (ABIP)

MCA-Madagascar has established six Agricultural Business Centers (ABCs) operating in the five zones. These centers provide rural entrepreneurs with training and technical assistance on agribusiness technology, accessing credit and management skills. The centers have provided technical assistance to over 7,500 farmers, and have assisted farmer groups in mobilizing \$485,000 worth of loans from microfinance institutions through their training in business plan development. A consortium led by Chemonics, Inc. has been selected to scale up services being offered by the ABCs. The ABCs focus on a number of key value chains including, but not limited to, rice, onions, potatoes, essential oils, crab, and sugar cane.

#### **Compact Goal**

MCC's investments as described in the Compact will support the development of key infrastructure and policy reform for productive sectors by addressing Mali's constraints to growth and capitalizing on two of the country's major assets, the Bamako-Sénou Airport, gateway for regional and international trade, and the Niger River Delta for irrigated agriculture. The Compact program (Program) will increase production and productivity of agriculture and small- and medium-sized enterprises, as well as expand Mali's access to markets and trade. The Program objectives will be met through investments aimed to increase farmers' incomes, enhance agricultural supply chains, reduce transport costs and create a platform for industrial production.

#### The Program's three projects:

- Expansion of large-scale irrigated agriculture in the Alatona zone of the Office du Niger: Interventions proposed in this Project will focus on increased agricultural production and productivity, crop diversification, improved road infrastructure, access to credit and secure property rights for farmers, in turn catalyzing the transformation and commercialization of family farms.
- Renovation and modernization of the Bamako-Sénou Airport: Interventions proposed in this Project are designed to increase cargo and passenger capacity and improve efficiency and safety.
- Development of an Industrial Park in the Bamako-Sénou Airport domain: Interventions proposed in this Project are designed to establish Mali's first adequately serviced industrial park.

#### **Update on Progress**

- September 2007: The Compact entered into force on September 17. A ceremony and press conference at the MCA headquarters in Bamako marked the occasion. Members of the MCA-Mali Board of Directors, US Ambassador Terrence McCulley, and representatives of several Malian journals, in addition to the MCA and MCC representatives, were present. Entry into Force (EIF) marks the beginning of the five-year time limit for implementation of the Compact. Since EIF, nine key officers of the MCA management team have been selected through a competitive recruitment process. The next milestone will be the initial disbursement of funds under the Compact.
- October and November 2007: Public consultations have been ongoing since October 24, as part of the Environmental Impact Assessment and Resettlement Action Plan required for the Alatona Irrigation Project. Round 2 public consultations for the Kalabankoro, Kabala, Noumoubougou, and Sénou sites were also completed.
- November 2007: The CEO visited Mali for four days, meeting with stakeholders in the Segou region, visiting the Airport and Industrial Park sites, meeting with MCA staff, the MCA board, the Prime Minister and President, civil society members as well as attending the Community of Democracies conference. The visit received significant media coverage and served to reinforce the importance of common engagement toward the achievement of Compact objectives. The MCA-Mali Board of Directors met for a 3rd meeting and approved key documents for Initial Disbursement projected for December. A feasibility study finalization workshop for the Airport and Industrial Park components was hosted by MCA-Mali and attended by key Malian stakeholders and government officials.

- The Government of Moldova has identified the political and technical points of contact to serve as MCC's partners in the Compact development process, and has formed an MCA unit to perform necessary analysis for Moldova's eventual Compact Proposal to the MCC. Two representatives from the Moldovan core team attended MCC University in Washington, DC from March 19-23, 2007.
- The Moldovan core team submitted to MCC analyses of the country's economy and industry sectors. Input solicited from donors, members of the private sector and other members of the general public is included in the final reports.
- The Government of Moldova concluded the first phase of its consultative process on July 26, 2007, with a conference in Ungheni.
- On September 12, 2007, the U.S. Embassy in Chisinau hosted an event where all of Moldova's political parties were invited to hear more about MCC's processes and the results of the constraints analysis, sector analysis and consultative process.
- On October 24, 2007, the National Monitoring Committee for the Compact development process approved the preliminary components of the country Proposal. The second phase of the public consultations, framed around the approved preliminary components, was launched on November 20, and it is currently in progress. For more information on the consultative process and the approved preliminary components, please see the Government of Moldova's MCA website at www.mca.gov.md.
- The Moldovan core team has begun work on their formal proposal to MCC and are working with stakeholders to design components and activities for inclusion in the proposal in the coming months.

#### **Proposed Compact Goal**

The five-year \$285 million Mongolia Compact seeks to enable key institutions and infrastructure to better support the country's burgeoning urbanized, market-based economy and help Mongolians to increase their incomes by becoming healthier and better trained, by using their land assets more productively, and by increasing their capacity to trade with the world.

#### **Expected Results**

- The Mongolian Compact anticipates that the following benefits will result:
- By 2028, the Program is expected to benefit directly roughly 95% of the country's projected population in that year.
- Per capita incomes for all Mongolians are expected to be 3.5% higher five years after the start of the Program, and to increase by a total of 4.5% within 20 years after the start of the Program.
- These increases correspond to increments of \$158 million to annual GDP after five years, and \$404 million after 20 years.

• On October 22, 2007, the Government of Mongolia and MCC signed a five-year \$285 million Compact.

#### **Proposed Goal**

• The objective of the Government of Morocco's Compact with the MCC is to stimulate economic growth by increasing productivity and improving employment in high potential sectors. Three sectors are identified as focus areas of the MCC-funded program, in line with the country's strategy for economic growth:

1) agriculture and related activities, 2) small-scale, coastal fishing and 3) artisan crafts and tourism. The GOM requested funding for targeted investments along the value chain that would unlock opportunities and transform these sectors. The investments include market infrastructure, support to the financial sector, and training and technical assistance in business management to unleash small business creation and stimulate growth.

- August 2007: MCC's Board of Directors approved the Morocco Compact. The
  Compact signing ceremony took place in Tétouan, Morocco on August 31. Immediately after Compact signing, King Mohammed VI and the Counsel of Ministers met to approve the legislation to ratify the Compact and establish the Accountable Entity. The legislation is expected to be presented to the parliament
  for full ratification in late 2007.
- September 2007: The Government of Morocco and MCC are finalizing the procurement schedule for the period prior to the Compact's Entry into Force.
- October 2007: The Government of Morocco released the General Procurement Notice for the compact implementation funding period. It is available through the MCC website.







#### **Program Summary**

The objective of the \$507 million program is to increase the productive capacity of the population in selected districts of northern Mozambique, with the intended impact of reducing poverty, increasing household income and employment, and reducing chronic malnutrition. The Program seeks to help unlock the economic potential of the north, which is crucial to sustaining Mozambique's growth, by removing key binding constraints to growth and enhancing key water/road sector institutions. Specific interventions include: rural and urban water and sanitation, roads, improved land administration, agriculture, and cross-cutting policy reforms and capacity building initiatives.

#### Update on Progress

- MCA Mozambique submitted a proposal to MCC on July 1, 2005. MCC and the Government of Mozambique (GOM) executed a \$6 million pre-Compact Grant Agreement on September 9, 2005, which was amended on June 16, 2006, to increase the pre-Compact funding to up to \$13.5 million to assist with developing a final program design and implementation framework for the proposed Compact. Implementation of the pre-Compact assistance culminated in the GOM's submitting a revised proposal in December 2006, on which MCC's due diligence was com¬pleted in May 2007. On July 13, 2007, the MCC and the Government of Mozambique signed a \$506.9 million Compact in a ceremony witnessed by President Armando Guebuza and Deputy Secretary of State, John Negroponte.
- The Compact was ratified on August 7, 2007, by the Council of Ministers. The Council of Ministers also approved on August 7, 2007, the creation of MCA-Mozambique, a public institution under Mozambican law with distinct legal, administrative and patrimonial autonomy for the implementation of the Compact.
- Several members of the Management Unit of the MCA Mozambique have been selected, following an open and competitive recruitment process. They are expected to be fully engaged by the end of the year. The recruitment process for management officers and project managers will continue through the first quarter of 2008.
- The procurements for the Fiscal and Procurement Agents are underway and the contracts are expected to be executed in mid-December.
- Ambassador John Danilovich visited Mozambique during the month of November. He visited the Nampula and Cabo Delgado provinces in Northern Mozambique. During his visit, he met with stakeholders, potential beneficiaries, private sector representatives, media, academics, and national and local authorities to discuss the implementation of the Compact. While in Maputo, he met with President Guebuza and a number of cabinet members to discuss the progress of the Compact's start-up phase and the challenges of the upcoming months.

#### **Proposed Goal**

Namibia's Compact Proposal seeks to reduce poverty through economic growth and foster economic transformation. The proposed program aims to achieve this goal in two ways: increasing the competence of the Namibian workforce (knowledge, skills and attitude), and increasing the productivity of (on-farm and off-farm) enterprises in rural areas. Key sectors proposed include: Education, Agriculture (livestock and indigenous natural products), and Community Based Tourism with supporting investments in roads.

- In late November 2007, an MCC team of staff and consultants traveled to Namibia to introduce the new MCC team management to key Government of Namibia counterparts, U.S. government officials, and other relevant stakeholders involved in the MCA process, and to participate in the Livestock Project Roundtable on improved market access and rangeland management.
- Since kicking off due diligence in February, 2007, MCC has conducted due diligence missions to Namibia for livestock, indigenous natural products, financial management, monitoring & evaluation, tourism, property rights & land policy, economic analysis, infrastructure, environmental & social assessment, education and procurement. Due diligence missions on property rights and land policy, tourism, and education are scheduled to occur in December 2007.

**Compact Goal** 

MCC signed a 5-year Compact with the Government of Nicaragua on July 14, 2005. Nicaragua's program for MCA assistance seeks to advance economic growth and poverty reduction by funding three projects in the Northwestern part of the country, an impoverished region with significant growth potential.

The program will reduce poverty and spur economic growth by funding projects in the regions of León and Chinandega aimed at reducing transportation costs and improving access to markets for rural communities, increasing wages and profits from farming and related enterprises in the region, and increasing investment by strengthening property rights. The MCA-Nicaragua Foundation (www. cuentadelmilenio.org.ni) administers the program.

#### **Land Regularization Component**

- An early titling effort has been approved to identify and clean approximately 464 property titles on a beneficiary-demand basis, prior to the initiation of the large-scale, more systematic property regularization campaign.
- In September 2006, MCA-Nicaragua publicly launched the Property Regularization Component of the Compact, awarding the first 26 clean titles to beneficiaries in the Department of León. This included 16 urban titles and 10 rural titles, many of which went to female landowners. These titles are the first of 43,000 titles to be delivered under the Program.

#### Rural Business Development Component

• The Rural Business Development Component of the program has assisted producers to develop and implement nearly 1,000 business plans. Approximately 985 bean, cassava and sesame producers have received technical assistance in marketing their products, thereby increasing profits. MCA-Nicaragua assisted a group of local cassava producers, who were able to export several containers of cassava (one to the U.S., another to El Salvador), doubling or tripling the price they normally receive on the local market.

- Investment promotion activities through ProNicaragua and MCA-N have resulted in investment commitments that will create 1,300 jobs in Leon and Chinandega.
- More than 300 cattle producers are receiving technical and market access assistance. Six milk collection facilities have now been installed, assisting approximately 150 cattle farmers (including 34 women) to improve milk quality, yields and market access.
- MCA-Nicaragua will assist during this agricultural cycle with the establishment of 1,100 hectares of high value timber, fuel wood and fruit trees as part of a larger effort to develop a forestry cluster MCA-Nicaragua has teamed with a government-initiated forest fire prevention campaign aimed at reducing the major environmental problems caused by seasonal forest fires. The watershed management project will complement this initiative.
- Five private tree nurseries are being developed and supported to grow trees for reforestation. MCA-Nicaragua has facilitated the planting of over 700,000 trees to date and expects to reach 1 million in the next 3 months with 476 farmers.
- MCA-N signed the livestock cluster development contract in September 2007. The services carried out by the contracted firm will benefit approximately 1,700 rural producers.

#### **Infrastructure Project**

- The Government of Nicaragua passed critical road maintenance funding legislation prior to entry into force of the Compact. This legislation helped to collect more than USD\$10 million for roads maintenance during 2006.
- Survey work on the Nejapa-Izapa road is underway. In addition, large trucks are being weighed in key sections of the road to obtain data that will be used for the final designs.
   Aerial photography has been completed. The traffic studies for the primary road segment will last approximately three weeks.



Total Disbursed to Date






#### **Proposed Goal**

MCC and the Government of Senegal continue to collaborate on design and assessment of a program which will address key constraints to Senegal's development, and promote poverty reduction through economic growth.








#### **Proposed Goal**

The goal of the proposal from the Government of Sri Lanka (GOSL) is to reduce poverty by fostering economic growth in targeted areas where poverty is particularly acute. As revised following due diligence, the GOSL proposal focuses on rehabilitation of roads to improve cost effective access to markets.

#### **Update on Progress**

 In light of the ongoing security concerns in Sri Lanka, MCC will consider a resumption of compact due diligence activities when there is a greater prospect for success of our mission.

#### **Proposed Goal**

The goal of the proposed program is to stimulate economic growth, increase household incomes, and raise the quality of life in program areas through targeted infrastructure investments in transportation, energy, and water. The Government of Tanzania views a Compact with MCC as a major opportunity to assist in implementing its National Strategy for Growth and Reduction of Poverty, finalized in 2005. The proposed program is expected to be well coordinated with other donors' activities and may leverage many of their investments.

- On September 14, 2007, the Millennium Challenge Corporation's Board of Directors approved the MCC Compact with Tanzania.
- Millennium Challenge Account-Tanzania (MCA-Tanzania), the Accountable Entity responsible for the implementation of the Compact, was formally constituted by the Government of Tanzania in September 2007 through publication of an official Government Notice.
- In October 2007, President Kikwete appointed the Chief Executive Officer and two Deputy Chief Executive Officers of MCA-Tanzania.
- On October 4, 2007, a \$9.8 million pre-Compact agreement was executed between MCC and the Government of Tanzania to fund feasibility and environmental assessment studies and some start-up costs of MCA-Tanzania.
- The inaugural meeting of the MCA-Tanzania Board of Directors is scheduled to take place on December 5, 2007.

- The Government of Timor Leste (GTL) submitted a draft Compact proposal to MCC in February 2007 that included investment proposals in the transportation, power, and water/sanitation sectors, vocational education and skills training, and a complementary private sector development component.
- An MCC delegation visited Timor Leste in March 2007 and requested GTL to conduct wider public consultations and to consider a tighter focus for its proposal. GTL is also planning to conduct technical analysis on the proposed projects, and to examine options for implementation arrangements, taking into account limited capacity of line ministries. Parliamentary elections were held in June 2007 followed by the formation of a new Government in August 2007, which was accompanied by civil unrest.
- Further progress on the proposal and Compact is to be determined by the new Government's selection of a MCC point of contact and formation of a team.

#### **Update on Progress**

- MCC conducted an initial visit to Ukraine from January 18-24, 2007 to discuss the MCC Compact development process with the Government of Ukraine (GOU) and other key stakeholders and to describe next steps.
- A second visit took place from March 11–17, 2007 during which the MCC delegation met with the regional governments of Lviv, Odessa, Dnepropetrovsk, and the Autonomous Republic of Crimea. This visit focused on raising awareness of MCC's existing threshold program in Ukraine and of Ukraine's eligibility to participate in MCC's compact program. The visit also focused on engaging the regional governments, NGOs and private sector leaders in the compact development process.

#### **Compact Goal**

The five-year, \$65.69 million Compact addresses improvements of the country's transportation infrastructure. Consisting of eleven infrastructure projects—including roads, wharfs, an airstrip and warehouses—the program aims to benefit poor, rural agricultural producers and providers of tourist related goods and services by reducing transportation costs and improving the reliability of access to transportation services.

#### **Expected Results**

The MCC program is expected to have a transformative impact on Vanuatu's economic development by increasing average income per capita by 15% within 5 years and directly impacting the lives of more than 65,000 poor, rural inhabitants. The Compact also includes institutional strengthening efforts and policy reform initiatives in Vanuatu's Public Works Department, namely: provision of plant and equipment for maintenance; introduction of service performance contracts; establishment of local community maintenance schemes; and introduction of user fees. These efforts aim to ensure the sustainable operation and maintenance of Vanuatu's entire transport infrastructure network, not only those assets built or rehabilitated with MCC funds.

- On September 27, 2007, MCA-Vanuatu opened the bids (technical proposals) from short-listed bidders for design and construction of all Compact civil works projects (one contract). The bids are undergoing final evaluations.
- During September 19-21, 2007, MCA-Vanuatu conducted public consultations
  with communities on Malekula and Pentecost islands, regarding the anticipated
  road, wharf, and warehouse projects. These consultations involved chiefs, local
  farmers and villagers, women's groups, and church groups, and focused on preparatory activities in advance of detailed design and project construction.
- Consultations were also held with borrow pit owners and the Department of Geology and Mines to alert them to the expected demands for materials and for issuance of mineral extraction permits. Similarly, consultations have been held with stevedoring and wharf service operators and the Ports and Harbour Department to alert them to the upcoming need for movement and storage of large quantities of imported materials and equipment.
- Vanuatu's 2007 National Budget contains a substantial increase—of approximately 125 %--in the Public Works Department's annual budget for road maintenance. PWD has recently commenced large-scale maintenance activities and institutional strengthening activities in response to this funding increase.
- Compilation of baseline data for the Household Income and Expenditure Survey (HIES) has been completed. This survey serves as the primary source for measuring goal-level indicators of the Compact,
