How Much Money Could New Yorkers Receive From the Earned Income Tax Credit?

The Earned Income Tax Credit (EITC) puts money back into the pockets of those who need it most and who are most likely to spend it immediately, thereby providing a boost to the economy. Unfortunately, it is also one of the most underused tax credits available despite the outreach efforts of the Internal Revenue Service (IRS). While prohibiting tax fraud is a noble goal, the IRS' announcement that it will now be requiring a higher level of proof to claim the EITC than for other tax credits is a step in the wrong direction for thousands of New Yorkers. Based on data from the 2000 tax year, over 140,000 people from Upstate New York who were eligible for the credit did not claim it, meaning they missed out on over \$231 million in tax refunds. The following report shows how many people in each county claimed the tax credit in 2000 and how many people were eligible yet did not apply.

The Capital Region: In 2000, there were over 358,000 ETIC claimants in the Capital Region. Unfortunately, over 17,000 people in the region who were eligible for the tax credit did not apply for it, meaning they missed out on \$27.5 million or over \$1,500 each.

Central New York: In 2000, there were over 324,000 ETIC claimants in Central New York. Unfortunately, over 18,000 people in the region who were eligible for the tax credit did not apply for it, meaning they missed out on \$29.4 million or about \$1,600 each.

The Finger Lakes: In 2000, there were almost 442,000 ETIC claimants in the Finger Lakes. Unfortunately, over 22,000 people in the region who were eligible for the tax credit did not apply for it, meaning they missed out on \$36.3 million or about \$1,600 each.
