Mixtures of sodium-2-chloro-6-[(4,6 dimethoxypyrimidin-2-yl)thio]benzoate (CAS No. 123343-16-8) and application adjuvants (Pyrithiobac-sodium) (provided for in subheading 3808.30.15).

The subject formulated products are herbicides containing the active ingredient pyrithiobac-sodium. These postemergence herbicides are used primarily for selective grass and broadleaf weed control in cotton crops. The subject products are imported from Japan.
