# Update: After Coal Ash Spill, TVA to Begin Replacing Damaged Rail Tracks at 1,456 MW Kingston Coal-fired Power Plant in Tennessee

The Tennessee Valley Authority (TVA) has removed all rails and ties at its Kingston coal-fired power plant in Tennessee, and expects to begin installing new tracks this week, it said. The plant has been unable to receive new coal shipments since December 22, when a massive ash spill blocked roadways, rail lines, and destroyed nearby homes. The new tracks will enable the plant to accept deliveries. Seven of Kingston's nine coal-fired units remain down, a source confirmed, as TVA seeks to preserve the facility's on-site coal supplies. The company also cited lower electricity demand in its decision to keep the units offline. Separately, a U.S. Senate panel asked TVA's Chief Executive Officer to testify on January 8 as to whether TVA might require more regulatory oversight. http://www.tva.gov/

### **Update: Explosion Could Postpone Start Date for SRP's Planned 400 MW Springerville Coal-fired Unit 4 in Arizona**

Salt River Project's (SRP) planned 400 MW Springerville coal-fired unit 4 in Arizona might not open on schedule, the company indicated, after a December 31 transformer explosion caused significant damage. The unit had been slated for a September 2009 start date, and a company official said that was still a possibility. If not, SRP said it would purchase power supplies elsewhere. The incident occurred as workers performed tests to a new unit at the facility; an electrical arc caused a transformer to explode. ## High Winds Preclude Tanker Loadings, Curtailing About 1.38 Million Barrels of Alaskan Oil Production over Nine Days

Winds continued to impede tanker loadings at the Port of Valdez in Alaska on January 5, Alyeska Pipeline Services confirmed, as throughput along its 800-mile Trans-Alaska crude-oil pipeline remained curtailed. Alyeska has been using only one of two loading berths at Valdez since December 29. Since that date, Alaskan producers have cut oil output by about 1.38 million barrels, cumulatively.

## State Officials, Flint Hills Resources Work to Avoid Shutdown of 210,000 b/d North Pole, Alaska Refinery

Flint Hills Resources' 210,000 b/d North Pole, Alaska refinery is struggling financially, the company has said, and state officials worry that its possible shutdown could hold negative, statewide economic impacts. Flint Hills' parent company, Koch Industries, canceled previous upgrade plans and put the refinery up for sale. It said it might also convert the facility into a receiving station. Under that scenario, it would distribute, but not produce fuels. Alaskan officials are working with the company to avoid any disruption, and at least one source said the state would consider buying the facility.

### EnCana Corp Plans 400 MMcf/d Natural Gas Processing Plant in British Columbia, Canada

EnCana Corp filed plans with the provincial government to build a 400 MMcf/d natural gas processing plant in British Columbia, Canada. The facility would process Horn River Basin natural gas. Depending on gas supplies, construction could encompass as many as six phases. The company hopes to break ground in March 2010, and open the project's first phase by 2011.

### Western Canadian Coal Plans to Reduce Operations at Two Coal-Producing Facilities in British Columbia, Canada

Citing market conditions and higher inventory levels, Western Canadian Coal said it planned to slow run rates at its Brule mine and Wolverine operation in British Columbia, Canada. The company will reduce Brule's run rate from 1.3 million tonnes/year to 750,000 tonnes/year, effective at the end of this month. It might also curtail operations at its Wolverine operation, beginning May 18, 2009. That facility is currently operating at an annual run rate of 1.6 million tonnes. The company attributed the reductions to rising inventory levels; it said some customers had deferred shipments through the next few months. The facilities will operate at reduced rates until economic conditions improve, it said in a release.
