# **Appendix D**

### 4. ELEMENTS OF THE BANKRUPTCY CASE FILE

*Interpreting this Chart—Assumptions and Conventions* 

ADVERSARY PROCEEDINGS--The "Proceeding" column has been left blank in the adversary proceeding sections of this chart because, by definition, all of those documents are part of such proceedings.

ATTACHMENTS -- Many motions and other documents are filed with attachments. Attached items may include any of the following: proposed orders, briefs or memoranda of law or of points and authorities, signed affidavits, signed declarations, or other signed documents (*e.g.*, deeds, mortgages, financing statements, leases, contracts).

CREATOR -- Generally, the creator of a document also will be its signer. A document created by one entity, however, may be signed by another. For example, a party may draft ("create") a proposed order that later is signed by a judge.

INVOLUNTARY CASE -- If an involuntary petition is contested, adversary procedures will apply.

NOTICES -- A printed copy of a notice is required if service of the notice is to be made by mail or by hand-delivery.

PARTY -- The term "Party" includes the debtor, creditors, any trustee, the United States trustee or bankruptcy administrator, and any "party in interest" who files a document in the case (e.g., a tenant or licensee), but not the clerk or the judge.

PROPOSED ORDERS -- See discussion of "Attachments," above.

SIGNATURES -- Every document generated and filed by an attorney or pro se party is presumed to be governed by Fed. R. Bankr. P. 9011. Accordingly, except for those documents especially exempted by Rule 9011 (a list, schedule, statement, or amendment to any of these), we have assumed signature by the attorney. Likewise, we have assumed that the bankruptcy judge signs every order. We likewise have assumed that any electronic case files system will include mechanisms for electronic "signing" by judges of the court and attorneys practicing there. Under these assumptions, therefore, we have noted signature requirements only when another individual -- such as the debtor, a creditor, a non-attorney professional, a process server, or a judge from another court -- must sign. We also have noted when a signature must be verified.
