MEMORANDUM OF UNDERSTANDING

ON

NEW JERSEY NATIONAL GUARD SUPPORT TO COUNTERDRUG OPERATIONS

1. **INTRODUCTION:** This is an agreement between the Department of the Interior (hereinafter referred to as the LEA) and the Department of Military and Veterans Affairs (hereinafter referred to as the NJNG). The agreement sets forth policies and procedures agreed to by the LEA and the NJNG concerning the use of NJNG personnel and equipment in support of counterdrug operations. In addition, it establishes lines of communication, delineates areas of responsibility and procedures to provide for timely, effective responses by the New Jersey National Guard to requests for assistance made by the LEA. For the purposes of this Agreement, the responsible official for the LEA shall be:

- 2. **OBJECTIVES:** The LEA and the NJNG agree that they enter into this Memorandum of Understanding to assist each other in accomplishing the following objectives:
- a. To significantly reduce illegal drug production, importation, distribution and use in the State of New Jersev.
- b. To establish policies regarding the employment of NJNG personnel in aerial observation and other drug interdiction/eradication operations.
- c. To establish procedures by which the LEA may request assistance from NJNG personnel and/or equipment in support of drug surveillance, interdiction and eradication operations.
- d. To establish procedures for training and exchanging information gathered during operations of both agencies.
- e. To increase expertise of NJNG personnel in aerial observation, ground inspection and other drug interdiction/eradication techniques for the purpose of gathering information pertaining to the growing, harvesting and/or distribution of illegal drugs, and the detection thereof, while conducting normal aerial training missions and requested ground inspections.
- 3. **PARAMETERS FOR EMPLOYMENT OF NJNG PERSONNEL AND EQUIPMENT:** Except as otherwise provided by the Federal Tort Claims Act, and other statutes, NJNG personnel shall not be deemed to be employees of the LEA while engaged in any activity under this agreement.

- a. NJNG personnel performing inactive duty status training, or full time training duty under Title 32, United States Code are limited, by federal law, from direct involvement in civilian law enforcement operations. Their activities will be limited to the National Guard Bureau pre-approved counterdrug missions (Enclosure 1), not the actual law enforcement activities customarily performed by police agencies or drug enforcement agencies.
- b. NJNG personnel will not be employed in a direct law enforcement role. They will not interdict or arrest persons engaged in criminal activities. NJNG commanders and counterdrug supervisors (hereinafter commanders) will ensure that their personnel are not put in situations that could place them in direct contact with suspects. NJNG personnel will be under the supervision of the NJNG operational element commander and under operational control of the LEA Agent/Officer in Charge. NJNG operations will be executed through the military chain of command. Their activities will be concentrated on, but not limited to ground/air reconnaissance/surveillance, surface transportation support, training of LEA personnel, aerial photographic reconnaissance, liaison, planning, coordination and reporting support.
- c. The LEA will be responsible for all follow-up actions on criminal activities observed by the NJNG. No member of the NJNG will be involved beyond reporting of information except upon a specific request by the LEA and subject to specific authorization by the Adjutant General (TAG).
- d. NJNG counterdrug support activities will be conducted in accordance with NGR (AR) 500-2/ANGI 10-801. No assistance of any kind will be rendered unless requested in writing by the LEA. No assistance of any kind will be rendered if, in the opinion of TAG or his designee, the assistance will adversely impact the formal training mission of the New Jersey National Guard or upon emergency response and mobilization missions having priority.

e. <u>Duty Uniforms</u>:

- (1) National Guard Personnel will wear the appropriate duty uniform during the conduct of Counterdrug Support Operations. Situations may arise when wearing civilian clothing or coveralls would be appropriate, such as:
- (a) When NG personnel accompany plain-clothes law enforcement officers during observation or surveillance operations.
- (b) When the supported LEA requests that NG personnel wear appropriate civilian attire for OPSEC or other security reasons.
- (2) In each situation, the Adjutant General is the approving authority for the wear of civilian clothes or coveralls on a case-by-case basis. All requests for National Guard personnel to wear civilian clothing should be forwarded to the NJNG Plans, Operations and Military Support Officer (POMSO) or the Counterdrug Officer (CDO) for The Adjutant General's approval.

f. <u>Interstate Use of NJNG Personnel</u>:

- (1) The LEA will not assign NJNG Personnel to missions which may require them to leave the State of New Jersey without the prior written approval of the POMSO/CDO.
- (2) In exigent circumstances involving federal LEAs the NJNG POMSO or CDO may authorize NJNG personnel to leave the State of New Jersey in support of a continuing counterdrug operation.

4. REPORTING PROCEDURES:

a. The LEA will provide reporting procedures for all information collected by NJNG personnel during the course of an operation. Reports will be made by radio, telephone, and/or writing as directed.

- b. Written reports will be prepared by NJNG personnel and turned over to the Officer in Charge (OIC), IAW NGR (AR) 500-2/ANGI 10-801.
- c. The POMSO/CDO will receive statistical results of each operation for inclusion in required reports/records. Results must include quantity and value of interdicted or eradicated drugs, etc.
- d. The LEA will be the office of record for all information gathered during operations and will be responsible for follow-up actions.

5. **COMMAND AND CONTROL PROCEDURES:**

- a. All requests for assistance from the NJNG made by the LEA must be directed to Assistant Attorney General (AAG) in charge, N.J., Statewide Narcotics Task Force, (SNTF), or his designee. The AAG in charge, SNTF will be responsible for evaluating the request and coordinating with the POMSO/CDO. Direct coordination of activities with local NJNG Commanders must be authorized by TAG. The AAG in charge, SNTF and NJNG POMSO/CDO are identified in (Enclosure 2) of this Memorandum of Understanding.
- b. New Jersey National Guard commanders will retain final authority over flight/ground operations of NJNG aircraft and vehicles.

6. **OPERATIONS SECURITY:**

- a. Information gathered by members of the NJNG will be treated in the same manner as classified military information within the NJNG. Information furnished by the NJNG to the LEA will be treated as "sensitive." Information reported for law enforcement purposes may be disclosed for civil or criminal judicial purposes in accordance with the applicable statutory and regulatory provisions.
- b. Any inadvertent disclosure of mission-sensitive information, by either the NJNG or LEA will be immediately reported, through the respective chain of command, to the LEA officer in charge and the NJNG officer in command.
- c. The NJNG will provide a list of all NJNG personnel involved in drug enforcement support operations to the AAG in charge, Statewide Narcotics Task Force. This list will include the relevant names, addresses, dates of birth and social security numbers of all personnel. The NJNG will update the list as personnel are added or deleted and will inform the SNTF immediately if any NJNG member on the list is arrested or otherwise suspected of involvement in illegal narcotics activities.
- d. National Guard personnel volunteering for duty in the Counterdrug Support Program will be screened for eligibility by the NJNG IAW paragraph 2-4d, NGR (AR) 500-2/ANGI 10-801. Final selection by the LEA will be by written notification of acceptance of the individual, verifying that the individual meets LEA security prerequisites.

7. **COMMUNICATIONS**:

- a. When possible, all planning and coordination will be accomplished in person.
- b. Operations and intelligence information will not be discussed/disclosed over unsecured telephone or radio facilities.
- 8. **SCOPE OF APPROVED OPERATIONS:** The NJNG may provide, as appropriate and available, one or more of the listed services or resources (which are on the attached list of eligible activities contained in NGR (AR) 500-2 / ANGI 10-801) in response to a request for assistance from the LEA:

- a. Provide aerial platforms to search for and observe drug production sites, smuggling routes and distribution activities.
 - b. Provide aerial platforms to insert law enforcement officers in close proximity to target missions.
- c. Provide airlift and transportation of LEA personnel and equipment in conjunction with an ongoing CD operation.
- d. Conduct photographic reconnaissance and interpretation missions relating to narcotics production, smuggling and distribution.
 - e. Provide radar operations for air/marine interdiction programs.
- f. Provide transportation of seized evidence, equipment or assets that are under law enforcement control.
- g. Provide transportation of prisoners who are under law enforcement control <u>from the arrest</u> <u>location to the initial Detention Facility only.</u>
- h. Construct command, control and communications (C3) bases/systems in support of law enforcement operations.
- i. Provide integration of command frequencies and equipment to facilitate C3 operations. Man and operate C3 facilities.
 - j. Provide aerial command and control platforms in support of law enforcement missions.
 - k. Provide stand-by MEDEVAC.
 - I. Loan equipment and/or operate and maintain the equipment.
 - m. Conduct ground surveillance and data collection missions.
 - n. Conduct training of law enforcement officers.
- o. Report information concerning suspected illegal drug activity obtained during routine NJNG missions.
- p. Identify and refer to the LEA serviceable surplus equipment that may be used in law enforcement missions.
 - q. Assist with cargo examinations at ports of entry.
- r. Other activities as NGB may, from time to time, authorize and which shall be attached hereto as Enclosure 1.

9. PROPERTY/EVIDENCE ACCOUNTABILITY:

- a. The loan of NJNG equipment and special mission requests will be in accordance with current National Guard policies, procedures and regulations.
- (1) The Adjutant General has authority to use federal property issued to the National Guard in support of counterdrug support operations. Loan and lease of equipment is governed by AR 700-131, and

AFM 67-1/ANGR 67-1. The United States Property and Fiscal Officer (USPFO) for New Jersey is responsible for preparing and negotiating agreements, and approving loans and leases of equipment.

- (2) Requesting agencies are encouraged to consult POTO-MS-CDS on equipment availability. Equipment availability for training for the wartime mission will be considered before each loan is approved. Loans will not be used in lieu of leases. All equipment loans for drug support will be reported to NGB-CDS.
- (3) Loan requests from the **state and local** agencies should be routed, in letter format on official agency departmental stationary, to the POMSO or CDO. All requests will be supported by a surety bond equal to the total price of the borrowed items. Bond will consist of a properly executed surety bond with a certified bank check, cash, or negotiable U.S. Treasury bonds.
- (4) Loan requests from the **federal** agencies should be routed through the agency's headquarters to DOD, and subsequently to POTO-MS, NJARNG. Requests for support from federal agencies listed in the Task Organization of the State Plan to support counterdrug operations may be channeled directly to the POMSO or CDO.
- b. <u>Rules of Evidence</u>. Court rules provide that exhibits cannot be offered into evidence in legal proceedings unless a chain-of-custody can be shown. This is especially true for items subject to adulteration. To ensure admissibility of evidence, only law enforcement officers should seize or possess any items that are or may become, evidence. Only under exigent circumstances may National Guard personnel handle potential evidence.
- c. Requests from the LEA for support by NJNG other than the National Guard Bureau preapproved counterdrug missions (Enclosure 1), on a non-interference with training basis, may be rendered upon certification by the Attorney General that the request is consistent with and not prohibited by State law, and approval of the National Guard Bureau. Examples, of such support may include, but are not limited to, the loaning of equipment, transportation of drug/law enforcement personnel, training and advising civilian law enforcement officials in the operations and maintenance of military equipment and the transporting of equipment or confiscated contraband. These requests must meet the following criteria:
 - (1) Mission must be compatible with the State Plan.
 - (2) Requested support must not interfere with scheduled training.
- (3) Contemplated modifications in training must not encroach upon environmental areas of other units/agencies without prior approval from TAG.
 - (4) Flying hours must be within allocated program.
- (5) Personnel and equipment must not be subject to known hostile environment (personnel and equipment maya be used to provide support in an operational area provided the threat of hostile direct fire has been eliminated). In (i.e., sniping from mountains or valleys) it may be prudent to provide support outside the objective area. Law enforcement authorities shall provide all available information regarding hostility or violence so that authorized NJNG personnel can evaluate the mission request.

10. FORCE PROTECTION:

- a. <u>Purpose</u>. The purpose of this guidance is twofold:
- (1) To emphasize the importance of safety when conducting drug enforcement support operations.

- (2) To alert personnel to applicable areas of force protection, policy and law.
- b. <u>Force Protection</u>. Commanders will ensure that pre-operation (liaison) coordination and planning with supported law enforcement agencies addresses the safety of National Guard personnel and equipment throughout the operation. Consideration will be given to potential threats to National Guard personnel and property for force protection purposes. Commanders will also ensure that public affairs efforts, directed at complying with the right of the public to know, do not jeopardize the safety of National Guard personnel and equipment by disclosing personnel identification in photographs or video recordings by the media.
- c. <u>Arming of Troops</u>. Since the NJNG is in a support role and not directly engaged in law enforcement, Guardsmen should rarely be armed. Weapons and small arms ammunition (State Security Ammunition), when issued, will only be used for personal protection. Arms and ammunition will be secured until issued. NJNG personnel will be armed only on order of **THE ADJUTANT GENERAL**, responding to a formal request from the SPECIAL AGENT IN CHARGE. Firearms will not be discharged from aircraft or motor vehicles.

d. Use of Force.

- (1) Guardsmen have the right to use force:
- (a) To defend themselves, other members of their team, law enforcement officers, or other persons,
 - (b) To protect property.
- (2) Deadly force (any force capable of causing serious injury or death) may only be used under the following circumstances:
 - (a) All other means have failed.
- (b) Risk of injury to other persons or bystanders is not increased by the use of deadly force.
- (c) Deadly force is the minimum force necessary to prevent death or serious injury to the Guardsman, other members of their team, law enforcement officers or other persons.
- e. <u>Arrest Powers</u>. Guardsmen will be advised that their powers of arrest are normally those of ordinary citizens as opposed to law enforcement officers. Arrest powers are prescribed by state law and the state JAG should provide detailed guidance with regard thereto.

11. PUBLIC AFFAIRS:

a. Public Affairs Guidance:

- (1) Counterdrug operations support generates considerable media interest. Safety and security concerns dictate that caution and restraint be exercised in dealing with the news media on NJNG support of these operations.
- (2) NJNG support to counterdrug operations will not be publicized unless authorized by HQ NJARNG Public Affairs Office (PAO) and the lead LEA Public Affairs Office.
- b. Information released to the media concerning NJNG assistance to the LEA or NJNG participation in counterdrug missions will be coordinated between the LEA and NJNG public information

officers. Participating National Guard personnel or specific units will not be identified by name, address or photograph unless cleared by the N.J. National Guard PAO.

12. **SAFETY:**

a. <u>Aircraft Safety</u>. The operation of aircraft constitutes a significant hazard. Pilots in Command (PIC) are responsible for the aircraft and the lives of passengers and crew. In addition to other guidance on aircraft safety, PIC will not fly into or land in known hostile fire areas and will ensure that passengers are instructed in the principles of aircraft safety. Aircraft will maintain a minimum safe distance (no less than 200 meters) from any known hostile elements (out of effective small arms range) when initially inserting law enforcement personnel who will be responsible for establishing and securing landing zones for further operations. Weapons carried on board aircraft will be secured by and be the responsibility of the law enforcement personnel to whom the weapon is issued. Firearms will not be discharged from aircraft or motor vehicles.

b. Pre Commitment Briefing.

- (1) Guardsmen will be briefed on all safety aspects before deployment nd will be issued written guidance approved by the State JAG. Such written guidance will advise them of the rules of engagement, their status (state active duty or Title 32), tort protection, medical benefits, and retirement points. The NJNG shall maintain records showing which personnel have been briefed and copies of written guidance provided.
 - (2) Supported LEA personnel will be briefed on the following:
 - (a) Role of the Guardsman.
 - (b) Use of special equipment.
 - (c) Permissible actions by Guardsmen.
 - (d) Command & Control of military troops.

13. **FUNDING/REIMBURSEMENT/ASSET SHARING:**

- a. <u>Funding</u>. Normally, the activities described in this agreement will be supported from regular counterdrug support funds and no cross-reimbursement will be required. If, however, NJNG support is rendered by personnel in other than normal training status, said support shall be funded by State active duty funds and reimbursed by Federal funds. In connection with such support, all appropriate coordination shall be made with the National Guard Bureau and necessary approvals obtained therefrom. Loss of equipment and special missions may incur obligations for additional funding, and such obligations must be authorized by TAG of New Jersey. In the event reimbursement is required by DMAVA regulations, each case shall be reviewed on an individual basis.
- b. LEA acknowledges that the United States is liable for the negligent or wrongful acts or omissions of its agents and employees while acting within the scope of their employment to the extent permitted by the Federal Tort Claims At (FTCA), 28 U.S.C. 2671-2680.
- c. <u>Tort Liability</u>. The Federal Tort Claims Act (FTCA) is applicable to Guardsmen engaged in Drug Interdiction & Law Enforcement support operations in a Title 32 status. A person whose property is lost, damaged or destroyed, or who suffers personal injury or death as a result of a negligent act or omission of a Guardsman acting within the scope of his employment may file a claim against the United States under the

FTCA. The Guard members themselves are generally immune from suit, except for intentional tortuous actions beyond the scope of their duties as authorized, and as otherwise provided for under applicable law. Guardsmen engaged in Drug Interdiction & Law Enforcement Support operations in a state active duty status are entitled to whatever protections and immunities are afforded by state law.

d. <u>Asset Sharing</u>. The NJNG may submit sharing requests to the LEA with respect to assets seized during operations in which the NJNG participated. All sharing requests will be processed in accordance with applicable LEA statutory and regulatory guidance. Final decision-making authority on all sharing requests resides in the appropriate LEA official.

14. TERMS OF THE MOU:

a. <u>Terms of this Agreement</u>: This memorandum is in effect upon the last signature and will remain in effect unless rescinded or suspended by either party on a 30-day written notice, or revised in writing by mutual consent.

ENCLOSURE 1 TO MEMORANDUM OF UNDERSTANDING

National Guard Bureau Counterdrug Missions

Mission Category #1 - Program Management

Mission 1. Counterdrug Coordination, Liaison, and Management - Plan and coordinate state counterdrug supply and demand reduction support, establish liaison with supported LEAs and other community organizations, resource and manage personnel and equipment requirements for counter drug support operations, and prepare operational/financial reports and briefings as required.

Mission Category #2 - Technical Support

- **Mission 2a. Linguist Support (Translator Support)** Transcription/Translation of audio/video tapes, seized documents and other information media. National Guard personnel will not participate in active/real-time Title III conversation monitoring or directly participate in interrogation activities. The National Guard will not maintain or store final products in National Guard facilities or databases.
- **Mission 2b. Intelligence Analyst Support**. Assist LEAs in the establishment of counterdrug intelligence systems/data bases and provide intelligence analysis support. All intelligence activities must be conducted IAW appropriate DOD Regulations. The National Guard will not maintain or store final products in National Guard facilities or databases.
- **Mission 2c. Operational/Investigative Case Support.** Provide assistance to LEAs in developing investigations and cases for prosecution. activities include, but are not limited to inputing, reviewing, and analyzing collected LEA information and providing assistance such as legal, paralegal, auditing. Operational support to LEAs is designed to enhance the effectiveness of the supported agency and "free-up" LEOs for drug enforcement duties. This category of support does not include such tasks as secretarial, janitorial, or receptionist assistance.
- **Mission 2d. Communications Support**. Provide personnel to establish, operate and maintain communications stations, bases, equipment, in support of LEA counterdrug operations.
- **Mission 2e. Engineer Support** Provide engineer support to LEAs and community organizations where the project has a counterdrug nexus. This will exclude drug laboratories or hazardous materials. Local LEA and government must secure the area prior to arrival of National Guard personnel, take possession of any evidence or materials to be confiscated/destroyed; and obtain clearances, court orders, warrants and/or permits for destruction, removal, disposal, of materials, or other environmental hazards/concerns.
- **Mission 2f. Subsurface/Diver Support** Subsurface inspections of commercial vessel hulls within U.S. territorial waters or U.S. maritime ports of entry through the use of sidescan sonar buoys or divers to detect alien devices or containers attached to the vessel hulls or other underwater activities. Prior to the use of National Guard personnel for inspection activities, the vessels must be secured by the responsible law enforcement officials. Divers may visually inspect and report to LEAs any unusual physical hull configurations but may not attempt entry, search, or alteration of features detected.

Mission Category #3 - General Support

Mission 3a. Domestic Cannabis Suppression/Eradication Operations Support -Support of LEA domestic cannabis suppression and eradication operations. This includes, but is not limited to, aerial support, logistic support, communications support, intelligence, planning support, operational staff coordination, medical, physical security, ground transportation, eradication and destruction of contraband, and spraying of herbicides.

Mission 3b. Transportation Support - Provide transportation (aerial, ground, or maritime) of LEA personnel/equipment, persons in LEA custody, seized property or contraband to, from, or as part of counterdrug operations, or when security or other special circumstances reasonably necessitate National Guard support and there is a counterdrug nexus. LEA officers are responsible for the security of any evidence or persons in their custody. Provide ground transportation of youth, adults, and associated equipment and supplies for community or state demand reduction program activities.

Mission 3c. Maintenance/Logistical Support - Provide maintenance/logistical support of LEA vehicles and equipment to enhance the counterdrug effectiveness of the supported agency and free-up LEOs for drug enforcement duties. General maintenance/logistics of non-counterdrug vehicles and equipment is prohibited.

Mission 3d. Cargo/Mail Inspection - Assist LEAs by inspecting cargo and mail. Primary emphasis will be placed on POEs and functional equivalents. Cargo/Mail includes, but is not limited to vehicles, containers, commercial cargo, aircraft, watercraft, baggage, and mail. National Guard personnel will not make arrests, conduct searches of individuals, seize property, or enter into the chain of evidence. Law enforcement officers must be present at inspection sites, make seizures, maintain custody of evidence, and maintain control of vehicle occupants.

Mission Category #4 - Counterdrug-related Training

Mission 4. Train LEA/Military Personnel. Train LEA/military personnel in military subjects and skills useful in the conduct of counterdrug operations or in the operation of military equipment used in counterdrug operations. LEA participants are responsible for associated travel and per diem expenses.

Mission Category #5 - Reconnaissance/Observation

Mission 5a. Surface - Reconnoiter or perform area observation by land or water to detect and report illegal drug activities which include, but are not limited to, cultivated marijuana, suspected isolated drug airstrips, drug drop zones, drug trafficking corridors, illegal drug labs, suspicious aircraft, watercraft, or motor vehicles. High speed "hot" pursuit or targeting specific persons for surveillance is not permitted. National guard personnel will not maintain or store gathered information files in National Guard facilities or data bases; information will be reported as designated by the supported LEA. Approved categories of counterdrug activities include, but are not limited to:

- 1. Unattended Sensor Support Personnel will support LEAs in the emplacement, monitoring, and maintenance of unattended sensors in areas where suspected drug activity is occurring.
- 2. Visual reconnaissance/observation by mobile patrols and listening posts/observations posts (LP/OP) using binoculars, cameras, night vision devices, and infrared/thermal imagery, including FLIR or low-light devices. An LEA officer must be present or in direct contact with the National Guard team.
- 3. Ground Surveillance Radar (GSR) Establish and operate ground radar sites using either Army or Air GSR systems. Mission includes site security and may require transportation support.

Mission 5b. Aerial - Reconnaissance/observation of airspace, maritime, or surface areas (land and internal waters and waterways of the US and its territories) for illegal drug activities which include, but are not limited to, cultivated marijuana, suspected isolated drug airstrips, drug drop zones, drug trafficking corridors, suspicious aircraft, watercraft, or motor vehicles. For RAID/C-26/MH-60G FLIR missions, an LEA officer must be present or in direct contact. Mission may require site security for aircraft and ground mobile radar. Approved equipment and techniques include, but are not limited to:

1. Radars.

- 2. Unmanned Aerial Vehicles (UAVs).
- 3. Aerial visual, including infrared/thermal imagery, and photographic reconnaissance.
- 4. Photo Reconnaissance/Film Processing

Mission Category #6 - <u>Demand Reduction Support</u> - Demand Reduction Support organizes National Guard resources, members, and their families in support of drug abuse prevention programs in the community. Support missions in this category should compliment, but must not duplicate other organizations' programs.

Mission 6a. Community Based. Support provided to community activities primarily designed to educate, train, or otherwise prevent drug abuse among youth. This includes, but is not limited to support of youth centers, drug-free events, community recreational programs, safe havens and community mobilization events.

Mission 6b. Educational Institutions. Support community based activities that focus on educational institutions, or otherwise have an educational institution as the primary sponsor, and are primarily designed to educate, train, or otherwise prevent youth from drug abuse. This includes, but is not limited to tutoring, mentoring, D.A.R.E. support, after-school programs, drug-free activities, role modelling programs, and sports-drug awareness programs.

Mission 6c. Informational. Participation for the sole purpose of providing information about drug abuse or drug abuse programs. This includes, but is not limited to speakers bureaus, static displays, Red Ribbon Campaign, and educational material distribution.

Mission 6d. Leadership Development. Support camps, retreats, seminars and programs, not primarily associated with educational institutions, that focus on developing drug abuse prevention leadership skills in youth and adults. this includes, but is not limited to Cadet programs, QUEST, PULSAR, Freedom Academy, Parent Training programs, and Young Leaders.

Mission 6e. Coalition Development. Assist in the development of a functioning community coalition organized to reduce the illegal use of drugs and the use of illegal drugs.
