

## Five Essentials for Alt. Financed Project

- Site approval
- Technical Champion
- Contracting Officer
- Financial Analyst
- Legal Support

#### **Baltimore Shipyard Landfill Gas ESPC**

- FY08 signed \$41M ESPC with Ameresco
- Signed \$4M contract with City of Baltimore for 15 year gas supply
- Equivalent of 4% CG electricity load (8% for R.E. reporting)
- Legal support absolute necessity!



## "Don't tell the lawyers but..."

- Often prevalent project engineer view
  - Intent to make a project happen
  - Understands other agencies have done it
  - Too much riding on project doesn't want to hear "no"
- Lawyers need to be part of the energy solution
  - Alternatively financed projects are complex
  - Applicable laws are often gray
  - Agency authorities are often different
  - Can find legal work arounds
  - Customize solutions integrating contracting, real property, and finance
  - Will review contract before award anyway
