Top Issues Hanford



1) Storing Plutonium

Nearly \$80 million per year taken away from cleanup to guard plutonium at Hanford.

2) Shipping Plutonium

DOE has prioritized important cleanup actions behind shipping plutonium meaning: If the plutonium isn't shipped on schedule, cleanup doesn't happen.

3) Waste Treatment Plant

Cost increases and schedule delays raise a multitude of programmatic questions.

Top Issues



Idaho National Laboratory Site Environmental Management Citizens Advisory Board

1) Budget for Environmental Management

- Concern for continuity
- Long-term potential for some infringement from the Nuclear Energy mission.

2) Spent Nuclear Fuel Reprocessing

- If reprocessing is not adopted, then will very soon need to look for additional repositories. However, if reprocessing is adopted then Yucca Mountain would be adequate for capacity.
- Idaho National Laboratory (INL) Cleanup program needs final waste acceptance criteria to proceed with designs for disposition of high level waste (calcine) and spent nuclear fuel.

2) Spent Nuclear Fuel Reprocessing (continued)

- The Department of Energy (DOE) should make contingency plans for interim waste disposal in case Yucca Mountain does not open in a timely manner.
- Concern about the schedule for opening Yucca Mountain.

3) Buried Waste

- Pending litigation "all means all" between the State of Idaho and the DOE.
- The DOE is planning to excavate "targeted waste" from the Subsurface Disposal Area. The CAB is concerned that some of the excavated waste may not meet the waste acceptance criteria for the Waste Isolation Pilot Plant and will require another approach to disposal.



- 3. Top Issue 3 New M&O Contractor at LANL Beginning June 1, 2006 First time the M&O Contract has gone out for competitive RFP in the history of LANL.
 - a. CAB must ensure that LANS will continue environmental restoration with EM and NNSA.
 - b. Socio-Economic impact on Northern New Mexico
 - 1. Will all employment levels, salaries and benefits stay as is?
 - 2. Will LANS maintain business partnerships in Northern NM?



FUNDING EQUITY FOR NEVADA SITE OFFICE EM PROGRAM

- 1998 In return for not pursuing a lawsuit related to the Waste Management Programmatic Environmental Impact Statement, which named Nevada as a major LLW disposal facility, DOE committed to the State of Nevada that an EM funding level of ~\$90M per year would be maintained
- FY 2006 Federal earmarks reduced the Department of Energy Nevada Site Office (DOE-NSO) EM budget to ~\$70M
- January 2006 CAB wrote letter to DOE-NSO Assistant Manager for Environmental Management and copied Nevada's elected officials expressing concerns related to budget and ultimate impacts to EM program – both locally and nationally
 - More than 30 waste generators throughout the DOE complex ship low-level waste to the NTS
 - In November 2005, the State of Nevada agreed to allow disposal of off-site generated <u>mixed low-level waste</u> at the Nevada Test Site
 - Ability to meet commitments in the Federal Facilities Agreement and Consent Order as well as provisions of the Federal Facilities Compliance Act


FUNDING EQUITY FOR NEVADA SITE OFFICE EM PROGRAM - continued

- March 2006 Governor Kenny Guinn writes letter to Secretary of Energy Bodman
 - Reiterates concerns voiced by CAB
 - States that funding cuts may have "serious implications for the productive and mutually beneficial working relationship that has been developed between the state of Nevada and the DOE-NSO over many years."
- Today DOE-NSO FY 2006 budget has been restored to ~\$80M

Bottom Line

The NTS plays an integral waste disposal role for the nation. To ensure that cleanup continues both at the NTS and at sites throughout the complex, DOE funding commitments to the State of Nevada and its stakeholders must be maintained.

Top Issues Rocky Flats



- 1) Future Public Participation
 - Process for establishing a Local Stakeholder Organization (LSO) was controlled by area local governments with very limited input by local citizens
 - Result is concern that future citizen participation will likewise be limited and will need to pass through an extra layer of government control
 - Critical community expertise and institutional memory will be lost
 - LSO will not be an advisory board under FACA

Top Issues Rocky Flats



- 2) Board is Being Shut Down Too Soon
 - Regulatory closure of Rocky Flats will not occur until the end of 2006 when the final Record of Decision is released
 - Board was not provided funds to remain open through that time and will close its operations at the end of June
 - Result is that Board has had to comment on a Proposed Plan it has not even seen
 - Board believes its expertise and oversight will be lost at a critical time in the site's closure process
 - Hence, rather than feeling celebratory for a job well done, the Board is quite dispirited as it completes its remaining work

3) Funding for Refuge Management Activities

- Transfer of portions of Rocky Flats property to the U.S. Fish and Wildlife Service will occur in 2007
- The Service has not been allocated funds in the proposed 2007 federal budget to manage Rocky Flats refuge lands
- Thus, the Service will have to limit its initial management activities and take funds from other refuge sites in order to do work at Rocky Flats
