The number at the intersection of rows and columns with the same land cover/use designation represents acres that did not change from 1982 to 1997. Reading to the right or left of this number are the acres that were converted to other uses in 1997. Reading up and down from this number are the acres that were converted from other uses in 1982.

NOTES: Total estimates may be adjusted to account for rounding. The error referred to in the table is the standard error of the estimate. You can obtain the margin of error at the 95% confidence limit by multiplying the error by 1.96.
