## **Position Description**

Position:	Inpatient Intake/After Care Therapist
Supervisor:	Executive Director
Summary:	Position requires completing alcohol/drug assessments, coordinating placements in inpatient treatment, and providing aftercare counseling, group counseling and follow-up care for clients receiving inpatient treatment.

#### Job Classification

This is a full time exempt position with benefits.

## **Typical Physical Demands**

- 1. Prolonged periods of sitting.
- 2. Stooping, bending or stretching for files and supplies.
- 3. Able to handle up to 30 lbs. of lifting.
- 4. Requires manual dexterity sufficient to operate a keyboard or other agency machinery.
- 5. Vision must be correctable to allow use of a computer monitor and hearing must be in normal range for telephone calls
- 6. Work may be stressful.
- 7. Capable of operating personal vehicle.

# **Typical Working Conditions**

- 1. Work must be performed in confidential manner.
- 2. Work may involve irregular hours.
- 3. Work may take place in office, homes of clients or other appropriate settings.

## Duties

- 1. Complete alcohol/drug assessments.
- 2. Make determination if further assessment is needed.
- 3. Determine treatment modality requirements for client.
- 4. Coordinate treatment options for client.
- 5. Case management coordination.
- 6. Chart progress of client in conjunction with treatment goals and in accordance with ADAD standards.
- 7. Attend and participate in clinical case conferences.
- 8. Maintain orderly files and complete in a timely manner.
- 9. Attend case conference meetings when needed.
- 10. Provide client services pre and post inpatient treatment.
- 11. Facilitate support groups for clients.

- 12. Work as a team member with other behavioral health staff.
- 13. Other duties as assigned.

## **Performance Requirements**

#### Transportation

- Must have personal vehicle for transporting clients when needed.
- Must have proof of Colorado Liability Insurance.
- Must have valid Colorado Driver's License.

#### Education

- Must have Bachelor's Degree in Human Services or other related field.
- Must be certified as CAC II and have ability to gain CAC III within one year.
- MA in Counseling preferred

## Experience

- Must have experience with IBM compatible computers and MS Office programs.
- Must have minimum of 1 year clinical experience in substance abuse treatment.
- Must have experience working with American Indian /Alaska Native groups.

#### Other

- If in recovery must have at least 3 years of continuous sobriety.
- Must be able to pass mandatory background check.
