#### DIRECT AND COUNTERCYCLICAL SIGN UP EXTENDED

The final date to sign up for the Direct and Countercyclical program has been extended until August 3, 2007. Contracts filed after August 3, 2007 can only be approved with a \$100 per farm late fee. Our sign up is currently around 60% complete which indicates that several of our normal participants have not signed up. If you are not signed up, and intend to participate, please call for an appointment as soon as possible. Advance payments of 22% are available after contract approval.

2007 is the last year of the Direct and Countercyclical program under the 2002 farm bill. Congress will draft a new bill covering programs for the next five to seven years this fall. For some insight into what the new bill may contain see the next article on farm bill proposals.

#### USDA 2007 FARM BILL PROPOSALS AVAILABLE

The U.S. Department of Agriculture recently printed "America's Farm Bill 2007 – 2007 Farm Bill Proposals." The 183-page document provides in-depth details of 65 proposals put forth by the Administration for consideration by Congress. The proposals cover the ten titles of the Farm Bill: commodity operations, conservation, trade, nutrition programs, credit, rural development, research and related matters, forestry, energy and miscellaneous. #### NONINSURED ASSISTANCE PROGRAM REPORTING REMINDERS

Producers with Noninsured Assistance Program coverage are reminded that notice of loss needs to be filed within fifteen days of the date of weather related disaster events, or when damage to a crop becomes evident. If you intend to destroy the crop, or will not continue to care for the crop through harvest, FSA must be contacted so that a loss adjuster can verify the damage prior to crop destruction. Failure to meet these requirements can compromise your coverage, or make claims ineligible for assistance.

There are certain basic reporting requirements for NAP policies. Acreage must be reported by the final acreage reporting date which for 2007 is **June 30<sup>th</sup>**. If you wish to build a proven yield, production from the previous year (2006) must be reported by the same final acreage reporting deadline. Failure to report by these dates can lead to a reduction in benefits.

#### ACREAGE REPORTING

We will begin taking 2007 crop year acreage reports in May. We ask that you call to schedule an **appointment** to report your acreage as soon as you finish seeding your 2007 crops. Please come to your appointment prepared to indicate which crop is in each field as well as when the crops were seeded.

Producers in the following programs are required to submit an acreage report:

<u>CRP</u> – Conservation Reserve Program <u>DCP</u> – Direct and Countercyclical Program <u>NAP</u> – Non-insured Assistance Program <u>PRICE SUPPORT</u>- Loans and Loan Deficiency Payments

If you are enrolled or plan to be enrolled in any of the programs listed above and fail to report your acreage, you will be ineligible for program payments. You can late file your report, but you will have to pay a late file fee and be subject to an automatic spot check.

Direct and Countercyclical Program participants should not confuse contract sign up with acreage reporting. There are two steps to participating in the Direct and Countercyclical Program. If you have signed a contract earlier in the year, you will still need to file an acreage report.

In many cases, routine acreage reports can be filed by telephone and mailed out for signature.

The final date to report your acreage is <u>JUNE 30th</u> Please mark this date on your calendar. It is your responsibility to file your report before the deadline.
