individuals to view legally accessible content in the privacy of their own homes. Consider the content blocking software currently in place in many schools and workplaces that block everything from pornography to high school students' blogs and, occasionally, scientific journals that use words deemed unacceptable by the filter. We can work around these things by going home to view that content. Do you imagine that Comcast intends to hand filter the content they're blocking? Probably not. Most likely it's to be done with some sort of filtration algorithm that will automatically dose off sites based on their content. What happens to your Photobucket account? What happens to your friends list on LiveJournal? What happens to non port 80 communications with MMORPGS and other internet, but non-web, applications? In places where the only internet service is provided by Comcast or other companies that are pushing for a closed internet, there will be no workarounds for people who wish to view content their provider disapproves of. It is not the place of the service provider to permit or deny content -- in the case of roads, we do have traffic cops, but they're not the same group of people who build and maintain the roads.
