1 Overview

A Background

Recent changes to the Check Writing software provided for the automated calculation and creation of PPI disbursements when issuing payments using the Check Writing function and when issuing automated LDP's. The software was also modified to automatically calculate PPI by using the payment number of the late disbursement when using program code "INTPEN" in the Check Writing software. Notice FI-2404 provided complete instructions on using the new software.

When LDP is re-entered as a corrected LDP, an automated PPI payment is not created and the County Office is required to issue the PPI payment using the Check Writing software. In some cases, the amount of PPI for these LDP's was calculated incorrectly in the Check Writing software. Modifications to the software included in County Release No. 431 will allow the payment amount, payment date, and due date of late LDP's to be changed on the Accounting Payment Data Screen ANK34010 to calculate the correct amount of PPI due.

This notice provides instructions on modifying payment data, when applicable, for re-entered corrected LDP's.

2 Issuing an "INTPEN" Disbursement for a Corrected LDP

A Introduction

County Offices must issue a PPI payment, when applicable, for re-entered corrected LDP's using the Check Writing software using program code "INTPEN". After installation of County Release No. 431, County Offices will be able to modify the payment amount, payment date, and the due date of the late LDP payment record to correctly calculate the amount of the interest penalty due.

B Issuing LDP "INTPEN" Disbursements

If necessary, County Offices shall follow this table to modify the payment amount, payment date, and due date.

Note: These procedures are only valid for interest penalty payments issued for LDP payments.

1	On Accounting - Check Writing Main Menu ANK000, select option 1, "On-line Check Writing".	Screen ANK31501 will be displayed to enter payment information.
2	On Screen ANK31501, enter the following: • "INTPEN" in the "Program Code" field • issue date of the payable • producer ID number, type, and facility code or name. PRESS "Enter" to continue.	Screen ANK34010 will be displayed.
3	On Screen ANK34010, enter the payment number of the LDP payment that was made late. PRESS "Enter" to continue.	The LDP payment data will be displayed.
