Dear Mr. Johnson:

This letter is in response to the request by the Congress and you for a report by the Department of the Interior (DOI) on its underground storage tanks (UST) as required by the Underground Storage Tank Act of 2005.

The DOI reports a total of 299 USTs as reported by its Bureaus. There are a total of 18 USTs (6.0 percent) reported as not in compliance due to recent discovery, orphaned status, or ownership by another entity. DOI Bureaus are committed to resolving these noncompliance issues. A summary table of DOI Bureau UST information is enclosed for your reference. Due to the large volume of UST data contained in the Bureau spreadsheets, a CD-ROM containing Bureau UST data is enclosed instead of hardcopy printouts.

As you will see, DOI is actively managing its USTs. Furthermore, we are firmly committed to environmental compliance as part of DOI's continuing implementation of environmental management systems by the Bureaus and Departmentwide activities and functions.

An identical letter is being sent to the Honorable James M. Inhofe, Chairman, Senate Committee on Environment and Public Works, United States Senate, the Honorable James M. Jeffords, Ranking Minority Member, Senate Committee on Environment and Public Works, United States Senate, the Honorable Joe Barton, Chairman of the Committee on Energy and Commerce, House of Representatives, and the Honorable John D.
