Vision Statement

Cedar Creek & Belle Grove NHP is a newly established partnership unit. The park will be jointly managed by the National Park Service and six non-profit and local government partners including -- Belle Grove Plantation, Cedar Creek Battlefield Foundation, the National Trust for Historic Preservation, Shenandoah County, and Shenandoah Valley Battlefields Foundation -- which is a national heritage area. Currently the National Park Service owns and manages a 7.5 acre site within the park, and approximately 1170 acres are owned and manged by its five partners, and another 29 acres are in conservation easements. The park's first General Management Plan is currently in development and a major goal of the plan is to develop a strategy for the six partners to colloboratively manage the park.

The national park will provide leadership and technical support to park, local government and community partners so that the park will be an exemplary example of resource stewardship, interpretation and visitor services. We will protect the park from incompatible growth and development. We will develop a superior set of interpretive programs that will ensure that all of the park's interpretive themes are presented, and that the programs of the individual partners complement one another. We will provide leadership and coordination so that the joint endeavors of the park and its partenrs will be consistent in quality, design and branding.
