

CLEAN AIR ACT **OPERATING PERMITS PROGRAM**

FACT SHEET

March 31, 1997

- ★ By November 15, 1993, operating permits programs were to have been submitted for all States and territories consistent with the Federal Operating Permits Program regulations
- ★ Submittals were required from 56 States, including the District of Columbia and Territories
- ★ In many cases, local programs are responsible for developing and implementing the operating permits programs for their areas of jurisdiction. For example, 34 local programs in California will implement the permit program across the State.
- ★ Steps in the approval process
 - Submittal by State or local agency
 - EPA regional offices determine whether submittal is complete enough for review
 - EPA notifies States of completeness status
 - EPA proposes to approve or disapprove in Federal Register
 - Public given opportunity to comment on submittal
 - EPA publishes final approval or disapproval of State's or locals operating permits program
 - Sources to submit permit applications to agencies
 - Permits reviewed and approved by agencies
- ★ To date: Complete submittals have been received from all State and local permitting authorities

Approvals have been published in the Federal Register for 52 State and all 60 local programs. Also, a proposal to approve 1 State program has been published in the Federal Register. Approvals of §325 actions have also been published for 3 territories.
