Cell phones with the CAP uniform

Pagers, cellular phones, and two-way radios may be worn clipped to the waistband or purse, or carried in the left hand. Only one is authorized.

Note: Your unit, group, wing or region commander may have a policy which places some restrictions on cell phones at CAP activities.

Wearing sunglasses while in CAP uniform

Conservative sunglasses may be worn with the AF style and CAP distinctive uniforms, except in military formation. Glasses must be free of ornamentation on frames and lenses. Conservative, clear, slightly tinted, or photosensitive lenses indoors or in formation. Conservative lenses and frames outdoors (faddish styles and mirrored lenses prohibited). Sunglass cases will not be worn or carried exposed on the uniform. Not worn around the neck.

Wearing jewelry while in CAP uniform

Men - Wear of earrings, or visible ornaments around the neck are prohibited while in uniform. Dog Tags may be worn while in CAP uniform provided they are not visible.

Women - One small spherical (ball), conservative, diamond, gold, white pearl, or silver pierced, or clip earring per earlobe may be worn. The earring worn in each earlobe must match. Earring should fit tightly without extending below the earlobe. (Exception: Connecting band on clip earrings.) Other visible ornaments around the neck including Dog Tags or on the head and ankle bracelets are prohibited.

Women's handbags while in CAP uniform

Women's handbags should be plain, conservative black or navy blue with or without shoulder strap. The size should not exceed 13 x 9 x 4 1/2 inches deep.
