MEMORANDUM ON PROPOSED TARIFF LEGISLATION of the 110th Congress ¹

Bill No. and sponsor: H.R. 4481 (Mr. Joe Courtney of Connecticut).

Proponent name, 3 location: Warren Corporation, Stafford Springs, CT.

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Woven fabrics containing 85 percent or more by weight of vicuna hair (provided for in subheadings 5111.11.70, 5111.19.60, 5112.11.60, or 5112.19.95).

Product information, including uses/applications and source(s) of imports:

This bill covers woven fabrics of vicuna hair, a rare and expensive fiber. The vicuna is similar to the llama and alpaca and is native to the Andean regions of Bolivia, Peru, Chile, Ecuador, and Argentina. Vicuna fibers are among the thinnest and most luxurious of any fine animal hair, with a diameter of 12 microns, compared with cashmere, which has a diameter of 15 microns.⁴ The subject fabric is imported for use in jackets and coats, and is retailed primarily to specialty tailors, as mass production of garments using this fabric is cost prohibitive. Woven fabrics containing 85 percent or more by weight of vicuna hair are provided for in HTS subheadings 5111.11.70 and 5111.19.60, which cover certain woven fabrics of carded wool or fine animal hair, and HTS subheadings 5112.11.60 and 5112.19.95, which cover certain woven fabrics of combed fine animal hair. As the vicuna are a protected species, vicuna fibers and fiber products may only be imported from countries where the vicuna population is classified as "threatened" versus "endangered," currently Argentina, Bolivia, Chile, 5 and Peru.

- 5 (a) In General.—Heading 9902.12.23 of the Har-
- 6 monized Tariff Schedule of the United States is amended
- 7 by striking "12/31/2009" and inserting "12/31/2011".
- 8 (b) Effective Date.—The amendment made by
- 9 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
