## Surgeon General's Column

Now that the summer is in full swing, there are many seasonal health issues that I would like to discuss with you. Because prevention of disease is as important as treatment, I think it prudent to remind you that there are things you can do to ensure that the summer months are safe and healthy ones for you and the people you care for and about.

Below I have compiled some statistics on *unhealthy* summer behavior that you should avoid, but before I share them with you, I want to mention a report titled "The Importance of Physical Activity for All Ages" released on June 20, 2002, by Secretary Tommy Thompson, Department of Health and Human Services. The Secretary's report not only describes the pressing need to get Americans to be more active, it also makes clear recommendations on how to go about doing it.

The Secretary's report focuses on being healthy all year long—an important message. But because summer is here, I thought the following statistics might serve as a reminder that at different times during the year we must pay special attention to our health.

Tanning, and the sunburn that precedes it, is still regarded by many to be a 'healthy glow.' Of course, now we know that prolonged exposure to the sun's harmful rays has a direct relationship to skin cancer. In fact, according to the National Cancer Institute, about a million people learn they have skin cancer each year, and it can be fatal.

According to the National Oceanic and Atmospheric Administration (NOAA), between 175-200 people die from heatrelated disorders during an average year in the United States. This statistic has risen to more than 1,500 people during years when there are long heat waves. The exact number of persons seeking treatment for heat-related disorders is not recorded but believed to be in the thousands.

Did you know that drowning is the 4<sup>th</sup> leading cause of accidental death in the United States, claiming 4,000 lives annually? Boating accidents, diving accidents, and other types of water-related injuries also account for thousands more injuries and fatalities each year. Many of them involve alcohol use in some way. Factor in the growing popularity of personal watercrafts and we shouldn't expect to see those trends reversed.

For automobile drivers, the summer holidays offer equally serious statistics. There are about a thousand or so traffic fatalities each Memorial Day, Independence Day, and Labor Day combined, and about half are alcohol related.

Even when summer get-togethers are alcohol-free, there are things to watch out for. This time of year is traditionally the height of barbecue and picnic season. Many summertime favorites, like ice cream, fresh fruit, and salads can sometimes cause food poisoning. These foods caused at least 130 confirmed food-poisoning outbreaks between 1990 and 2001, according to a report by the Center for Science in the Public Interest (CSPI). CSPI's advice for summer chefs is to "keep it cold, keep it clean, and cook it well-done."

Summer is also a time when disease can be transmitted by insects. Two of

these diseases that you may have heard a lot about lately are the West Nile Virus and Lyme disease. West Nile Virus has been documented in 27 States (and the District of Columbia) in the northeast, south, and mid-west. It may be spread by mosquitoes that pass it through birds to humans by biting. The West Nile Virus causes flu-like symptoms; the most serious manifestation is fatal encephalitis, but it is rarely found in humans. However, when transmitted, it can be fatal, especially to the elderly and very young.

Also, Lyme disease, named in 1977 when arthritis was observed in a cluster of children in and around Lyme, Connecticut, is a serious disease that tends to be associated with summer activity. Lyme disease is caused by a bacterium that is transmitted to humans by the bite of infected deer ticks. In 1999, a total of 16,273 cases of Lyme disease were reported to the Centers for Disease Control and Prevention by 50 States and the District of Columbia. Lyme disease is rarely, if ever, fatal. If left untreated, patients may develop arthritis, including

intermittent episodes of swelling and pain in the large joints, neurologic abnormalities, and, rarely, cardiac problems.

Finally, there are many warm weather activities to be enjoyed including cycling, miniature golf, gardening, and just plain walking. If you participate in them, take basic precautions to ensure your safety. Enjoy yourselves, enjoy the weather, enjoy your health.

Most of the health issues I mentioned are summer-specific, but all are serious. Obviously, we should take Secretary Thompson's advice and work toward healthy behavior all year long. With that in mind, I encourage those of you who have yet to participate in the Healthy Lifestyles Program's Web-based nutrition and physical activity survey to do so today. The survey is a follow-up to the one that was mailed to commissioned corps officers in early 2000, which encouraged officers to identify and implement a healthy lifestyle for themselves. It takes less than 10 minutes to complete, and the result will help to develop a baseline program that meets your healthy lifestyle needs as commissioned corps officers. Your input counts! (Note: Please see the article titled "Healthy Lifestyles" on page 9 of this issue of the Commissioned Corps Bulletin.)

#### Medical Reserve Corps Update

In my May column I told you about developments for the Citizen Volunteer Medical Reserve Corps (MRC). I'd like to take this opportunity to give you a few updates that I hope you'll find interesting.

To date, a lot of 'behind the scenes' work has been done on the MRC. As of June 1, more than 8,000 people had registered with the USA Freedom Corps, via its Web site, to be volunteers for MRC in their local communities. Along those same lines, the Office of the Surgeon General has developed a comprehensive "Guide for Local Officials" for communities wishing to begin their own MRC. The Guide is nearing completion and should be available either this month or next.

A Web site and a monthly newsletter are in development. The URL for the new Web site has not been determined as of

this writing, but I will be sure to share it with you in an upcoming column. The newsletter will be available on the Web site. Also, the Office of the Surgeon General is putting together a grant program that will provide funds to qualified Citizen Corps Councils.

The MRC is a very exciting new initiative, and I anticipate the number of local sites and enrollment to increase exponentially over the next 6 months.

## **Medical Affairs Branch**

#### BMP Corner

The Beneficiary Medical Program (BMP) Section of the Medical Affairs Branch, Division of Commissioned Personnel, authorizes annual eve exams, including contact lens fittings, with an optometrist for those officers who are stationed outside the catchment area of a Military Treatment Facility (MTF). Eyeglass lens, frames, contact lens (hardware), and LASIK eye surgery are not covered benefits outside an MTF and are the responsibility of the officer. The officer may obtain corrective eye hardware through MTFs which have eyeglass programs.

When an officer is injured on the job and is treated at a healthcare facility other than an MTF, the payment of medical bills is still the responsibility of BMP. The officer is responsible for contacting BMP within 72 hours of the incident to report any emergency care for sickness or injury. Public Health Service Commissioned Corps officers are not covered by Federal or State worker compensation programs, but completion of incident reports or information for statistical purposes may be required from the officer.

# Field Medical Readiness Badge (FMRB)

All Web-based training modules have now been completed and are posted on the Web. If you wish to receive the FMRB, please submit the items listed below, to:

- A photocopy of the front and back of your AHA BLS Healthcare Provider card.
- (2) A copy of a statement, signed by the individual supervising your work, that you have completed a minimum of 112 hours of work in your deployment role. The statement must include the following: your name; facility where you performed the work; a one sentence description of the services provided; the number of work hours performed in the last 12 months; the name, title, and contact

- information of the supervisor; and the supervisor's signature.
- (3) A copy of form PHS-731 (yellow Immunization Card) showing compliance with all required vaccinations.
- (4) A statement, signed by your healthcare provider, certifying your height and weight within the last 12 months. The statement must include the following: your full name; the date; your weight in pounds, height in inches, and age; and the name, address, contact information, and signature of the provider.
- (5) A statement, signed by another active-duty PHS officer, that you have successfully completed the Annual Physical Fitness Test (APFT). The statement must contain your name and age; the date of the APFT; number of pushups completed in 2 minutes; number of sit ups completed in 2 minutes (or your time on the Sidebridge); time on the 1½ mile run (or the 500 yard swim); and the name, rank, PHS serial number, and contact information of the officer certifying your results.

CCRF personnel will verify the following: current license on file with the Division of Commissioned Personnel (DCP); physical exam on file with the Medical Affairs Branch, DCP, dated within the last 5 years; validation of login to the CCRF Web site; and currency of your information

CCRF personnel will review officer qualifications for the FMRB on a quarterly basis beginning in June 2002. DCP will consider officers who fulfill the requirements for the FMRB. Those who do not fulfill the requirements will be notified and given further guidance.

## **Keeping You Informed**

Although the Division of Commissioned Personnel (DCP) and the Agencies/Operating Divisions/Programs to which Public Health Service Commissioned Corps officers are assigned attempt to process orders as quickly and efficiently as possible, some glitches still occur. The many levels of communication that take place to move an officer during a Permanent Change of Station (PCS) or initial Call to Active Duty (CAD) can be overwhelming for everyone, especially the officer. Many times, orders for a transfer are not received until the last minute. This can be very STRESSFUL during an already nerve-wracking period. Trying to coordinate all aspects of the move-including you, the family, the household goods (HHG), the current job, and all the other details—is almost impossible.

Temporary Lodging Expense is an entitlement that can help in this stressful period. Up to 10 days of Temporary Lodging Expense (TLE) is authorized to *partially* pay for the lodging/meal

expenses when it is necessary to occupy temporary quarters during a move. This means, if you received your orders at the last minute and have trouble finding housing at your new duty station, you have up to 10 days of assistance to locate a place to live. This entitlement can also be used before you leave your old duty station, but remember a maximum of 10 days may be used.

#### $Increased\ Entitlement$

As of May 2002 with Change 185 of the Joint Federal Travel Regulations (JFTR)—and effective from January 1, 2002—TLE is authorized for all member moves including initial CAD, and the maximum daily allowance has increased from \$110 to \$180 per day. (Note: This is a change from the article on TLE which appeared in the June 2002 issue of the Commissioned Corps Bulletin.)

This increased entitlement is **not** a flat rate of \$180; so don't demand " $10 \times $180$ " from your new duty station. There is a computation that adjusts for your Basic Allowance for Housing (BAH) and Basic Allowance for Subsistence (BAS) and is determined by the local per diem rate where the losing or gaining duty stations

are located. A TLE computation sheet is available on the DCP Web site—http://dcp.psc.gov—to assist you. (*Note:* This site has not been updated to reflect the new changes as of the printing of this issue of the *Commissioned Corps Bulletin.*) Check with your Human Resource department for assistance, or visit the JFTR Web site at www.dtic.mil/perdiem/.

Oops!!! A correction to the Travel Tips article that appeared in the June issue of the Commissioned Corps Bulletin! Dislocation Allowance (DLA) is not only applicable to members with dependents who move with the member during the initial CAD. DLA is an entitlement for all active-duty members during a PCS and new members going through their initial CAD with dependents who move their household in accordance with the JFTR.



- I have seen Public Health Service Commissioned Corps officers wearing their pants at many different lengths. What is the correct length for wear on women's slacks and men's trousers?
- The correct wear for the women's slacks and the men's trousers is to button all buttons, close all fasteners, and wear a belt through all loops. Trousers should cover the top of the shoe by 1 inch at the heel. In addition, for women, the skirt length may range from 1.5 inches above to 1.5 inches below the crease behind the knee. Wear the zipper centered in the back and a belt through all loops. Any wear of these items that varies from the above is considered unauthorized and out of uniform.
- Many officers complain about the uncomfortable shoes they have to wear with their uniforms. I have even seen officers wearing crosstrainers and tennis shoes with the uniform. What is the authorized footwear with the uniform?
- The bottom line is we are a uniformed service. Whether the shoes are uncomfortable or not, there are regulations that dictate what is correct and not correct. Officers have a variety of shoes that are available to wear. These shoes are described in Commissioned Corps Personnel Manual Pamphlet No.61, "Information on Uniforms," available online on the Division of Commissioned Personnel (DCP) Web site—http:// dcp.psc.gov—click on 'Publications.' The only authorized reason for not wearing the appropriate footwear is if an officer has a medical reason. In this case, a medical profile describing the reason, the time limit, and other criteria should be maintained in the medical file in DCP and carried at all times while in uniform.
- I have seen officers not wearing undershirts. What are the proper undergarments for the uniform?

- For men, the undergarments to be worn are (1) Undershirt, white: Made of white cotton or polyester/cotton. May be sleeveless and have a V-neck or crew neck. (2) Undershorts: Shall be boxer or brief style, and white when wearing white uniforms.
  - For women, the undergarments to be worn are (1) Brassiere: White when worn under white shirts. Otherwise, color is wearer's option. (2) Underpants: White when worn under white skirt/slacks. Otherwise, color is wearer's option. (3) Slip: May be full or half slip. Shall be white when wearing white uniform components.
- Q: What is the correct wear for hair?
- A: Men:

Hair shall be neat and clean and present a groomed appearance. Hair above the ears and around the neck shall be tapered from the lower hairline upwards and outwards so as to blend smoothly with the hair style. Hair on the back of the neck may not touch the collar. Individual hair shall be no longer than 4 inches; however, hair which lies close to the head may be longer than 4 inches, if necessary, in order to cover thin or bald areas. Hair shall be groomed so that it does not touch the ears or the collar, nor extend below the eyebrows when headgear is removed. The bulk of the hair shall not exceed 2 inches.

#### Women:

The hair shall be neatly arranged and shaped to present a conservative appearance. Hair on the back of the neck may touch but may not fall below the collar. No hair shall show under the front brim of the hat. Afro, natural, bouffant, and similar hair styles are permitted; but exaggerated styles and styles with excessive fullness or extreme height are not authorized. Pony tails and plaited hair are not permitted while in uniform. Hair may be braided provided that the braids are held close to the head and do not interfere with the correct fit of the headgear. Hair coloring must have a natural appearance, be of a color which would occur normally, and be applied in a fashion so as to complement the individual.

Q. Do I have to wear my ribbons on my uniform?

Yes. Ribbons and medals are a required part of all the uniforms except the working khaki uniform, indoor duty uniform, and with the service dress blue sweater. The arrangement of ribbons shall be in the order of precedence in rows from top down, inboard to outboard with rows. A minimum of three ribbons shall be worn by those possessing three or more; all ribbons may be worn, if desired. If only one row of ribbons is worn, it shall consist of the three senior ribbons. Membership ribbons (Commissioned Officers Association, Reserve Officers Association, Association of Military Surgeons of the U.S.) may not be worn without at least one service ribbon on the uniform.

- Q. I have noticed that uniforms come in different materials. Can I mix and match the materials used with my uniform?
- A. No. When you wear the uniform, you want to present yourself in a professional manner. The uniform needs to be neat and clean and appear as if the components of the uniform belong together. Different materials, i.e., cotton, Certified Navy Twill (CNT), and polywool blends do not look alike. Make sure, when you buy your uniforms, that the materials match.
- Q. Are the brown shoes authorized with the khaki uniform?
- Yes. Brown shoes are now authorized to wear with the khaki uniform. When brown shoes are worn, brown socks are required. In addition for women, if you choose to wear brown shoes with your khaki uniform and choose to carry a handbag, the handbag must be of a matching brown color.

## **Hispanic Officers Advisory** Committee—Call for Nominations for the Juan Carlos Finlay Award

The Juan Carlos Finlay Award was established by the Hispanic Officers Advisory Committee (HOAC) to honor individuals, organizations, and groups who through work performance and other activities have demonstrated leadership in the development of programs, methods, or initiatives that improve health services for Hispanics. This award was named after Juan Carlos Finlay (1833-1915), a Cuban physician and epidemiologist who discovered that the mosquito was the vector of "fiebre amarilla" or yellow fever.

Nominations for the Juan Carlos Finlay Award should describe the specific accomplishments of the candidate (individual or organization) in one or more of the following areas:

- (1) leadership in their area of expertise as it pertains to Hispanic healthcare
- (2) accomplishments in Hispanic healthcare development, management, and/or improvement; and/or
- (3) organization and/or implementation of activities/programs that significantly improve Hispanic access to healthcare and healthcare services.

Nominations may be submitted by the Department's Operating Divisions (OPDIVs) and regional offices, private nonprofit groups, and others with special knowledge of Hispanic health issues and programs. Each nomination must be signed by the individual making the nomination, and in the case of an OPDIV or organization, the head of the OPDIV or organization should sign, and only one nominee should be submitted by each. ## **Reminders Regarding** Annual Leave

The summer vacation season is underway and officers are reminded and encouraged to schedule their annual leave through the year so as to preclude any disappointment or misunderstanding resulting from the loss of accrued leave at the end of the year.

Commissioned Corps Bulletin

The maximum annual leave that may be carried forward from one leave year to the next is 60 days. The leave year is a calendar year; the period beginning January 1 and ending December 31. The 60-day limitation on the amount of unused annual leave that can be carried forward from one year to the next is imposed by statute. Therefore, no waiver is legally permissible. In other words, no one can grant an exception.

Important Note: Those officers who were authorized to accumulate up to 90 annual leave days as of December 31, 2001 under the leave accrual provisions of 10 U.S.C 70, should review Manual Circular No. 368, "Annual Leave-Implementation of Special Leave Accrual Policy and Amendment," dated December 12, 2001, which appeared on page 7 of the the January 2002 issue of the Commissioned Corps Bulletin.

Officers are also reminded that they are required to keep their leave-granting authority and leave maintenance clerk informed of their whereabouts during any period of leave. In addition to providing this information on form PHS-1345, "Request and Authority for Leave of Absence (Commissioned Officers)," supervisors must be furnished with the address and phone number where you can be reached while you are on leave.

## Officers Promoted to the Rank of Assistant Surgeon General

RADM John Babb has been promoted to the rank of Assistant Surgeon General (Rear Admiral lower half) effective May 1, 2002.

RADM Babb, a pharmacist officer, is the Director of the Commissioned Corps Readiness Force (CCRF) within the Office of Emergency Preparedness. The CCRF is responsible for the deployment of commissioned officers to disasters, terrorist attacks, public health emergencies, and special security events, both within the United States and internationally.
