I am writing this letter in support of a bill that would temporarily suspend the tariff on a raw material (certain "acrylic fiber tows") used by one of our local industries in Roane County, TN – Toho Tenax America. I am supporting this bill only because Congressman Lincoln Davis of Tennessee did not introduce one that would permanently remove the tariff on this certain "acrylic fiber tow". I support the bill even though I have not a clue as to what "acrylic fiber tow" actually is.

#### What I do know is that Toho

- produces carbon fiber at their plant in Rockwood, TN,
- has the reputation of being a good employer, as well as a good corporate citizen,
- contributes significantly to our state and local economy,
- has invested more than \$37 million in their plant in the last three years,
- requires this certain "acrylic fiber tow" as a raw material,
- and, is at a market disadvantage because they chose to manufacture their product in the USA.

The raw material in question is no longer produced in this country – if it ever was. There is no need for a protective tariff because there are no U.S. companies to protect and, since Toho's competitors in Europe and Japan do not pay import duties on this very same material, the existing tariff puts U.S. companies (such as Toho) in a distinct competitive disadvantage.

In 2002 a bill, H.R. 4135, was sponsored by a Wyoming Congresswoman with the same quest as Congressman Davis – suspend the tariff on certain "acrylic fiber tows" and protect U.S. jobs. At stake was a small U.S. company based in Wyoming that faced

unfair foreign competition for the same reason as Toho does now. The tariff in question that is the root cause of this unfair foreign competition should be permanently removed.

Since a permanent solution is not offered, I am very much in support of the bill that would at least temporarily suspend this tariff. I would appreciate the passage of this bill.
