Proposed Action Title/Type: Change in the Season of Grazing Use – Barnard Ridge, Ervin Ridge, Greasewood Bottom & Williamson Bottom Grazing Allotments

Location of Proposed Action: The Barnard Ridge, Ervin Ridge, Greasewood Bottom and Williamson Bottom Grazing Allotments are located on the north side of the Missouri River, approximately 11 miles down stream from the Stafford Ferry crossing. All or portions of the grazing allotments lie within the Upper Missouri River Breaks National Monument, Ervin Ridge Wilderness Study Area (WSA) and Upper Missouri National Wild and Scenic River corridor (maps attached). The affected area involves 14,170 acres of public land.

Description of Proposed Action: The grazing permittee has submitted an application to change the season of use in the Barnard Ridge, Ervin Ridge, Greasewood Bottom and Williamson Bottom grazing allotments. The applicant has requested turning out cattle 14 days later in the Barnard Ridge and Ervin Ridge allotments (upland areas) and 14 days later in the Greasewood Bottom and Williamson Bottom Grazing Allotments (river). The current authorization for the area is as follows:

PLAN CONFORMANCE REVIEW

The proposed action is in conformance with the West Hiline Resource Management Plan (RMP) 1988, Missouri River Breaks Grazing EIS (1979), State Director's Interim Guidance for Managing the Upper Missouri River Breaks National Monument (2001) and Proclamation 7398 (2001) establishing the Upper Missouri River Breaks National Monument.

Under the Proclamation, the "laws, regulations, and policies followed by the Bureau of Land Management in issuing and administering grazing permits or leases on all lands under its jurisdiction shall continue to apply with regard to the land in the monument."

Rules governing grazing use on public lands administered by the Bureau of Land Management can be found in the Code of Federal Regulations, Title 43, Subpart 4100.

CATEGORICAL EXCLUSION REVIEW

Compliance with the National Environmental Policy Act

Categorical Exclusions are defined as a group of actions that would have no significant individual or cumulative effect on the quality of the human environment and, for which the absence of extraordinary circumstances, neither an environmental assessment nor an environmental impact statement is required.

Changing the season of grazing use in the Barnard Ridge, Ervin Ridge, Greasewood Bottom and Williamson Bottom Grazing Allotments is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with the Department of Interior, Departmental Manual 516, Chapter 11 (Managing the NEPA Process - BLM), Appendix 1, Section 11.9 [Actions Eligible for a Categorical Exclusion (CX)], (D) Rangeland Management, (11) Issuance of Livestock Grazing Permits for these reasons:

- 1. The same kind of livestock (cattle) will be grazed.
- 2. The active grazing use (AUMs) previously authorized has not changed.
- 3. The grazing use does not occur more than 14 days earlier or later than as specified on the previous permit.
- 4. The grazing allotments have been assessed and evaluated and the Responsible Official has documented in a determination that the allotments are meeting land health standards.

Further, BLM Instruction Memorandum No. 2008-019, Guidance on the Use of a New Categorical Exclusion for Grazing Permits/Leases, states the use of a categorical exclusion would be appropriate for issuing a grazing permit within a National Landscape Conservation System unit, including a wilderness study area (WSA), if the proposed action is compatible with the area's management goals and objectives.

The requested change in the season of use will create positive benefits to both recreation and upland and riparian vegetation. Deferring grazing use in upland areas for an additional two weeks, until mid June on one allotment and late June on another, would shorten the duration of grazing use and delay grazing later into the growing season. Forage plants would have a longer period of time to develop, reaching a stage of growth where grazing is less stressful and plants recover more quickly. Grazing river riparian areas would also be delayed an additional two weeks, until mid September, further reducing or completely eliminating livestock and recreation conflicts during the peak of the floater season. Depending on the riparian bottom. grazing by livestock during the fall months would only last 10 to 24 days. These riparian areas are dominated by short and medium sedges and rushes. Woody species are a very minor component.

The changes in grazing use requested by the applicant have been determined to conform to the policy and standards in the Departmental Manual as an action eligible for a categorical exclusion. The proposed change involves the same kind of livestock (cattle), the same grazing preference (AUMs) and the change in the season of use does not exceed 14 days, either earlier or later than the current grazing permit. Rangeland evaluations prepared in 2000 for all the affected grazing allotments determined that the Standards of Rangeland Health were being met.

Extraordinary Circumstances

Does the proposed action:

In addition, the proposed action has been reviewed to determine if any of the exceptions described in 516 DM 2, Appendix 2, apply. Any action that is categorically excluded must be subjected to sufficient environmental review to determine whether it meets any of the extraordinary circumstances, in which case, further analysis and environmental documents must be prepared for the action (CEQ Regulations, 40 CFR, 1508.4). BLM has determined that this action does not significantly affect any of the extraordinary circumstances and that no further analysis is necessary. All of the questions below must be answered negatively before the Categorical Exclusion can be approved.
