Report Highlights:

In 2002, French manufactured tobacco sales continued to increase and reached USD 13.76 billion compared to USD 12.46 billion in 2001. Much of this increase came from government taxes, valued at USD 10.30 billion in 2002 from 9.30 billion in 2001. Taxes are higher because of government efforts to discourage consumption. In addition, cigarettes accounted for much of the total with USD 12.72 billion in sales. The number of cigarettes purchased declined to 80.5 million pieces in 20002 from 83.5 million pieces in 2001. Nevertheless, France remained a net importer of both unmanufactured tobacco and cigarettes in 2002. The U.S. was France's fourth leading supplier of unmanufactured tobacco, after Brazil, Greece and Turkey. The Netherlands continues to be France's leading supplier of cigarettes.

Executive Summary

In 2002, French manufactured tobacco sales continued to increase and reached USD 13.76 billion compared to USD 12.46 billion in 2001. Much of this increase came from government taxes, valued at USD 10.30 billion in 2002 from 9.30 billion in 2001. Taxes are higher because of government efforts to discourage consumption. In addition, cigarettes accounted for much of the total with USD 12.72 billion in sales. The number of cigarettes purchased declined to 80.5 million pieces in 20002 from 83.5 million pieces in 2001. Nevertheless, France remained a net importer of both unmanufactured tobacco and cigarettes in 2002. The U.S. was France's fourth leading supplier of unmanufactured tobacco, after Brazil, Greece and Turkey. The Netherlands continues to be France's leading supplier of cigarettes.





Section I: Situation and Outlook

Altadis consumption of raw tobacco

The two graphs below illustrate the evolution of Altadis' purchases of domestically produced tobacco compared to the total French production of tobacco. They show that French tobacco production of dark tobacco has declined to the benefit of blond tobacco since 1996-97, in response to the increased consumer demand for blond cigarettes and reduced demand for dark cigarettes. In addition, Altadis continues to purchase the majority of domestically-grown dark tobacco, and a minority of domestically-grown blond tobacco.





Consumption of manufactured tobacco products


The value of French tobacco sales have increased significantly in recent years, as illustrated in the graph below. Higher retail prices have offset a decline in the quantity of tobacco sold in France. The value of manufactured tobacco product sales continued to increase in 2002: they were up 4% from 2001 to USD 13.76 billion. The bulk of which are cigarette sales (USD 12.72 billion).

In 2002, the French Government's revenue generated from taxes on tobacco amounted to USD 10.30 billion, which is about 5% higher than in 2001. The GOF is the leading beneficiary of tobacco sales in France, as more than 75 percent of the retail price of tobacco products is made up of taxes. The revenue from a pack (20) of "Gauloises" produced by Altadis selling for Euro 3.50 (USD 3.31) in January 2003 breaks down like this: 77.6 percent for taxes, 14.4 percent to the manufacturer, and 8 percent to the retailer.




The graph below illustrates the decline in French cigarette consumption since 1991. The decline is attributed to health concerns and increasing retail prices. In 2002, there were 80.5 billion cigarettes consumed in France, down from 83.5 million pieces in 2001. Health concerns and increased retail prices continue to negatively affect cigarette consumption in France.

For 2002, the distribution


of cigarette market share is illustrated in the graph below. It clearly shows that Philip Morris and Altadis are the leaders, with 38.9 and 29.3 percent of the market, respectively. In 2002, Philip Morris market share was up 0.2 percent, while Altadis' market share was down 0.3 percent from 2001.



In 2002, the substitution of dark for blond cigarettes continued. Dark cigarettes represented 14.2% of the market, while blond cigarettes accounted for 85.8%.

In contrast, the market for full flavor cigarettes, which was declining to the benefit of light cigarettes until 1999, has grown slightly since then. In 2002, light cigarettes represented 33.8% of the French market, as indicated in the following graph.

Trade

France is a net importer of unmanufactured tobacco. Brazil, Greece and Turkey were France's leading suppliers of raw tobacco in 2002, and the United States ranked fourth. The following table shows the distribution of French imports and exports of raw tobacco to and from the United States in 2001 and 2002 (in MT):
