# H.Res. 838— Welcoming His Holiness Pope Benedict XVI on his first apostolic visit to the United States (McCotter, R-MI)

<u>Order of Business</u>: H.Res. 838 is scheduled to be considered on Wednesday, April 9, 2008, under a motion to suspend the rules and pass the resolution.

<u>Summary</u>: H.Res. 838 would express the sense that the House of Representatives welcomes His Holiness Pope Benedict XVI on his first apostolic visit to the United States.

The resolution lists a number of findings, including:

- ➤ "Joseph Alois Ratzinger ascended to the Papacy and chose the name Benedict XVI on April 19, 2005, becoming the 265th reigning Pope in the history of the Roman Catholic Church;
- "he was born and baptized on April 16, 1927, in Marktl am Inn, Germany;
- ighthereof in the first interest is the first interest in the priestly vocation was evident from a young age to family and friends;
- ➤ "he was required to leave seminary at the age of 16 and forced into compulsory military service for Nazi Germany;
- ➤ "he risked grave danger by defecting from the Nazi anti-aircraft corps in 1945 and subsequently spent time in an Allied prisoner of war camp;
- "he was ordained to the priesthood on June 29, 1951;
- ➤ "he is a highly regarded theologian and scholar, having served in various university posts from 1959 until 1977;
- ➤ "he participated as a theological advisor to the monumental Second Vatican Council from 1962 until 1965;
- ➤ "he was appointed Archbishop of Munich and Freising in Germany on March 24, 1977, and ordained a bishop on May 28, 1977;
- "he was elevated to cardinal on June 27, 1977;
- ➤ "he was appointed Prefect of the Congregation for the Doctrine of the Faith and President of the Pontifical Biblical Commission on November 25, 1981;
- "he was elected Dean of the College of Cardinals on November 27, 2002;
- > "Joseph Cardinal Ratzinger was installed as Bishop of Rome on April 24, 2005;
- ➤ "Pope Benedict XVI has made repeated calls for peaceful resolutions to international conflicts, especially with respect to North Korea's nuclear ambitions;
- ➤ "Pope Benedict XVI has made reconciliation and peace an important goal of his Papacy on an ecumenical level reaching out to both Orthodox and Protestant Churches and in an interreligious manner with Judaism and Islam;
- ➤ "Pope Benedict XVI has affirmed the dignity of the human person with respect to refugees, exiles, evacuees, and other migrant persons;
- ➤ "Pope Benedict XVI has written 25 books and given thousands of hours of lectures, making him one of the most prolific theologians in modern times;
- ➤ "Pope Benedict XVI has decried the imminent dangers terrorism and extremism pose to Western Civilization; and
- ➤ "Pope Benedict XVI has identified the failed revolutions and violent ideologies of the 20th century as being the result of the 'Dictatorship of Relativism' stating that 'absolutizing what is not absolute but relative is called totalitarianism'."

Committee Action: H.Res. 838 was introduced on December 4, 2007, and referred to the

Committee on Foreign Affairs, which took no official action.

H.Res. 865— Expressing the sense of the House of Representatives that the March 2007 report of the United Nations Office on Drugs and Crime and the International Bank for Reconstruction and Development makes an important contribution to the understanding of the high levels of crime and violence in the Caribbean, and that the United States should work with Caribbean countries to address crime and violence in the region (Clarke, D-NY)

<u>Order of Business</u>: H.Res. 865 is scheduled to be considered on Wednesday, April 9, 2008, under a motion to suspend the rules and pass the resolution.

**Summary**: H.Res. 865 would express the sense that the House:

- "welcomes the recommendations contained in the March 2007 UNODC and World Bank report, 'Crime, Violence, and Development: Trends, Costs, and Policy Options in the Caribbean';
- ➤ "urges the United States Government to consider fully and carefully the recommendations in the UNODC and World Bank Report and to take the recommendations into account when developing United States policy toward the region;
- > "urges the governments of United States and other drug-consuming countries to increase counter-narcotics assistance to the Caribbean region;
- "urges the United States Government to increase coordination on policy development and implementation with Caribbean governments to help combat crime and violence in the region;
- "urges the Department of State and the Department of Homeland Security to work with Caribbean governments to mitigate the negative effects of United States deportation policy; and
- ➤ "urges governments of Caribbean countries to consider fully and carefully the recommendations in the UNODC and World Bank Report, and to take the recommendations into account, especially regarding improvements in their criminal justice systems."

The resolution lists a number of findings, including:

- "in his 2006 New Year's address, then Prime Minister of Jamaica, P.J. Patterson, said, 'Without a doubt, the high level of violent crime remains our most troubling and pressing problem.';
- ➤ "in opening the Parliament of Trinidad and Tobago in September 2005, President George Maxwell Richards said his country was in crisis due to the escalating crime rate;
- ➤ "in March 2007, the United Nations Office on Drugs and Crime (UNODC) and the International Bank for Reconstruction and Development (World Bank) issued a report entitled, 'Crime, Violence, and Development: Trends, Costs, and Policy Options in the Caribbean':
- ➤ "the UNODC and World Bank report presents detailed analyses of crime and violence in the Caribbean region and offers possible policy responses;
- ➤ "the UNODC and World Bank report draws on input from governments, civil society organizations, and Caribbean experts;
- "the UNODC and World Bank offer the following facts about crime in the Caribbean:
  - "the Caribbean region has the highest murder and assault rates in the world, with murder rates at 4 times the level of the United States; and
  - "Trinidad and Tobago doubled its kidnapping rate between 1999 and 2005;
- ➤ "the UNODC and World Bank report that high crime levels have long term developmental effects on the Caribbean:
  - "crime cost the Jamaican economy \$12,400,000,000 in Jamaican dollars, 3.7 percent of its gross domestic product, in 2001; and
  - "reducing the region-wide homicide rate by 1/3 could over double the rate of economic growth per capita; and
- > "the UNODC and World Bank report reached the following conclusions:
  - "Caribbean countries are transit points and not producers of cocaine. Interdiction needs to be complemented by other strategies outside the region: principally demand reduction in consumer countries and eradication and/or alternative development in producer countries;
  - "expansion of gun ownership and illegal gun trafficking is a dangerous outgrowth of the drug trade. Although reducing gun ownership is difficult, better gun registries, marking, and tracking can help, as can improved gun interdiction in ports. Policies should also focus on limiting the availability of firearms and on providing meaningful alternatives to youth;
  - "deaths and injuries from youth violence constitute a major threat to public health and social and economic progress across the Caribbean. Youth are disproportionately represented in the ranks of both victims and perpetrators of crime and violence;
  - "although the average deportee from the United States to the Caribbean is not involved in criminal activity, a minority of deportees may be causing serious problems, both by direct involvement in crime and by providing a perverse role model for youth. The report recommends that more services be offered to reintegrate deportees, with deporting countries contributing to the cost of these programs;
  - "in general, there is an over-reliance on the criminal justice system to reduce crime in the region, but some types of crime, such as organized crime, and drug and firearms trafficking, are generally impervious to prevention initiatives; their control requires an efficient criminal justice system. Urgent priorities for improving the criminal justice system in the region include: the development of management information systems, tracking of justice system performance, monitoring of reform programs, and increased accountability to citizens;

- "several Caribbean countries are increasingly investing in crime prevention—using approaches such as integrated citizen security programs, crime prevention through environmental design, and a public health approach that focuses on risk factors for violent behaviors;
- "youth violence is a particularly serious problem in the region, and youth homicide rates in several countries of the region are significantly above the world average. To address issues of youth violence, Caribbean policymakers should invest in programs that have been shown to be successful in careful evaluations such as: (i) early childhood development and mentoring programs; (ii) interventions to keep high risk youth in secondary schools; and (iii) opening schools after hours and on weekends to offer additional activities and training; and
- "many of the issues facing the Caribbean transcend national boundaries and require a coordinated regional and international response. Demand for drugs emanates from Europe and the United States; deportees are sent back to the region from the United States, the United Kingdom, and Canada; and many weapons that are trafficked are brought from the United States."

<u>Committee Action</u>: H.Res. 865 was introduced on December 11, 2007, and referred to the Committee on Foreign Affairs, which took no official action.

<u>Conservative Concern</u>: Some conservatives may be concerned that the findings include "... reducing gun ownership is difficult, better gun registries, marking, and tracking can help, as can improved gun interdiction in ports. Policies should also focus on limiting the availability of firearms and on providing meaningful alternatives to youth."

<u>Cost to Taxpayers</u>: The resolution does not authorize expenditures.

# H.R. 5489— To designate the facility of the United States Postal Service located at 6892 Main Street in Gloucester, Virginia, as the "Congresswoman Jo Ann S. Davis Post Office" (Wittman, R-VA)

<u>Order of Business</u>: H.R. 5489 is scheduled to be considered on Wednesday, April 9, 2008, under a motion to suspend the rules and pass the resolution.

<u>Summary</u>: H.R. 5489 would designate the facility of the United States Postal Service located at 6892 Main Street in Gloucester, Virginia, as the "Congresswoman Jo Ann S. Davis Post Office."

**Additional Background**: According to the sponsor's office:

Jo Ann Davis made history when she was elected to the U.S. Congress in 2000, becoming the first female Republican elected to the U.S. House of Representatives from the Commonwealth of Virginia. In Congress, she was a passionate advocate for better government, lower taxes, and a strong defense.

As a tireless advocate for our brave service members, Jo Ann supported legislation that strengthened our armed services and improved benefits for our men and women in uniform. Her first piece of legislation increased life insurance benefits for the families of service members who have given the ultimate sacrifice in service to our nation.

As the Co-Chair and founding member of the Shipbuilding Caucus, Jo Ann worked tirelessly to ensure that the Congress adequately provide for our Navy. She worked to secure funding for the Navy's next-generation aircraft carrier.

Jo Ann fought a two-year battle with cancer and we were all deeply saddened by her loss. While her common-sense values will be missed on Capitol Hill, it is fitting to honor her legacy. Because of her diligent and devoted service to her country, she truly deserves the honor of having a post office in her hometown, Gloucester, Virginia bear her name.

Additional Background: Julia M. Carson served as a Member of the United States House of Representatives for Indiana's 7th congressional district from 1997 until her death in 2007. Ms. Carson was the first woman and first African American to represent Indiana's 7th District. Furthermore, Ms. Carson was the second African American woman elected to Congress from Indiana. Ms. Carson passed away on December 15, 2007.

<u>Committee Action</u>: H.R. 5472 was introduced on February 14, 2008, and referred to the Committee on Oversight and Government Reform, which held a mark-up and reported the bill by voice vote on March 13, 2008.

# H.R. 5395— To designate the facility of the United States Postal Service located at 11001 Dunklin Drive in St. Louis, Missouri, as the "William 'Bill' Clay Post Office Building" (Carnahan, D-MO)

<u>Order of Business</u>: H.R. 5395 is scheduled to be considered on Wednesday, April 9, 2008, under a motion to suspend the rules and pass the resolution.

<u>Summary</u>: H.R. 5395 would designate the facility of the United States Postal Service located at 11001 Dunklin Drive in St. Louis, Missouri, as the "William 'Bill' Clay Post Office Building."

### **Additional Background**: According to the sponsor's office:

Mr. Clay was born in St. Louis, Missouri, and began his political career in 1959, as a member of the St. Louis Board of Alderman, where he served until 1964. Prior to entering Congress in 1968, he worked as a real estate broker and later as a labor coordinator. He worked for the union of St. Louis city employees from 1961 to 1964, and then with a Steamfitters Union until 1967.

Bill Clay is known as a true pioneer of civil rights. Throughout his tenure in Congress, he became a champion of social justice, working on behalf of the poor and disenfranchised. He has been credited with eradicating racial discrimination throughout his notable career. He remains today a valuable leader in our community, and this will be a fitting tribute to his years of dedication and service.

Bill Clay represented Missouri's 1st Congressional District in the House for 32 years, was a cofounder of the Congressional Black Caucus, and Chairman of the House Committee on the Post Office and Civil Service.

**Summary**: H.Res. 1038 would express the sense that the House of Representatives:

- recognizes the fifth anniversary of the Department of Homeland Security; and
- In the Department's dedicated public servants for their extraordinary service to this Nation in helping preserve the safety and security of the American people."

The resolution lists a number of findings, including:

- ➤ "in the wake of the attacks of September 11, 2001, the Department of Homeland Security was created in an effort to consolidate our Nation's efforts to prevent, prepare for, respond to, and mitigate against threats to the homeland, including acts of terrorism, natural disasters, or other emergencies;
- "the Department of Homeland Security marked its fifth year of full-scale operations on March 1, 2008;
- ➤ "the Department has strived to integrate 22 disparate agencies and offices, while at the same time has been successful in helping prevent another terrorist attack over this period;
- > "the United States must continue to remain vigilant against all such threats;
- ➤ "the employees of the Department of Homeland Security have spent the past 5 years enhancing our Nation's domestic preparedness and collective response to terrorism and standing ready to assist State, local, and tribal governments as they prepare for and prevent acts of terrorism and respond to natural disasters and other emergencies;
- > "the Department's employees work diligently to deter, detect, and prevent acts of terrorism and stand willing, ready, and able to respond in the event of a terrorist incident or other major emergency;
- ➤ "the Department's employees have cooperated closely with the private sector to enhance emergency preparedness across the Nation;
- > "the American people rely on the Department's employees to protect our Nation's borders, airports, seaports, rail lines, and other transit systems;
- "the continuing efforts of the Department's employees will be crucial to the security of our Nation in the years to come;
- \* "the Department's employees have sacrificed, and will continue to sacrifice, time with their families and working long hours to fulfill the Department's vital mission;
- ➤ "because the Nation depends on the Department's employees to keep the American people safe from harm, they deserve the best in training, testing, and equipment;
- \* "the Department's employees often do not receive the recognition they deserve; and
- > "the Nation is indebted to the Department's employees for their sacrifices, efforts, and contributions."
