# At first sight: photography and the Smithsonian





instrumental in revealing the modern world to itself. The Smithsonian holds more than 13 million images spanning over 150 years of taking and collecting photographs. This largely unknown body of photography (most never before been published) have nothina less than represents the Smithsonian's effort, in the name of all Americans, to describe and comprehend the world. Open anywhere in these pages to be plunged in the history of our modernity, and see what the Smithsonian deemed important to document and preserve. The famous, the infamous, and the never-before-seen are

here in a remarkable "democracy of images": Amelia Earhart, Abraham Lincoln, P.T. Barnum and Tom Thumb, John Brown, Frederick Douglass, Lucille Ball, Greta Garbo, Babe Ruth; the earliest views of the moon and the earliest panoramic view of Damascus: rare Native American photography; views of Asia, Africa, and the American West; photographs of early flight, and much, much more. 

### The story of the space shuttle

In spite of the Challenger and Columbia disasters, the US Space Shuttle,

which entered service in 1981, remains the most successful spacecraft ever developed. Conceived and designed as a reusable spacecraft to provide cheap access to low Earth orbit, and to supersede expendable launch vehicles, serving as the National Space Transportation System, it now coexists with a new range of commercial rockets. David Harland's definitive work on the Space Shuttle explains the scientific contribution the Space Shuttle has made to the international space programme, detailing missions to Mir, Hubble and more recently its role in the assembly of the International Space Station. This substantial revision to existing chapters and extension of 'The Space Shuttle', following the loss of Columbia, will include a comprehensive account of the run-up to resumption of operations and conclude with a chapter beyond the Shuttle, looking at possible future concepts for a partly or totally reusable space vehicle which are being considered to replace the Shuttle.





### The league that lasted: 1876 and the founding of the National League of Professional Base Ball Clubs




By Neil W. Macdonald Jefferson, NC: McFarland & Co, 2004. 796.357 MAC In the early 1870s, baseball was chaos. mired in mismanagement and corruption. William Hulbert, the owner of Chicago's National

Association team, believed that a league run

efficiently with honest competition would survive and flourish. Hulbert, relying on his pragmatic philosophy of "molasses now, vinegar later" and working with his prize recruit Albert Spalding, founded the National League in 1876. The league fell far short of Hulbert's dreams in its first season, but he stuck to his belief that integrity would win out in the end. He not only prohibited Sunday baseball and the sale and consumption of alcohol within the league's ballparks, but ousted two teams-New York and Philadelphia-from the league because they failed to meet their obligation to finish out the season. Despite the setbacks, scandals, and considerable opposition, all of which are thoroughly covered here, the National League survived its first year.


### Best technology practices in higher education


Native American storytelling: a reader of myths and legends By Karl Kroeber Malden, MA : Blackwell Pub, 2004. 398.2 NAT

The myths and legends in this collection have

They are drawn from oral traditions of the major culture areas of aboriginal North America, and include trickster tales, origin myths and stories of domestic sexual conflict. In a substantial introduction and headnotes to each story, editor Karl Kroeber highlights the otherness of Native American narratives, in which suspense is insignificant, metaphors hardly used, protagonists are often unnamed and ambiguity of motives is stressed. He reveals the highly practical functions of myths and legends in Native American societies, demonstrating how they helped listeners to explore the efficacy of social practices and cultural institutions, and how they reinforced Indians' profound American spiritual engagement with their natural environment.



### Making government manageable: executive organization and management in the twenty-first century



After a trio of chapters explores the nature and causes of disaggregation, following chapters discuss the impact of organization and program design on federal management, with case studies of the Department of Health and Human Services, the United States Postal Service, and Medicare. The final contributions are more general in nature, presenting overall principles of organizational and program design.




Greening the Americas: NAFTA's lessons for hemispheric trade


Urban sprawl and public health: designing, planning, and building for healthy communities

Taking sustainable cities seriously: economic development, the environment, and quality of life in American cities

Today at least twenty-five major U.S. cities have pursued some form of sustainability initiative. Although many case studies and "how-to" manuals have been published, there has been little systematic comparison of these cities' programs and initiatives. In this book Kent Portney lays the theoretical groundwork for research on what works and what does not, and why. Distinguishing cities on the basis of population characteristics and region for his analysis, Portney shows how cities use the broad rubric of sustainability to achieve particular political ends. Cities that take sustainability seriously, such as Portland, San Francisco, and Seattle, use broad definitions that go well beyond concern for the physical environment or creating jobs. They pursue sustainability at many levels and integrate concern for economic development, the environment, and quality of life across all activities of city government. Cities that take sustainability less seriously, such as Cleveland, Boston, and Orlando, confine it to such issues as solid waste disposal, brownfields, redevelopment, and neighborhood beautification. Still other cities, such as New Haven, Brownsville, and Milwaukee, do considerably less to work toward sustainability.
