The Special Reclamation Group is currently applying active chemical treatment at two sites in the Tygart Valley River watershed. The first site is the DLM Mine Complex in Upshur County. Treatment to NPDES technology-based effluent limitations is required through litigation by the West Virginia Highlands Conservancy in 1985. Drainage from the Complex flows into several small tributaries of the Buckhannon River. The second site is the F&M Mine Complex in Preston County. Treatment at this site is a result of litigation by the Laurel Mountain/Fellowsville Area Clean Watershed Association. Treatment to technology-based effluent limitations requirements is the goal but not the requirement at F&M. Drainage from the site flows into the Left Fork of Sandy Creek, Sandy Creek, and then into the Tygart Lake.
