Area Command Team (Rounsaville) assigned to assist with creating a strategic plan for suppression action in Florida.

Florida Bugaboo, National Forests in Florida. Unified Command between IMT 1 (Quesinberry) and Florida DOF (Greene). NIMO (Ferguson). Baker County, FL. Southern rough. Moderate to extreme fire behavior with torching and spotting. Numerous structures in several communities remain threatened.

Bugaboo Scrub, Okefenokee NWR. Sixteen miles west of Folkston, GA.. Southern rough and timber. Running and torching. Numerous structures remain threatened.

Bugaboo Scrub 2, Georgia Forestry Commission. IMT 2 (Hannemann). IMT also managing the Sweat Farm Road, Roundabout Swamp and Kneeknocker Swamp fires. Started on private land five miles east of Fargo, GA. Southern rough and timber. Moderate fire activity with torching and spotting. Several communities are threatened. Highways remain closed. Reduction in acreage due to more accurate mapping.

Big Turnaround Complex (two fires), Okefenokee NWR. IMT 1 (Ruggiero). IMT also managing the Bugaboo Scrub fire. Ten miles southeast of Waycross, GA. Southern rough and timber. Running and torching. Folkston and surrounding communities remain threatened.

BICY Complex (four fires), Big Cypress National Preserve. IMT 1 (Stanich). Fifty-one miles west of Ft. Lauderdale, FL. Southern rough. Running fire. No further information received.

Dairy Road, Florida DOF. Seven miles northwest of Keystone Heights, FL. Timber and brush. Numerous residences threatened. No further information received.

Sweat Farm Road, Georgia Forestry Commission. Started on private land 10 miles west of Waycross, GA. Southern rough and timber. Backing fire. State park remains threatened.

Roundabout Swamp, Georgia Forestry Commission. Started on private land four miles west of Pearson, GA. Southern rough and timber. No further information received.

Knee Knocker Swamp, Georgia Forestry Commission. One mile northwest of Nahunta, GA. Southern rough. Minimal fire activity. Numerous structures remain threatened.

Deland Complex (three fires), Florida DOF. IMT 2 (Utley). IMT also managing Airport Road, Red Oak and Lee fire. Southern rough. Smoldering fire. Residences threatened.

Half Moon, Timucuan Ecological & Historic Preserve, NPS. Includes previously reported Marxh fire. Five miles south of Yulee, FL. Southern rough. Creeping fire. No further information received.

Callaway Height, Florida DOF. Eight miles northeast of Callaway, FL. Southern rough. No new information.

Smoking Monkey, Merritt Island NWR. One mile west of Titusville, FL. Tall grass. Moderated fire activity due to rain. Smoldering. Reduction in acreage due to more accurate mapping.

Getting It, Florida DOF. Four miles southwest of Yeehaw Junction, FL. Southern rough. No new information.

Oompa, Florida Panther National Wildlife Refuge. Twenty-five miles east of Naples, FL. Timber and grass. Backing fire. No further information received.



Roadside Incident Response

Nationally, the number of injuries and fatalities among emergency responders who are responding to roadside incidents is increasing at an increasing rate. Although most wildland fires occur in remote areas, there are situations where wildland fire personnel are responding to fires along rural country roads, jeep roads, or major highways; the risk still exists for our firefighters. Below is a checklist of considerations that should be utilized when responding to fires and other incidents along roadsides:





Firefighter and public safety will always be the number one priority.

- Utilize L.C.E.S. in all incident activities.
- Personal Protective Equipment will be used on all incidents.

Upon Arrival at the Scene

Size up incident- see Incident Response Pocket Guide

- What has happened?
- What is happening?
- What will or could happen?
- Is this a HazMat situation?

Risk Management Process-

Decision Point, Go No Go. See the Incident Response Pocket Guide, page 1

Tactical Considerations

- Anytime traffic flow is affected by the incident, contact the jurisdictional law enforcement agency for assistance.
- Conduct all operations as far from traffic lanes as possible to provide for crew and public safety.
- Park units on the same side of the roadway when ever possible to avoid traffic congestion.
- Personnel do not exit the fire apparatus until instructed to do so by the module leader.
- Exit the fire apparatus away from the roadway or where hazard exposure is minimized.
- Exit the fire apparatus with full personal protective equipment.
- Post a lookout to watch for and control oncoming traffic.
- Utilize forward and rear spotters when visibility is impaired or road conditions warrant.
- Utilize and place road flares or other traffic warning signs when ever possible
- If equipment needs to be removed from the traffic side of the apparatus, one person will retrieve the equipment and a lookout will watch for oncoming traffic.
- Engine operators will operate pumps from the non-traffic side or from the cab of the apparatus when possible. Keep all hose, fire tools, and equipment out of traffic lanes when possible.
- During night operations utilize reflective clothing, vests and other safety equipment as necessary.
- All emergency responses on roadways will be concluded as quickly as possible to reduce personnel exposure.
- Cancel or demob unnecessary apparatus as soon as possible.
