# **Vietnam Animal/Plant Inspection and Quarantine**

# **Regulation Update**

**Report Highlights:** The Government of Vietnam recently issued new regulations to clarify the inspection and quarantine systems. Almost all agricultural and aquatic goods must be inspected before they enter or exit Vietnam. Additionally, selected products (e.g., livestock or live fish) are subject to quarantine periods and additional tests. U.S. exporters should carefully review these regulations with Vietnamese importers.

Includes PSD changes: No Includes Trade Matrix: No Unscheduled Report Hanoi [VM1], VM In an attempt to improve the agricultural and aquatic products inspection systems and to strengthen coordination between customs and the inspection services, the Government of Vietnam (GOV) released a new set of regulations. Unfortuantely, the GOV's informal English translation of the regulations generated new uncertainities. In Vietnamese a single word can refer to both 'inspection' and 'quarantine'. This report is based on the Vietnamese version of the regulations and Post's discussions with the GOV's animal, plant and aquatic inspection services. However, all U.S. exporters are urged to carefully discuss these new regulations with their Vietnamese importers.

On March 14, 2003 the Ministry of Finance, the Ministry of Agricultural and Rural Development (MARD), and the Ministry of Fisheries issued Circular 17 to strengthen the trade inspection system for animal, plant and fishery products. The circular provides guidelines on requesting inspections, and on the supervision of those inspections. This circular (i.e., regulation) came into effect on April 1, 2003.

The formal title of Circular 17 is: Inter-Ministerial Circular 17 / 2003 / TTLT / BTC - BNN & PTNT - BTS. Guiding the Inspection and Supervision of Import/Export Goods Subject to Animal, Plant or Aquatic Product Inspection

Note: The informal translation published in the Vietnamese Official Gazette incorrectly used the English word 'quarantine' at the end of the title instead of 'inspection'. The new regulations cover inspections of all agricultural and aquatic goods, including the smaller sub-set of products that have additional quarantine requirements. The Official Gazette notes that the official version is the Vietnamese language version, not the English translation.

Circular 17 can be summarized as follows:

#### **General regulations**

- The regulation applies to all exports and imports of animal, plant and fishery products subject to inspection by MARD and the Ministry of Fisheries. MARD and the Ministry of Fisheries periodically release a list of goods subject to inspection and/or quarantine. This report includes a summary of the animal and plant products subject to inspection in Appendix 1 and 2.

- Only regional agencies assigned by MARD (Appendix 1 - Animal Products, Appendix 2 - Plant Products) and Ministry of Fisheries (Appendix 3) have authorization to certify the request for inspection forms (Appendix 4) and grant inspection certificates.

- The regulation is not applied to transit goods that are not unloaded in Vietnam.

- The inspection system consists of two steps: (1) requesting an inspection, and (2) commodity inspection. That means, the owner of the goods must first complete the 'inspection request form' and submit it to one of the inspection agencies. The inspection agency will certify the inspection request form before the good are inspected. The goods inspection (by one of the agencies listed below) can be done concurrently with the Customs check or after the Customs check. The Customs check is done to determine the import tariff, the VAT taxes, and to review the shipment's documentation, while the

goods inspection is to verify the quality and safety of the import/export goods.

#### **Responsibilities of the Trading Company or Owner of the Goods**

#### S Exporting

Before loading goods for export, the owners (or trading company) will have to request an inspection and declare their goods to an inspection agency in order to get an inspection certificate in accordance with the current Vietnamese inspection regulations or the requirements of the buyers.

#### S Importing

Before obtaining customs clearance, importers (and/or the owners of the goods) will have to submit 3 copies of the inspection request form (Appendix 4, below) to an inspection agency.

After the inspection request form is certified,

- a. one copy is submitted to Customs office for goods/commodity clearance
- b. one copy is for the owner/trader, and
- c. one copy is retained at the inspection agency.

Goods that do not meet the inspection agency or Customs requirments must be re-exported or destroyed.

#### **Responsibilities of the Inspection Agencies**

- **S** To certify the inspection request forms.
- **S** To implement good inspections and issue inspection certificates.
- **S** To coordinate with Customs offices the inspection of the goods
- **S** To decide whether imported goods can enter Vietnam or must be destroyed or re-exported.

#### **Responsibilities of the Customs Offices**

- **S** For export goods, they will only request the inspection certificate
- **S** For import goods, Customs officers must have one copy of the inspection request form.
- **S** For import goods rejected for Customs reasons, the Customs officers will coordinate the reexport or destruction of the goods with the appropriate inspection agency.

Note: In addition to the procedures described in Circular 17, animal product (e.g., beef or pork meat) importers need to obtain an import inspection permit issued by the Department of Animal Health (DAH) of Ministry of Agricultural and Rural Development (MARD). The permit is extended (renewed) quarterly.

Animal products subjected to inspection are listed in Decree 607/NN-TY/QD dated June 9, 1994 by MARD.

That Decree (highlights only) requires inspection for:

#### Part I

- a. All live animals
- b. Animal products, including meat, pate, milk, honey, hides and skins, etc.
- c. Equipment used in livestock production, slaughter and packaging
- d. Means of transport for animals and animal products (plane, ship, truck, etc.)

#### Part II

The Decree includes a long list of diseases to be checked. This list is based on OIE standards, and also notes MARD will adjust the list based on the prevailing OIE standard, and world animal diesease concerns.

Part III - Toxic Substances

A list, based on OIE standards, of various chemicals and contaminates ranging from antibiotics to bacteria and aflatoxin. NOTE: The list was recently updated to include chloramphenicol.

This Decree covers (summary only):

1. Plants

Live plants imported /exported for breeding purposes, bulbs, tubers, etc.

2. Plant Products

Includes rice, flour, oilseed meal, seeds, fiber, tobacco, yeast, wood, straw, and other bulk plant products, such as wheat, cotton, etc.

3. Agents Impacting Plants

Fungus, Virus, Insects, etc.

- 4. Soil
- 5. The means of Transportation for plants, plant products, etc.

#### **MINISTRY OF FISHERY**

The Ministry of Fishery authorizes the **Fishery Resource Reservation Department** as a sole agency in certifying company inspection registration forms and granting inspection certificates to fishery exporters and importers.
