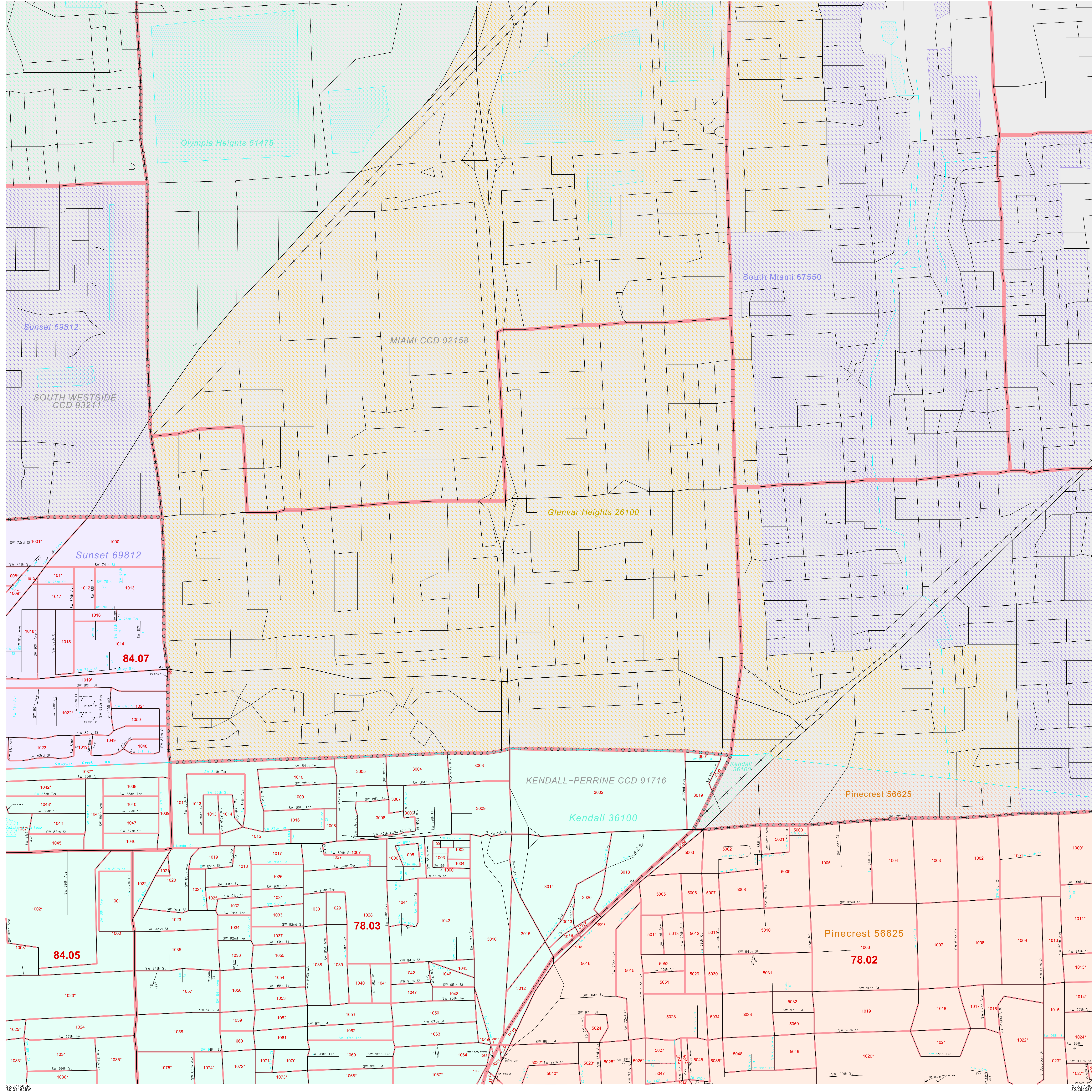


CENSUS 2000 BLOCK MAP: KENDALL-PERRINE CCD

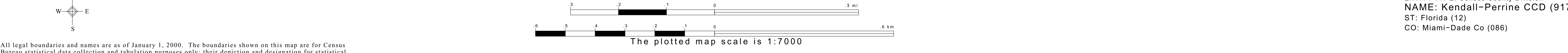
