Frames Project

Goal 1, Section 2, item 2 of the strategic plan says that EIA will monitor the percent of key EIA surveys frames with sufficient industry coverage to provide accurate supply, demand, and price statistics.

The attached table is our first draft of a list of EIA surveys that are either frames surveys, or that are census surveys, so the respondent list is essentially a "frame".

EIA will need to decide which are the "key" frames.

The most difficult question we will need to address is how to assess "coverage"? First, we are interested in developing an internal "feel" for the quality of the frame by considering questions such as: how often survey managers look for new frame members, and how successful these efforts are, how often major frames update studies are conducted and so on. We might look for comparisons to outside data.
