2	Topic – IQCS Performance Problems				
	Presenters – George Conley				
	Discussion:				
	Al began the session by stating that this session was an attempt to get all comments on the				
	table in order to discover the truths behind the latest spate of rumors about how this				
	system has been performing. George presented an in-depth, technical description of				
	the factors contributing to IQCS performance issues. Basically, the system is being				
	utilized in a different way (using multiple windows) than was foreseen during design.				
	PeopleSoft parameters are being adjusted for the newly discovered concurrent				
	workloads for users and processes. Performance increases are being gained. A variety				
	of network and performance tools are being utilized to analyze performance issues.				
	George is completing the draft of an information bulletin about IQCS performance				
	issues that is to be distributed to the business community using IQCS. Intent is to				
	share what is happening and to request continued input from the users. Individual				
	agency network latency appears to also be a problem. SCG suggests that, if possible,				
	George expand the scope of queries to the users to also ask about performance of other				
	interagency systems. In a side topic, George notes that the BLM will be performing an				
	independent review of the IQCS system – possible as soon as this winter.				
	In follow-on discussion, the SCG noted that open communication about these types of				
	issues would help prevent assumptions and rumors. The SCG noted also that we are				
	not really taking advantage of the SCG mailing list to share system-related				
	information. As topics of IRM-related issues arise within individual members'				
	agencies, we should strive to circulate these emails via the SCG mailing list.

Jon Skeels (FS) and Tina Vorbek (BLM) have been designated as the leaders for this task group. Task group members have been identified as Greg Jensen (BLM), Faye Chandler (FS), Gina Bald (FS), and David Potter (SCG). 	Discussion:
	The SCG discussed the task to create these guidelines, and different perspectives arose over the merits of such an endeavor. The group finally concurred that an attempt to create these guidelines was a good idea. Task Group lead will be Al Borup. Task Group team membership suggestions were John Lutzow (BLM), Merrie Johnson (NPS), Mike Barrowcliff (FS), and John Noneman (FPA). SCG agrees that the existing DRAFT NWCG Change Mgmt guidelines will provide a place to start.

- Andy
 - Open house demo of the Yantra package for ICBS-R was very well received.
 - Al noted that the RAWS depot is about ready to procure a system for their maintenance inventory and suggested that Andy get the Yantra folks and the RAWS depot folks (Kazimir) together to see if we can leverage our Yantra toolset investment. Andy and John G. will follow up.
- John Noneman
 - Suggested that an interagency on-line discussion forum be created for national users to discuss and share information about national systems use. SCG agrees that this idea has merit and suggests that its consideration could possibly be a part of the HelpDesk study Task Group's assignment.
 - An interagency review of the FPA application is scheduled.
- John Gebhard
 - Mentioned that Sheldon Wimmer of Utah BLM is having major support problems with their implementation of VOIP.

- NIFC BLM is going to be setting up a test center for fire applications so that changes can be "bounced off the test systems" before implementation. Identification of the core interagency fire and aviation systems need to be identified.
