Session 24: Case Study Presentations

1 hr.

Objectives:

- 24.1 Identify at least six disaster case studies, including the event, locale, and authors
- 24.2 Identify the range of data collection techniques used in at least six disaster case studies
- 24.3 Discuss the most significant conclusion from at least six disaster case studies
- 24.4 Identify at least four findings or conclusions from disaster case studies that are inconsistent with the Drabek (1986) inventory
- 24.5 Discuss at least four normative recommendations pertaining to emergency management policy or procedures made by case study authors
- 24.6 Identify at least four findings from disaster case studies that have relevance to emergency managers.

Scope:

This session provides students with opportunity to prepare and present an informational speech based on a disaster case study of their choice. By listening attentively to the presentations of classmates, the breadth of their knowledge of the disaster literature will be expanded considerably.

Remarks:

- I. Procedures.
 - A. It is recommended that the professor **remind** students of the **procedures** outlined previously (see Session 18 entitled "Mid-Term Examination"; Objective 18.2).
 - B. Depending on the class size and professorial discretion, the **length** of the case study presentation may very although **experience suggests** that 10-15 minutes is useful.
 - C. An additional five to ten minutes for **questions and discussion** can help maximize the contribution of each case study to student knowledge of the literature.
- II. Introduction.
 - A. It is recommended that the professor **display** Overhead 23-1; "Case Study Topics" **prior** to the first presentation. (remind class of Student Handout 18-3; "Oral Summary of Case Study: Required Topics").
 - 1. Authors (what did you learn about them?)
 - 2. Event and locale (summary).
 - 3. Research methods (summary).
 - 4. Cautions (given the methods used, what cautions are in order regarding acceptance of the findings and conclusions?)
 - 5. Confirmed conclusion (select the most significant conclusion or finding that was confirmed in the Drabek inventory and summarize it).

- 6. Inconsistent conclusion (describe the most significant inconsistency you discovered between this case study and the conclusions included in the Drabek inventory).
- 7. New research (what new research studies did this case study suggest to you?)
- 8. Emergency management lessons (what aspects of this case study are most relevant to emergency managers?)
- B. As the presentations continue, it may be **helpful to display** the overhead from time to time as a referent for questions or as a reminder for upcoming speakers.
- C. The **rationale** for the assignment should be noted, i.e., course objective pertaining to increase in student capacity in written and oral communication skills.
- D. Prior to each presentation, **students should distribute** the note taking device on which they have listed the citation for the case study.
