

# Helmet Effectiveness

50% of all riders were helmeted in Los Angeles, 40% in crashes were helmeted and only 20% of the fatally injured riders wore helmets.

## Helmet Effectiveness

Unhelmeted injured riders are three times more likely to suffer brain injury.

(CODES, 1998)

# Helmet Effectiveness Helmets have no effect — positive or negative on neck injury.

# **Helmet Myths Busted**

Helmets do not break necks Helmets do not block vision Helmets do not cause hearing problems Helmets don't add to inertial injury Goldstein was wrong

Helmet Drawbacks Can be expensive Are easily stolen Inconvenient after arrival Cause "helmet hair" Can be hot depending on coverage and weather

- Promulgated 1974
- Updated 1980, 1988
- Update Feasibility Study completed 1997
- Additional update work complete
- Current labeling requirements hinder enforcement
- No date set for update

# Legislation

 Universal helmets laws increase helmet use from voluntary 50-60% to often 100%

# Universal helmet laws do not mean universal head protection




18 states with universal helmet laws
30 states with partial laws (e.g., under 21)
3 states with no helmet requirements

# Universal helmet laws do not mean universal head protection



In universal helmet law states, up to 40% of riders are wearing unqualified novelty helmets.

#### Heads Up on Retro Helmets

NAZI-INSPIRED MOTORCYCLE helmets have been around since, well, the Nazis. But now they're becoming the headgear of choice for a growing corps of professionals who want that bad-boy biker image. Jim Peacock, president of Butthead Novelties, sells about 500 German-style helmets a month-up 20% from a year ago-at \$50 each to customers in "the Incrowd kind of states like California." John Daniele, owner of the online retailer Helmets R Us (www.helmetsrus .com), confirms it. "I'm selling them mostly to professional, business-oriented people," he says.

Not everyone thinks the fad is smart, since the trendy styles tend to be too lightly padded. "It's like having a fake fire extinguisher," says David Thom of the Head Protection Research Laboratory. "Sure, it will keep you from scraping your skull, but it won't protect your brain." **—By Clare Demerse**
