
### The Pan Am building and the shattering of the modernist dream





## The illusion of public opinion: fact and artifact in American public opinion polls





In a rigorous critique of public opinion polling in the U.S., George F. Bishop makes the case that a lot of what passes

as public opinion in mass media today is an illusion, an artifact of measurement created by vague or misleading survey questions presented to respondents who typically construct their opinions on the spot. Using evidence from a wide variety of data sources, Bishop shows that widespread public ignorance and poorly informed opinions are the norm rather than definitive public opinion on key political, social, and cultural issues of the day. The Illusion of Public Opinion presents a number of cautionary tales about how American public opinion has supposedly changed since 9/11, amplified by additional examples on other occasions drawn from the American National Election Studies. Bishop's analysis of the pitfalls of asking survey questions and interpreting poll results leads the reader to a more skeptical appreciation of the art and science of public opinion polling as it is practiced today.







Capital Account relates the story of the world's greatest investment bubble from the perspective of

professional investors. The book, comprised of selected reports from Marathon Asset Management, а successful investment firm, explains how shareholder value the notion that companies should be run in the interests of their shareholders became corrupted in this era of frenzied finance. Senior managers, succumbing to the lure of stock option fortunes, took to manipulating their company's earnings. Professional investors, interested only in maintaining their investment performance over the next quarter, were willing abettors. The 'croupiers' of Wall Street also know as investment bankers, whipped up the euphoria and peddled to investors superficially plausible stories, 'MacGuffins', in order to generate huge fees for themselves. As a result, by the turn of the century almost the entire investment community had become fixated with chasing short-term profits at the expense of longterm returns for clients. By the end of 2002 this cynical game had ended in investment disaster the world's stock markets having produced more than \$15 trillion of losses since their peak. Yet to a large extent, the outcome was predictable to those investors who had retained a disciplined approach to investment analysis throughout the bull market. This book introduces the 'capital cycle' approach to investment an approach that brings together ideas from the fields of behavioral finance, economic theory and business analysis. Capital cycle analysis based on the apparently simple insight that investor euphoria leads to excessive investment in the real world and subsequent poor returns for shareholders - enabled

Marathon to identify at an early stage the inevitable collapse of the technology and telecoms bubble.


When the Wright brothers invented their flying machine, Americans lived in a nation of two dimensions, circumscribed by lines drawn on a conventional map. A century later, their nation existed-- in fact,



reigned--in three dimensions. Two million Americans "slipped the surly bonds of earth" daily, carried aloft by aircraft operating in every part of the world. The airplane turned the sky into a new domain of human activity, a fast-developing frontier first braved by adventurous young men. Then came the rich and the hurried, followed by just about everybody else. Until now, no one has told the story of aviation as one of frontier expansion. Aviation's frontier stage lasted a scant three decades, then vanished as flying became a settled experience. Sky as Frontier shows how commercial and military imperatives destroyed this pioneer world by routinizing flight. Along the way, Courtwright stops to consider dog fighting, barnstorming. the first air mail pilots, the development of

airlines, air power during World War II, flight's impact on the environment, the troubled space frontier, and how the maledominated aviation enterprise domesticated and democratized. The history of American flight shows a fateful trade-off. Rationalization killed the adventure in flying but made possible rapid aerial expansion. With it came commercial growth and global military reach. In no other country did social life, business, and military operations become so intertwined with aerospace advances or have such large consequences for national power and prestige.

### The opportunity: America's moment to alter history's course




