<u>United States of America vs. Richard Brown, Michael Rivera, Jose Concepcion, Bruce Vetre,</u> <u>Nelson Datil, Richard Dominguez, David Brown, Angel Hernandez, Dariel Perez Torres, Shoreline</u> <u>Motors Corp. dba Shoreline Mitsubishi and James Clanton</u>

On May 18, 2005, a fourth superseding Indictment was filed charging Angel Hernandez with one count of Conspiracy (18 U.S.C. § 371), three counts of Mail Fraud (18 U.S.C. § 1341) and eighteen counts of Wire Fraud (18 U.S.C. § 1343); David Brown with one count of Conspiracy, and six counts of Wire Fraud; Richard Brown with one count Conspiracy, one count of Mail Fraud and four counts of Wire Fraud; and Nelson Datil with one count of Conspiracy, one count of Mail Fraud and four counts of Wire Fraud.

A trial has been rescheduled to August 9, 2005 at 10:00 a.m. at the United States District Court, 141 Church Street, New Haven, Connecticut. The defendants on trial are Angel M. Hernandez, David S Brown, Richard L Brown, and Nelson Datil. It is possible, however, that this date may change.
