If equipment fails due to such defects, Nvision shall, at its option, repair or provide a replacement for the defective part of product. Freight and insurance charges for the return of the defective product or part shall be the responsibility of the Buyer.

AJA Video Warranty

AJA Converters carry a 5-year warranty from the date of purchase against defects in material and workmanship. All Desk top products carry a 3-year warranty from the date of purchase against defects in material and workmanship. AJA Video, at its option, will repair or replace each defective product with a similar or better product. This warranty is limited to defects which were not casued by misuse, abuse, imporper handling, tampering or attempts to repair by any unauthorized repair service.

ISIS GROUP WARRANTY

All Products manufactured by ISIS carry a seven (7) year waranty, with the following exceptions: -MiniBlox and MaxiBlox series products carry a one (1) year warranty - Openstore Series products carry a one (1) year warranty. If equipment fails because of such defects, ISIS will, at its option, repair the defective product and restore it to its normal operation or provide a replacement in exchange for the defective product providing the equipment has not been subject to mechanical, electrical or any other abuse or modification. Equipment that fails under conditions other than those covered above will be repaired at Buyer's expence at the price of parts and labor in effect at the time of repair. Such repairs are warranted for a period of (90) days from the date of reshipment to Buyer. Replacement of spare components are also warranted for a period of (990) days from date of shipment. Equipment supplied by ISIS and manufactured by others carries the respective manufacturer's warranty. ISIS assumes no warranty obligation either expressed or implied for equipment manufactured by others and suplies by ISIS.
