Purpose and Methodology

Purpose

This report is the fifth in a series of reports examining national priority related DHS funded activities. *Strengthen CBRNE Detection, Response and Decontamination Capabilities: DHS Funded Activities* highlights major state, urban area, regional and local initiatives designed to Strengthen CBRNE Detection, Response and Decontamination Capabilities which are funded with Department of Homeland Security grant programs including the Homeland Security Grant Program (HSGP) and the Urban Area Security Initiative (UASI).

National Priority

Strengthen CBRNE Detection, Response and Decontamination Capabilities

Methodology

The projects described in this report have been reported directly to the Department of Homeland Security Office of Grants and Training by state and local users of the Grants Reporting Tool (GRT) through the submission of their Bi-annual Strategy Implementation Report (BSIR).

The project types listed below in the fiscal years 2004 and 2005 BSIRs from the June 2006 calendar year submission were used to identify projects that Strengthen CBRNE Detection, Response and Decontamination Capabilities and Citizen Protection Capabilities. Previous submissions were used for the District of Columbia (December 2005) and Puerto Rico (June 2005) due to the status of those submissions at the time of this report.

- Enhance capabilities to respond to CBRNE events
- Establish / enhance explosive ordnance disposal units/bomb squads
- Establish / enhance regional response teams

All investments in the fiscal year 2006 ISIP submission specifically mapped to the Strengthen CBRNE Detection, Response and Decontamination Capabilities national priority were also identified and detailed in this report.

The project narratives provided on each state and territory detail page were selected from those projects and investments aligned to the types and priority listed above and may represent only a portion of total state or territory funding aligned to Strengthen CBRNE Detection, Response and Decontamination Capabilities related projects and investments.




National Strengthen CBRNE Detection, Response and Decontamination Capabilities Projects Allocation Summary for Fiscal Years 2004, 2005 and 2006.













FY 2004 Strengthen CBRNE Detection, Response and Decontamination Capabilities Allocations by Type



Project Description: This project is to provide CBRNE Response Vehicles to Law Enforcement, Fire, and Emergency Medical Services to enhance response capabilities. The Lee County Homeland Security Council seeks to provide 1.) A Response Vehicle capable of towing a

Mobile Command Post Vehicle (purchased with local funds) for the Opelika Police Dept 2.)A Response Vehicle capable of transporting personnel and equipment for the Lee County Sheriff's Office 3.) Investment Name: Maintain and enhance the state's CBRNE detection and response capabilities **Investment Description:** The purpose of this Investment is to enhance the state's law enforcement and hazardous materials (HAZMAT) capabilities associated with chemical, biological, radiological, nuclear, and explosive (CBRNE) threats and events, as well as the state's Metropolitan Medical Response System (MMRS). These funds will enable the state to procure current equipment, train technicians and responders in the latest weapons of mass destruction (WMD) and all-hazards techniques, and effectively share information/intelligence through a state-level intelligence fusion center. Expected outcomes include: enhanced capabilities for handling hazardous materials, including decontaminating mass casualties and containing the negative effects of WMD devices; enhanced capabilities to gather and disseminate information in a manner promoting collaboration and information sharing; and enhanced training of our law enforcement and HAZMAT teams to facilitate collaboration and interoperable response.



Investment Name: Increase EOD Capabilities

Investment Description: The Anchorage Bomb Squad is working with the FBI on a task force concept that would bring all three civilian bomb squads into a unified response structure to assist with State wide response. The idea is to create a team that could respond anywhere in the State, under the FBI umbrella, and either take care of the problem or stabilize it until



outside help can be obtained. The initial funding appears to be part of the Joint Terrorism Task Force, but could change depending on other future avenues. This would enable all bomb techs to train and work together developing continuity of operations to benefit the whole State. Each local jurisdiction is also in need of PPE for their responders who assist the EOD teams. If the EOD teams deploy to a local jurisdiction in a mutual aid capacity, the local first responders will likely not have the sufficient and appropriate PPE to functionally support the EOD. This creates the possibility for an extremely unsafe incident with an EOD team operating without support. **2006 Funding:** \$163,500.00



Investment Description: As a crosscutting initiative, the development of multi-discipline HazMat teams for response in American Samoa communities were identified as essential assets for response enhancement by the program leadership during the Program and Capability Assessment Review process. CBRNE Detection, Response, and Decontamination objectives, including the priority concerns of Explosive Device Response Operations – in conjunction with established ordinance teams - are





inherently linked and are to be addressed through this multi-purpose initiative. Through the combined approach of well trained and outfitted HazMat teams, comprised of multiple disciplines to include fire, health, law enforcement, public works, and customs staffs, gains in efficiency of situational assessments with simultaneous improvements in time-sensitive response coordination, and reduction of the labor resource consumption due to responder limitations based on operational strain factors, this initiative will serve to markedly enhance support capacity for dealing with the core nature of risk-based capabilities throughout American Samoa. **2006 Funding:** \$1,273,050.00



CBRNE detection equip such as portal detection systems, remote camera/video technology, and individual hand-held sensors will enhance the detection capabilities at the four international POEs along the 350 mile border with Mexico, seven high volume Interstate POEs, and sixteen additional secondary highway POEs along the 1,100 mile interstate border with neighboring states. Providing state of the art Intelligence Analysis database software for Arizona's Fusion Center (AcTIC) will enhance CBRNE Detection capabilities. Additionally, providing detection equipment to LE and FS departments and Regional Rapid Response Teams for National Security Events such as Presidential visits, Presidential Candidate Debates, Super Bowl, Fiesta Bowl, Insight Bowl, and World Series. **2006 Funding:** \$349,931.00

Investment Description: This investment will establish specialized technical rescue capabilities through the development of Regional Task Forces. The Task Force is a compilation of first responder "teams" with specialized training. A few of these teams already existed, some of them needed additional or enhanced training and a few specialities didn't even exist in Wisconsin. The level of ability was also



geographically uneven across the State so that some areas had a capability while others had none. Those that did exist had little or no awareness training of the other disciplines operational capabilities or procedures. This would create operational problems when they had to work together on an interdisciplinary major disaster. FFY06 Homeland Security funds will be utilized to enhance and support this concept. Law Enforcement, Fire, EMS and other disciplines will be equipped, trained and organized into regional response teams that will be located strategically around the state of Wisconsin. These teams will be positioned to respond to WMD incidents or natural disasters.



This program will be fine tuned through the use of exercises involving terrorist attacks using CBRNE weapons to test the ability to detect, deter and mitigate these attacks.
