

 - ▶ **PECO Energy, Chester, PA**







RCRA Brownfields Pilots

1st Round

■ **Bethlehem Steel, Lackawanna, NY**

- ▶ 2000 acre former integrated steel mill with multiple planned reuses, including greenspace.
- ▶ Pilot succeeded in:
 - removing a parcel of the site from the Corrective Action investigation order to encourage cleanup and redevelopment, and
 - serving as a focal point for launching a community-wide land use and redevelopment dialogue.
- ▶ Intended future use: - Build a light industrial park.


RCRA Brownfields Pilots

1st Round

■ **Blue Valley, Kansas City, MO**

- ▶ Multi-facility industrial area containing several RCRA facilities, in the Blue River floodplain.
- ▶ Pilot succeeded in:
 - consolidating RCRA, GIS and other environmental data into a Redevelopment Opportunity Portfolio.
 - developing a site parceling approach at one of the RCRA facilities to enhance redevelopment.
 - facilitating a partnership with USACE to allow reuse of clean dredged materials as fill on RCRA facilities in industrial area.
- ▶ Intended future use: - new industrial facilities in former industrial areas.



CBS/Viacom, Bridgeport, CT






RCRA Brownfields Pilots

1st Round

■ ***CBS/Viacom, Bridgeport, CT***

- ▶ An electrical manufacturing facility for over 100 years in an Environmental Justice Area.
- ▶ Pilot succeeded in:
 - RCRA Corrective Action requirements successfully integrated with Connecticut Property Transfer Act, and
 - streamlined cleanup process and redevelopment plans.
- ▶ Intended future use: - light manufacturing



■ ***PECO Energy, Chester, PA***


- ▶ Former utility site located in an Environmental Justice community.
- ▶ Pilot succeeded in: - Successfully integrating RCRA Corrective Action requirements with Pennsylvania's Act II streamlined cleanup process .
- ▶ Intended future use:
 - former coal fired utility is currently being renovated into a high tech office building.
 - rest of site to be redeveloped later.

■ **Muskegon Heights, MI**


- ▶ Former wastewater treatment and hazardous waste treatment plant.
- ▶ Pilot will attempt to:
 - resolve purchaser liability concerns.
 - facilitate redevelopment as a residential and recreational area, and
 - resolve demolition issues.



■ **BP Refinery: Wood River, IL**


- ▶ Former 600 acre refinery site in center of business and residential areas.
- ▶ Pilot will attempt to:
 - develop an overall cleanup strategy,
 - encourage commercial and industrial reuse and ecological restoration, and
 - involve community with cleanup goals and future-use planning.

RCRA Brownfields Pilots 2nd Round

■ ***Union Carbide Caribe: Infrastructure Financing Authority, Puerto Rico***

- ▶ Former chemical processing facility in prime location for a deep draft container transshipment port Guayanilla Bay.
- ▶ Pilot will attempt to:
 - finalize a site acquisition plan,
 - integrate port designs with RCRA permit,
 - carve out a parcel for quick redevelopment,
 - determine fate of each of the 36 SWMUs,
 - structure an Environmental Management System for the port consistent with ISO 14000, and
 - negotiate a prospective purchaser agreement.

■ ***Milt Adams: Commerce City, CO***


- ▶ Bankrupt former used oil recycler and TSD, one acre in size in an environmental justice area.
- ▶ Pilot will attempt to:
 - initiate Alternative Dispute Resolution to establish cleanup goals that fit with redevelopment and identify financial resources for cleanup,
 - package site with 3 acre adjacent property, and
 - scope out remedial requirements (incl. poss. long term institutional controls).

■ ***Pharmacia & Upjohn: North Haven, CT***

- ▶ Former 78 acre specialty chemical manufacturer abutting the Quinnipiac River.
- ▶ Pilot will attempt to:
 - enhance stakeholder input on reuse of the site early in the process through meetings and presentations,
 - provide a written summary of stakeholder suggestions for future reuse,
 - clearly define cleanup objectives for the CMS, and
 - expedite cleanup and restoration of the site.



RCRA Brownfields Pilots

Summary Thoughts and Conclusions

- Each pilot serves as a good example of expanded stakeholder involvement as cleanup decisions are being integrated with redevelopment plans.
- Six of the nine facilities are also in environmental justice areas.
- The first round of pilots have a greater emphasis on establishing, modifying or highlighting the regulatory mechanism in place.
- The second round of pilots have a greater emphasis on resolving liability concerns.
- These pilots demonstrate that frequent communication among diverse stakeholders, along with the RCRA Cleanup Reforms' emphasis on "results over process" can expedite cleanup and redevelopment at all RCRA facilities (not just Brownfield sites).
