10	tablish policies and procedures to delineate the du-
11	ties of the chief ethics officer.
12	"(3) Line of Authority.—
13	"(A) In general.—The chief ethics offi-
14	cer shall report to the chief executive officer of
15	the corporation.
16	"(B) Certain Parties.—Notwithstanding
17	subparagraph (A), the chief ethics officer shall
18	report to the ethics committee whenever an al-
19	leged violation involves—
20	"(i) senior management or directors
21	of the corporation;
22	"(ii) officers or directors of a member
23	organization;
24	"(iii) a bid city; or

1	"(iv) the International Olympic Com-
2	mittee.
3	"(c) Ethics Policy.—The ethics committee shall es-
4	tablish an ethics policy for the corporation, subject to the
5	approval of the board of directors, modeled upon the best
6	practices used in corporate and government offices. The
7	policy shall include—
8	"(1) a conflict of interest policy;
9	"(2) an anti-discrimination policy;
10	"(3) a workplace harassment policy;
11	"(4) a gift, travel reimbursement, honorarium,
12	and outside income policy;
13	"(5) a financial propriety policy, including a
14	prohibition on loans to corporation officers and em-
15	ployees;
16	"(6) a bid-city policy which includes a trans-
17	parent and objective set of criteria published in ad-
18	vance by which the corporation will choose a United
19	States city to submit a bid to the International
20	Olympic Committee for an Olympic games, which
21	adheres in all respects to the rules and ethics guide-
22	lines of the Olympic Charter and the International
23	Olympic Committee, and which applies to the leaders
24	and staff of a city, or organizations representing a

1	bid city, that file an official bid with the corporation
2	to host Olympic games;
3	"(7) potential sanctions and penalties for viola-
4	tions of the ethics policy, which may include removal
5	from corporation duties;
6	"(8) a procedure for reporting and investigating
7	potential ethics violations; and
8	"(9) procedures to assure due process for any
9	individual accused of an ethics violation, including—
10	"(A) a timely hearing before the ethics
11	committee;
12	"(B) the right to be represented by coun-
13	sel; and
14	"(C) access to all documentation and state-
15	ments that would be used in an ethics pro-
16	ceeding against that individual.
17	"(d) Written Statement Required.—All mem-
18	bers of the board, employees, and officers, directors of
19	member organizations, and leaders or representatives of
20	United States bid cities must sign a statement that they
21	have read the corporation's ethics policy and agree to
22	abide by its rules.
23	"(e) ETHICS COMMITTEE ADJUDICATION OF VIOLA-
24	TIONS.—When the ethics committee determines that an
25	individual has violated the corporation's ethics policy, it

- 1 will report to the Board and may make recommendations
- 2 for action to be taken.
- 3 "(f) Investigation, Reporting, and Review Pro-
- 4 CEDURES.—The ethics committee shall establish a proce-
- 5 dure for the prompt review and investigation of ethics vio-
- 6 lations, and establish regular reporting and review proce-
- 7 dures to document the number and types of complaints
- 8 or issues brought to the ethics committee and the ethics
- 9 officer.
- 10 "(g) Outside Counsel.—The ethics committee may
- 11 hire outside counsel to conduct investigations, report find-
- 12 ings, and make recommendations.
- 13 "(h) BID CITY DEFINED.—In this section, the term
- 14 'bid city' means 1 or more cities, States, regional organiza-
- 15 tions, or other organizations that file an official bid with
- 16 the corporation to be chosen as the site nominated by the
- 17 United States to the International Olympic Committee to
- 18 host an Olympic Games.".

- 20 quotation marks and the period at the end of the item
- 21 relating to section 220544.
- On page 17, before line 11, after the item relating
- 23 to section 220544, insert the following:

"220545. Ethics and compliance".
