## The Conference Report is:

- $\$ 1.129$ billion or $\mathbf{7 . 1 \%}$ above last year;
- \$388 million or $\mathbf{2 . 3} \%$ above the President's request;
- $\$ 48$ million or $0.3 \%$ above the House passed bill; and
- $\$ 49$ million or $0.3 \%$ below the Senate passed bill.


## LANGUAGE OF NOTE:

Mandatory Contraceptive Coverage: The Conference Report contains language similar to last year mandating that FEHBP plans to provide contraceptive coverage. The provision retains the conscience protection.

Federally Subsidized Child Care: The Conference Report makes permanent the pilot program created two years ago which permits federal agencies to use their salaries and expense accounts to subsidize childcare for federal employees. While the provision was designed to benefit lowincome federal workers, recent reports indicate that the program in some instances is subsidizing employees with salaries in excess of $\$ 60,000$ and $\$ 80,000$ annually.

Federal Employee Pay: The Conference Report contains a provision providing federal employees with a $4.6 \%$ pay raise. President Bush proposed a $3.6 \%$ raise for civilian employees and a $4.6 \%$ raise for military personnel. The increased pay for civilian employees above the President's request will cost taxpayers $\$ 900$ million.

OMB Authority: The Conference Report prohibits OMB from calculating after February 15, 2002, what each appropriations bill would cost under the President's budget.

Utilities at the Vice-President's Residence: The Conference Report includes language authorizing the Navy to pay for utility costs at the Vice-President's residence.

Breast Cancer Research, 9-11 Heroes, and Domestic Violence Semipostals: The Conference Report extends the authorization for the Breast Cancer Research Semipostal and authorizes the creation of two new semipostals. The 9-11 Heroes Semipostal would be authorized through December 31, 2004, with the proceeds collected (above the cost of regular mail) to be transferred to FEMA. The Stamp Out Domestic Violence Semipostal would be authorized through December 31, 2006, with the proceeds collected (above the cost of regular mail) to be transferred to the Department of Health and Human Services.
