FOR A FOREIGN AIR CARRIER PERMIT AND EXEMPTION

On March 30, 1992, Laker Airways (Bahamas) Limited ("**Laker**") filed applications for issuance of a **§** 402 Foreign Air Carrier Permit and **§** 416(b) Exemption but erroneously indicated that Laker's aircraft would be maintained by **USAir**, Inc. In fact, Laker's aircraft will be maintained by PMS, Inc., an FAA-approved repair station **located at** the Miami International Airport. The aircraft will be

maintained by PMS pursuant to **USAir's** FAA-approved maintenance program. In addition, the aircraft are not owned by **USAir** but Laker is subleasing them from **USAir**.
