16	funding within the Department must be shifted else-

- 14 Warriors.—Section 2031 of title 10, United States Code,

- 1 Warriors as result of combat action and may be in receipt
- 2 of medical pay for regular active duty service and whose
- 3 qualifications are approved by the Secretary and the insti-

"(1) A medically retired member so employed is entitled to receive the member's retired or retainer pay without reduction by reason of any additional amount paid to the member by the institution concerned. In the case of payment of any such additional amount by the institution concerned, the Secretary of the military department concerned shall pay to that institution the amount equal to one-half of the amount paid to the retired member by the institution for any period, up to a maximum of onehalf of the difference between the member's retired or retainer pay for that period and the active duty pay and allowances which the member would have received for that period if on active duty. Notwithstanding the limitation in the preceding sentence, the Secretary concerned may pay to the institution more than one-half of the additional amount paid to the retired member by the institution if (as determined by the Secretary) the institution is in an educationally and economically deprived area and the

1	Secretary determines that such action is in the na-
2	tional interest. Payments by the Secretary concerned
3	under this paragraph shall be made from funds ap-
4	propriated for that purpose.
5	"(2) Notwithstanding any other provision of
6	law, such a retired member is not, while so em-
7	ployed, considered to be on active duty or inactive
8	duty training for any purpose.".
