Semiannual Regulatory Agenda

AGENCY: National Indian Gaming Commission.

ACTION: Semiannual regulatory agenda.

SUMMARY: The National Indian Gaming Commission (NIGC) today is publishing an agenda of its open and anticipated rulemaking actions. The agenda is a general announcement to the public intended to provide notice of rulemaking actions in which the public may wish to participate. Beginning with the fall 2007 edition, the Internet became the basic means for disseminating the Unified Agenda. The complete Unified Agenda will be available online at www.reginfo.gov.

In the future, the NIGC intends to issue notices of proposed rulemaking, advance notices of proposed rulemaking, or final rules for the following: rules establishing classification standards for gaming machines; rules establishing technical standards for Class II gaming machines and associated equipment; rules revising the audit standards that apply to Indian gaming facilities; rules revising Privacy Act procedures; rules establishing a process for the assessment, notification, and collection of debts owed the NIGC; rules revising tribal background investigation submission requirements and timing; rules concerning hearings and appeals procedures; rules revising the scope and review of management contracts; rules concerning the definitions of "electronic or electromechanical facsimile," "net gaming revenue," "sole proprietary interest," "direct or indirect financial interest in a management contract," and "key employee"; rules concerning administrative fees; rules revising and updating the civil fines provisions; rules concerning technical amendments to the NIGC's Minimum Internal Control Standards (MICS); rules regarding MICS specific to Class II gaming; rules regarding background investigations of persons or entities with a financial interest in a gaming facility; and rules concerning background investigations and licenses for key employees and primary management officials. The NIGC invites questions and public comment on individual agenda items.

SUPPLEMENTARY INFORMATION: In accordance with Executive Order 12866 "Regulatory Planning and Review" and the Regulatory Flexibility Act (5 U.S.C. 605), executive agencies are required to publish semiannual regulatory agendas in the **Federal Register** each year.

The regulations being considered by the NIGC are not "significant" rules within the meaning of EO 12866, and no regulatory impact analysis is required. The NIGC also has determined, under the Regulatory Flexibility Act, that except as stated below, most of the regulations under consideration will not have a significant economic impact on a substantial number of small entities. Furthermore, Indian tribes are not small entities under the Act. No regulatory flexibility analysis is required for the proposed rules. The NIGC has not yet determined whether the rules implementing the Privacy Act or the rules regarding gaming machine classifications require a regulatory flexibility analysis. The proposed rules are not covered under section 202 of the Unfunded Mandates Reform Act (Pub. L. 104-4), as the NIGC is an independent agency not subject to the Act. The NIGC has determined that the proposed rules for gaming machine classification standards and technical standards may result in an expenditure of \$100 million or more in any one year by State, local, or tribal governments. The rest of the proposed rules are not considered major under 5 U.S.C. 801 enacted by Public Law 104-121, and, therefore, are not subject to section 801's 60-day deferral requirement.

Title: Technical Standards for Gaming Machines and Gaming Systems

Abstract: It is necessary for the National Indian Gaming Commission (NIGC) to promulgate regulations establishing technical standards in order to assure the integrity of electronic equipment used with the play of class II games. Technical standards will address actual operation of gaming machines and systems and the equipment related to their operation.

Statement of Need: Technical standards are needed to assure machine games are operated in a manner that ensures uniformity and integrity in tribal gaming.

Legal Basis: It is the goal of NIGC to provide regulation of Indian gaming to shield it from organized crime and other corrupting influences as well as assuring that gaming is conducted fairly and honestly. (25 U.S.C. 2702). The Commission is charged with the responsibility of monitoring gaming conducted on Indian lands. (25 U.S.C. 2706(b)(1)). The Indian Gaming Regulatory Act expressly authorizes the Commission to "promulgate such regulations and guidelines as it deems appropriate to implement the provisions of the (Act)." (25 U.S.C. 2706(b)(10)). The Commission relies on these sections of the statute to authorize the promulgation of technical standards for gaming machines to ensure uniformity and integrity in tribal gaming.

Alternatives: If the Commission does not issue a rule establishing technical standards for gaming machines, tribal gaming will not have the benefit of a standard that can help promote the integrity of the equipment in class II gaming.

Costs and Benefits: The development of technical standards will reduce the cost of regulation to the Federal Government. Additionally, technical standards will aid tribal governments in the regulation of their gaming activities as well as prevent loss associated with defective or substandard gaming devices. Anticipated costs will be to gaming machine manufacturers and tribes.

Risks: There are no known risks to this regulatory action.

Title: Game Classification Standards

Abstract: It is necessary for the National Indian Gaming Commission (NIGC) to promulgate regulations establishing game classification standards because of the distinction between class II and class III gaming set forth in the Indian Gaming Regulatory Act (IGRA). Technical changes make it difficult for regulators to keep up with the gaming industry. By establishing classification standards and clarifying the definition of "electronic or electromechanical facsimile," tribal gaming commissions, the primary regulators of tribal gaming, will more easily be able to distinguish between class II and class III machines.

Statement of Need: Gaming classification standards are needed to assure that regulators can determine whether gaming machines are class II or class III devices under IGRA.

Legal Basis: It is the goal of NIGC to provide regulation of Indian gaming to shield it from organized crime and other corrupting influences as well as assuring that gaming is conducted fairly and honestly. (25 U.S.C. 2702). The Commission is charged with the responsibility of monitoring gaming conducted on Indian lands. (25 U.S.C. 2706(b)(1)). IGRA expressly authorizes the Commission to "promulgate such regulations and guidelines as it deems appropriate to implement the provisions of the (Act)." (25 U. S.C. 2706(b)(10)). The Commission relies on these sections of the statute to authorize the promulgation of technical standards for game classifications and for gaming machines to ensure uniformity and integrity in tribal gaming.

Alternatives: The Commission can either: (1) Issue a rule establishing game classifications and gaming machines, or (2) continue evaluating classifications on a case-by-case basis.

Costs and Benefits: The development of classification standards will reduce the cost of regulation to the Federal Government. Additionally, classification standards will aid tribal governments in the regulation of their gaming activities. There are anticipated costs to gaming machine manufacturers and tribal governments. The NIGC is conducting a cost/benefit analysis.

Risks: There are no known risks to this regulatory action.

Abstract: The National Indian Gaming Commission (NIGC) is considering a rulemaking to define "sole proprietary interest" as that term is used in the Indian Gaming Regulatory Act (IGRA). IGRA requires, with one limited exception, Indian tribes to have the sole proprietary interest and responsibility for the conduct of any gaming activity on the tribes' Indian lands.
