# INSTRUCTIONS FOR EMPLOYEES FILING FORM FDIC 2410/06 CONFIDENTIAL REPORT OF INDEBTEDNESS

#### Employees who must file the FDIC Form 2410/06

- All employees who are required to file an SF-278, Public Financial Disclosure Report;
- DSC employees at or above grade 13 in a job series 301, 341, 343, 501, 505, 510 and 2210;
- DSC employees at or above grade 12 in job series 1101
- DSC employees at or above grade 11 in job series 301 identified as consumer affairs specialists, consumer affairs assistants, and consumer affairs technicians;
- DSC employees at or above grade 5 in job series 570 and 1160;
- DSC employees at or above grade 4 in job series 599
- CEP Examiners

# When you must file FDIC Form 2410/06 and for what period

# New Entrant

- Within 30 days of entering on duty in one of the job categories described above.
- The reporting period for a new entrant is the preceding 12 months from the date of filing.

# Annual Filer

- Employees who are required to file an SF-278, Public Financial Disclosure Report, file FDIC Form 2410/06 in conjunction with their SF-278 due annually, no later than May 15, unless that date is extended by the FDIC. The reporting period is the preceding calendar year.
- Other employees in the job categories described above file FDIC Form 2410/06 due annually, no later than February 15, unless that date is extended by the FDIC. The reporting period is the preceding calendar year.

#### About those indebtedness you must report on FDIC Form 2410/06

- You own
- Your spouse's

- Your dependent child's, and
- · Indebtedness you have jointly with another person

# Completing Part I "Creditors" of FDIC Form 2410/06

- If none of the persons about whom you are reporting owed any financial obligation to an FDIC-insured institution during the reporting period, mark the "NONE" box;
- In the "Type of Liability" column describe in a few words each financial obligation owed during the reporting period to an FDIC-insured institution, including its subsidiaries. Include both obligations that were actually owed during the reporting period and those that were contingent (e.g., you were a loan co-signer or guarantor). For example, identify mortgage loans for a personal residence, mortgage loans for rental property, car loans, and lines of credit;
- Designate who owned the financial obligation by marking, "S" for spouse, "J" for joint, and "DC" for dependent child;
- Identify the creditor and the city and state in which the creditor is located.

Note: Report all liabilities, including those exempt from reporting on the Public or Confidential Financial Disclosure Reports, SF 278 or OGE Form 450.

# Completing Part II "Employee's Certification" of FDIC Form 2410/06

- Sign and date the form in the designated blocks;
- Your signature certifies that the statements made on the form are true, complete, and correct to the best of your knowledge and belief; and
- Your signature also acknowledges that you must disqualify yourself from participating in any official FDIC business that affects any of the creditors you listed, as applicable.

# What to do with the completed FDIC Form 2410/06 (For Non-Electronic Filing)

- Sign a completed copy of the form;
- Make two copies of the completed and signed form;
- Send the form with your original signature and provide the original and one copy to your Deputy Ethics Counselor; and
- Keep one copy for your records.
