### TREASURY INTERNATIONAL CAPITAL DATA FOR MARCH

Treasury International Capital (TIC) data for March are released today and posted on the U.S. Treasury web site (<u>www.treas.gov/tic</u>). The next release date, which will report on data for April, is scheduled for June 15, 2006.

Net foreign purchases of long-term securities were \$69.8 billion.

- Net foreign purchases of long-term domestic securities were \$89.2 billion, \$1.6 billion of which were net purchases by foreign official institutions and \$87.6 billion of which were net purchases by private foreign investors.
- U.S. residents purchased a net \$19.4 billion in foreign issued securities.
