HAPPY BIRTHDAY UNITED STATES COAST GUARD!!!

The United States Coast Guard, one of the country's five armed services, is also one of the most unique agencies of the federal government. We trace our history back to 4 August 1790, when the first Congress authorized the construction of ten vessels to enforce tariff and trade laws, prevent smuggling, and protect the collection of the federal revenue. Known variously as the Revenue Marine and the Revenue Cutter Service, we expanded in size and responsibilities as the nation grew.

These added responsibilities included humanitarian duties such as aiding mariners in distress. Our law enforcement functions also continued to expand. Congress tasked us with enforcing laws against slavery, piracy, and enlarged our responsibilities to prevent smuggling. We were also given the responsibility to protect the marine environment, explore and police Alaska, and chart the growing nation's coastlines, all well before the turn of the twentieth century


Today, the Coast Guard will:

- Save 15 lives
- Assist 117 people in distress
- Protect \$2.8 million in property
- Interdict 30 illegal migrants at sea
- Conduct 90 search and rescue cases
- Seize \$21 million worth of illegal drugs
- Respond to 11 oil and hazardous chemical spills
- Board and inspect 122 vessels



If you are new to post and have not visited the health unit, you are invited to do so at your earliest convenience. The Health Unit is staffed by Carol Clowes, RN who is US trained with a degree in Nursing. The Health Unit is open from 8 AM-1 PM Monday - Friday. The Nurse is also on call for emergencies. Carol's cell number is 427-2508.

The Health Unit performs a variety of functions. Health information classes and CPR instruction are scheduled throughout the year. Chronic conditions such as Diabetes and Hypertension can be monitored. An extensive list of physicians and dentists is available along with an information booklet on local and State Department Medical policy. Immunizations and a small inventory of medications are available for immediate care. A mail-in prescription service is also available. An open line of communication is maintained with our Regional Medical Officer in Ft. Lauderdale who visits quarterly.

I'm sure everyone is wondering why I have a list of the "Ten excuses NOT to be a blood donor". Well it's that time of year again. We are trying to get everyone excited and prepared to donate so eat your iron and vitamin enriched foods. Look for more information on the blood drive next month. We would love to see a bigger turn out. Remember one day you may need blood.



10 Excuses NOT to be a Blood Donor

#10. "I've never been asked to donate blood." Well, we're asking now!

#9. "I'm afraid of needles." There's very little pain involved in giving blood. The feeling is like a slight pinch that lasts only a second.

#8. "It's not urgent because they can store blood a long time." Blood has a short shelf life of only 42 days. We can't stock pile it. We need donors every day to ensure there is always enough.

#7. "I don't have any blood to spare." If you are in general good health, you have 10 to 14 pints of blood in your body. You may safely donate 1 pint every 8 weeks.

#6. "I can't donate because I take medication." Most prescription and over-the counter medications are fine if you are feeling well. Includes aspirin, blood pressure, thyroid, anti-depressants. Most people *CAN* give blood. **#5.** "I'm too old to donate." There is no upper age limit! If you are in good health and are 17 or older you may safely donate.

#4. "My blood isn't the right type." Every type is the "right" type. Patients are all blood types, so we need donors of all types

#3. "I only donate for emergencies." The blood has to be available *BEFORE* the emergency happens. And more importantly, every day in our community we need 150 blood donations for hospital patients and "little emergencies." Certainly saving the life of a cancer patient or car accident victim is just as important as when a bigger disaster occurs! We have to be ready 365 days of the year.

#2. "Other people are giving enough blood." The #1 safety concern with this country's blood supply today is adequacy! Only 5% of eligible donors actually donate blood. Every year we need more donors, because local needs increase as our area grows and some regular donors move away or can no longer donate due to health reasons or new FDA restrictions.

...and the number one Excuse is...

#1. "I don't have time to donate blood." It takes less than an hour of your time to save someone's life! There is no substitute. We encourage every to donate.

SECURITY ALERTS: Nigerian Scam

The US Embassy in Nassau has zens receiving letters, either through fax or the mail, claiming to be from the Internal Revenue Service (IRS). These letters are not genuine. They are a variation on the common Nigerian scam which attempts to get bank information from you so that criminals can illegally access your accounts. PLEASE DO NOT RESPOND TO THIS LETTER.

The IRS would never request information from you in this manner. If you have questions for the IRS, you may contact them directly in the United States at 215-516-2000.

Both the IRS and the FBI have

been notified of these letters. In these received several reports of US Citical cases, however, recourse is generally limited due to the high frequency of this Monday-Thursday and 10:00-12:00 fraud and the ability of the criminals to cover their tracks.

Be Aware of Internet Fraud

In general, the same types of fraud schemes that have victimized consumers and investors for many years before the proliferation of Internet use are now appearing online. You may find fraud schemes in chat rooms, and e-mails.


A form of fraud which is becoming more common today is called phishing. Phishing is defined as a way to trick people into providing their personnel and financial information by pretending to be from a legitimate company such as your financial institution, or a legitimate retailer. The sender asks you to "confirm" your personal information for some made-up reason. Typically, the e-mail contains a link to a phony Web site that looks just like the real thing – with sophisticated graphics and images. In fact, the fake Web sites are nearreplicas of the real one, making it hard even for experts to distinguish between the real and fake Web sites. You enter your personal information onto the Web site – and into the hands of identity

thieves. Its pretty simple. **BEWARE!** To report phishing go to the website http://www.phishinginfo.org/.

The Ambassador would like me to contact you on a monthly basis on EEO issues. The Ambassador has asked that I attend staff meetings in different sections to raise awareness and underscore the importance of EEO principles.



There are three main objectives of EEO counseling:

- 1. Inform individuals about the EEO process.
- 2. Gather certain vital information concerning the claim(s) raised at counseling.
- 3. Help resolve EEO matters quickly and informally.

An individual has 45 days from date of alleged discriminatory event to contact an EEO Counselor.

QUESTION 1: WHAT ARE THE FEDERAL LAWS PROHIBITING EMPLOYMENT DISCRIMINATION?

ANSWER 1: THERE ARE SEVERAL LAWS THAT PROHIBIT DISCRIMINATION IN THE FEDERAL WORKPLACE, NOT ALL OF WHICH ARE ENFORCED THROUGH THE EEO PROCESS: TITLE VII OF THE CIVIL RIGHTS ACT OF 1964, AS AMENDED (TITLE VII), PROHIBITS EMPLOYMENT DISCRIMINATION BASED ON RACE; COLOR; RELIGION; SEX; NATIONAL ORIGIN; PREGNANCY, CHILDBIRTH, OR RELATED CONDITION; OR REPRISAL FOR PRIOR EEO PROTECTED ACTIVITY OR OPPOSITION TO ILLEGAL DISCRIMINATION; THE EQUAL PAY ACT OF 1963, AS AMENDED (EPA), PROTECTS MEN AND WOMEN WHO PERFORM SUBSTANTIALLY EQUAL WORK IN THE SAME ESTABLISHMENT FROM SEX-BASED WAGE DISCRIMINATION; THE AGE DISCRIMINATION IN EMPLOYMENT ACT OF 1967, AS AMENDED (ADEA), PROTECTS INDIVIDUALS WHO ARE 40 YEARS OF AGE OR OLDER FROM ADVERSE EMPLOYMENT ACTIONS BASED ON AGE; AND THE REHABILITATION ACT OF 1973, AS AMENDED, PROHIBITS DISCRIMINATION AGAINST QUALIFIED INDIVIDUALS WITH DISABILITIES WHO WORK IN THE FEDERAL GOVERNMENT.

ALSO, THERE ARE OTHER FEDERAL LAWS NOT ENFORCED BY THE EEOC THAT ALSO PROHIBIT DISCRIMINATION AND REPRISAL AGAINST FEDERAL EMPLOYEES AND APPLICANTS.

DISCRIMINATION AND REPRISAL AGAINST FEDERAL EMPLOYEES AND APPLICANTS.

THE CIVIL SERVICE REFORM ACT OF 1978, AS AMENDED, CONTAINS A NUMBER OF PROHIBITIONS KNOWN AS "PROHIBITED PERSONNEL PRACTICES." THIS LAW PROHIBITS ANY EMPLOYEE WHO HASAUTHORITY TO TAKE CERTAIN PERSONNEL ACTIONS FROM DISCRIMINATING AGAINST EMPLOYEES OR APPLICANTS FOR EMPLOYMENT ON THE BASES OF RACE, COLOR, NATIONAL ORIGIN, RELIGION, SEX, AGE, OR DISABILITY. IT ALSO PROVIDES THATCERTAIN PERSONNEL ACTIONS CANNOT BE BASED ON AUTHORITIES OR CONDUCT THAT DO NOT ADVERSELY AFFECT EMPLOYEE PERFORMANCE, SUCH AS MARITAL STATUS AND POLITICAL AFFILIATION. THE LAW FURTHER PROHIBITS REPRISAL AGAINST FEDERAL EMPLOYEES OR APPLICANTS FOR WHISTLEBLOWING, OR FOR EXERCISING AN APPEAL, COMPLAINT, OR GRIEVANCE RIGHT. THE FOREIGN SERVICE ACT OF 1980, AS AMENDED, EXTENDS THESE MERIT PRINCIPLES AND LEGAL PROTECTIONS TO MEMBERS OF THE FOREIGN SERVICE AND APPLICANTS TO THE FOREIGN SERVICE.

David 's TOP Ten List

PREPARATION FOR A HURRICANE

- 1. Plan how you will deal with your pets in the event of evacuation. NO you can not tie them to a tree.
- 2. Have some US cash available in the event of an evacuation (ATMs won't work without electricity) and shopping is expensive.
 - 3. Keep your car's fuel tank at least 1/2 full at all times.
- 4. Keep your cell phone's battery charged, its hard to call home without it.
 - 5. Have sufficient drinking water (and other things) on hand.
 - 6. Have water and toilet paper on hand for well you know...
- 7. Have a bag packed in the event you must leave your house or leave the island (medicines, extra eyeglasses, valuable papers, cash, computer backup disk, etc.).
- 8. Have a supply of nonperishable foods hidden from the kids.
- 9. Have a working flashlight for playing hand games in the dark 10. Battery-operated radio with extra batteries.

Please note the following paragraph from a recent cable received from State.

The designated Safe Haven for all Authorized/Ordered Departures is Washington, D.C. for all State employees. Family Members must elect a Safe Haven point in the U.S.; out of the projected path of the storm. Other agency employees and family members at post may be evacuated to the location of their agency headquarters or to a point previously identified in writing to the Under Secretary for Management.

• We are still awaiting policy from the other agencies. Keep in mind, however, this policy could be changed at any time prior to evacuation. With this in mind, if your family members (on your orders) would like to designate alternate Safe Haven in the U.S., you need to get the information to me as soon as possible. You can E-mail me at murrayjl@state.gov.or call me at ext. 4206 or drop off a new Personnel Evacuation Data form at the CLO office.

The Family Liaison Office (FLO) is pleased to announce a new professional training and support program for spouses of Foreign Service direct-hire employees of the Foreign Affairs agencies (Department of State, Agency for International Development, the Foreign Commercial Service, and the Foreign Agriculture Service).

This new pilot program, called e-Entrepreneur, provides training and support in setting-up and developing a "portable" home-based virtual business. FLO has partnered with the StaffCentrix Company to provide and implement the e-Entrepreneur training program.

As a result of the enormous number of applications, additional sessions have been added for June, July, and October 2005, and will be held in Washington , DC . The e-Entrepreneur workshop and following support services are at no cost for the participants, but the candidate is responsible for her/his own travel, meal and lodging expenses.

Training dates and program
The two-and-half day program will take place in the Washington D.C. area.

Summer sessions full October session: October 24, 25, 26, 2005

Phase I full day Exploring Entrepreneurship
Phase II 3:00-5:00 p.m.* Anticipating Changes in the Household
Phase III full day Launching and Marketing your Business

*Attendance of the candidate's spouse is strongly recommended for this session.

Application and selection process
Applications will be accepted from interested candidates through an on-line application process. In cooperation with the Family Liaison Office,
StaffCentrix professionals will review the applications and select the candidates. Applications will be accepted until the program workshops are full, or until a week before the training starts.



PLEASE DISTRIBUTE TO ALL FAMILY MEMBERS

- 1. SUMMARY: The Family Liaison Office is pleased to announce a partnership with Manpower Corporation as part of our Global Employment Strategy (GES) Initiative launched in October 2004 (reftel). We anticipate that Global Employment Strategy along with SNAP, our in-country employment program, will provide more professional opportunities for globally mobile spouses.
- 2. The Department of State entered into a no-cost, global partnership with Manpower Corporation, and through this partnership Manpower has undertaken to provide on-the-ground support and placement for our family members who are seeking professional opportunities overseas and in the D.C. area. With Manpower, our EFMs may receive targeted employment assistance in the 66 countries where Manpower has offices.
- 3. Manpower has moved beyond the temporary and support staffing function that many associate with this organization. Today Manpower services include affiliates such as Right Management Consultants, Brook Street, Elan and Jefferson Wells. In addition to professional counseling and placement services, the entire range of Manpower assessment tools and training programs will also be available to all spouses everywhere, at no cost to spouses or to the USG.
- 4. As of May 24th, 2005, Manpower began accepting resumes and conducting referrals on behalf of our globally mobile spouses. We initiated the Manpower program by announcing it to spouses who had contacted our Global Employment Advisors for employment assistance after our initial cable last year. We are now opening this Manpower partnership worldwide to all spouses.
- 5. Manpower views this partnership as an important initiative and has committed high level support. Each Manpower office overseas was required to designate a country level GES coordinator who will be the operational point of contact. In the absence of a local employment advisor (LEA) hired through the SNAP program, we ask CLOs, as part of their spousal employment advocacy responsibility, to serve as the liaison with the local incountry Manpower office representative. We gave CLOs a heads up in the June 2005 e-newsletter, FLO-CLO Connection and we will follow this cable with an ALDAC spelling out the CLO and LEA relationship with Manpower.
- 6. How can spouses take advantage of this service? Manpower is eager to assist spouses with job placements and can provide spouses access to their on-line training and assessment programs.

 Repeat: there is no cost for any of these services. m.

- 7. We encourage management at posts to pursue work agreements since working on the local economy as a diplomatic spouse requires having a negotiated bilateral or defacto work arrangement. If your agreements are not working well, or treatment is not reciprocal, please advise FLO so we can start to address these issues.
- 8. We have bilateral agreements or de facto arrangements in 57 out of 66 countries where Manpower has offices. We have annotated the Manpower country list below where we have the legal right to work.
