## CIVIL RIGHTS COMMISSION TO EXAMINE WHETHER SCHOOL DISTRICTS ARE FACILITATING OR IMPEDING SUPPLEMENTAL SERVICES FOR LOW-INCOME STUDENTS

Commission probes whether school districts are implementing the supplemental educational services program.

What: Meeting of the U.S. Commission on Civil Rights, an independent, bipartisan agency charged with monitoring and protecting civil rights

WASHINGTON, DC – The U.S. Commission on Civil Rights (Commission) has assembled three expert panels to discuss whether school districts are implementing or impeding the Supplemental Educational Services (SES) program under the No Child Left Behind Act (NCLB). The SES program is intended to provide low-income students with academic assistance, including tutoring and remediation, as well as summer school. Some school districts have been criticized for failing to provide appropriate SES and for failing to provide parents with adequate information about their rights.

The speakers will include a panel of experts, a panel of parents, and a panel of government officials and representatives. The experts will include Hon.
