<u>Budget/Costs Status:</u> The overall budget has not changed from the January 2007 baseline. The project is continuing to progress and the estimate to complete will be adjusted as final designs are completed and the first construction contracts are awarded later in the summer.

4/19/07 - \$1,108,179 was removed on a prorated basis from both the VA and WV federal participating and WV non-participating rows. This amount was for the planning work completed prior to the MOA and is now included in the Misc. amount. This was done to better correspond with Norfolk Southern's project accounts.

# Work Completed:

✓ Project Funding: In a Letter of Authorization from EFLHD dated February 8, 2007, Norfolk Southern was authorized Section 1301 funds in the amount of \$5,498,664 for the Federal share of preliminary engineering work in West Virginia.

In a Memorandum from FLH Director, Office of Program Development dated March 27, 2007, Section 1702 funds for fiscal years 2005 and 2006 were allocated to EFLHD for the Heartland Corridor in the amount of \$1,716,300. In a Letter of Authorization from EFLHD dated April 9, 2007, Norfolk Southern was authorized Section 1702 funds in the amount of \$556,364 for the Federal share of preliminary engineering work in Virginia.

- ✓ Preliminary Engineering: The 70% plans and specifications for the first tunnels in West Virginia and Virginia, and the bridges in Ohio were distributed for comment in early March 2007.
- ✓ Contractor Meeting: A Contractor informational meeting was held February 13, 2007 in Charleston, WV. This meeting was held to inform contractors of future construction work for the Clearance Project. 31 individuals attended representing contractors, engineering firms, and labor unions.

#### Work-In-Progress:

- Project Funding: On April 18, 2007 EFL received a draft of the FY 2007 Projects of National and Regional Significance funding memo for the Heartland Corridor. This memo from FHWA Office of Freight Management and Operations will allot a total of \$20,716,107 in Federal budget authority to West Virginia for direct transfer to EFLHD for the Heartland Corridor. This dollar amount represents the 25% distribution for FY 2007 plus an additional \$390,726 in RABA adjustment. The obligation limitation is 90.5% for FY 2007 funds.
- Preliminary Engineering: 70% plans for five more tunnels in WV have been completed. 70% Plans and specifications are scheduled to be distributed to WV the first week of May. HMM is continuing to make progress on the remaining tunnels.
- Construction Engineering: A Request for Proposals for the construction management of the Heartland Corridor Clearance Project was posted on the West Virginia DOT web site on February 1, 2007. Proposals were due March 1, 2007 and a selection panel met on March 5-6, 2007 to evaluate the proposals. Norfolk Southern is currently negotiating a contract with the selected team led by STV/Ralph Whitehead.
- Contractor Pre-Qualification: A Request for Pre-Qualification was posted on West Virginia DOT web site on April 6, 2007. Contractor qualification statements are due April 25, 2007. A selection panel is scheduled to meet April 30, 2007 to review qualification statements and determine which contractors are qualified and will be given the opportunity to bid on the tunnel work.

- NEPA Compliance: EFL has coordinated with the West Virginia, Virginia, Ohio, and Kentucky State Historic Preservation Offices (SHPO) regarding the Clearance Project. The SHPOs and FHWA have agreed that the Norfolk Southern mainline between Cowan, VA and Bull, WV is eligible for listing on the National Register of Historic Places and that the proposed undertaking may have an adverse effect on the corridor. A Memorandum of Agreement is being developed between FHWA and SHPOs regarding the mitigation of these adverse effects. EFL has also coordinated with the Fish and Wildlife Service regarding threatened and endangered species. Once these coordination efforts are completed, the Categorical Exclusion can be completed.
- Initial Financial Plan: A draft of the Initial Financial Plan has been completed and was sent to all Parties of the MOA on April 25, 2007 for review and comment. FHWA HQ was also given the opportunity to comment on the plan. It is intended to finalize the Initial Financial Plan by mid May 2007 prior to the solicitation of bids for the first construction projects.
