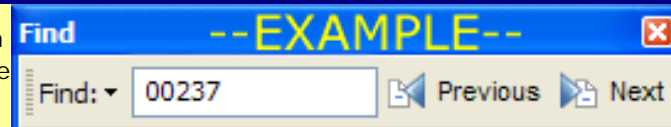


STATUS OF ALL FY2007 FOIA REQUESTS

Search for your Request Identification Number (RIN) by using Ctrl F to open the Find window. Hold down the control key (Ctrl) and hit the letter F on your keyboard. When the Find window opens type in only the five digit number of your RIN and click Next. ex. 04-RIN-00237-07
